1 A BILL finding and declaring certain claims against the state and its agencies to be moral
2 obligations of the state; and directing the Auditor to issue warrants for the payment thereof.

Be it enacted by the Legislature of West Virginia:

CLAIMS AGAINST THE STATE.

§1. Finding and declaring certain claims against the Department of Administration, Office of Technology; Division of Corrections; Division of Highways; Division of Rehabilitation Services; Division of Labor; Division of Motor Vehicles; Department of Health and Human Resources, Bureau for Behavioral Health and Health Facilities; and Department of Health and Human Resources; and Regional Jail Authority to be moral obligations of the state and directing payment thereof.

1 The Legislature has considered the findings of fact and recommendations reported to it
2 by the Court of Claims concerning various claims against the state and agencies thereof and in
3 respect to each of the following claims, the Legislature adopts those findings of fact as its own
4 and in respect of certain claims herein, the Legislature has independently made findings of fact
5 and determinations of award and hereby declares it to be the moral obligation of the state to pay
6 each such claim in the amount specified below and directs the Auditor to issue warrants for the
7 payment thereof out of any fund appropriated and available for the purpose.

8 The Legislature finds that the above moral obligations and the appropriations made in
9 satisfaction thereof shall be the full compensation for all claimants and that prior to the payments
10 to any claimant provided in this bill, the Court of Claims shall receive a release from said claimant
11 releasing any and all claims for moral obligations arising from the matters considered by the
12 Legislature in the finding of the moral obligations and the making of the appropriations for said
13 claimant. The Court of Claims shall deliver all releases obtained from claimants to the department
14 against which the claim was allowed.
