BY MR. SPEAKER (MR. ARMSTEAD) AND DELEGATE MILEY

BY REQUEST OF THE EXECUTIVE

[INTRODUCED FEBRUARY 28, 2017; REFERRED

TO THE COMMITTEE ON FINANCE.]

1 A BILL expiring funds to the unappropriated surplus balance in the State Fund, General Revenue,
2 for the fiscal year ending June 30, 2017 in the amount of \$18,600,000 from the Department
3 of Revenue, Office of the Secretary – Revenue Shortfall Reserve Fund, fund 7005, fiscal
4 year 2017, organization 0701, and making a supplementary appropriation of public
5 moneys out of the Treasury from the balance of moneys remaining as an unappropriated
6 surplus balance in the State Fund, General Revenue, to the Department of Administration,
7 Division of Finance, fund 0203, fiscal year 2017, organization 0209, and to the Department
8 of Administration, Public Defender Services, fund 0226, fiscal year 2017, organization
9 0221, by supplementing and amending the appropriations for the fiscal year ending June
10 30, 2017.

1 Whereas, The Governor submitted to the Legislature the Executive Budget document,
2 dated February 8, 2017, which included a Statement of the State Fund, General Revenue, setting
3 forth therein the cash balance as of July 1, 2016, and further included the estimate of revenues
4 for the fiscal year 2017, less net appropriation balances forwarded and regular appropriations for
5 the fiscal year 2017 and further included recommended expirations to the surplus balance of the
6 State Fund, General Revenue; and

7 Whereas, It appears from the Executive Budget document, Statement of the State Fund,
8 General Revenue, and this legislation, there now remains an unappropriated surplus balance in
9 the State Treasury which is available for appropriation during the fiscal year ending June 30,
10 2017; therefore

Be it enacted by the Legislature of West Virginia:

1 That the balance of the funds available for expenditure in the fiscal year ending June 30,
2 2017, in the Department of Revenue, Office of the Secretary – Revenue Shortfall Reserve Fund,
3 fund 7005, fiscal year 2017, organization 0701, be decreased by expiring the amount of
4 \$18,600,000, to the unappropriated surplus balance of the State Fund, General Revenue to be

5 available for appropriation during the fiscal year ending June 30, 2017.

1 And, That the total appropriation for the fiscal year ending June 30, 2017, to fund 0203,
2 fiscal year 2017, organization 0209, be supplemented and amended by adding a new item of
3 appropriation as follows:
