1 A BILL finding and declaring certain claims against the state and its agencies to be moral  
2 obligations of the state; and directing the Auditor to issue warrants for the payment thereof.

*Be it enacted by the Legislature of West Virginia:*

**CLAIMS AGAINST THE STATE.**

**§1. Finding and declaring certain claims against the Department of Administration, Office of Technology; Division of Corrections; Division of Highways; Division of Rehabilitation Services; Division of Labor; Division of Motor Vehicles; Department of Health and Human Resources, Bureau for Behavioral Health and Health Facilities; and Department of Health and Human Resources; and Regional Jail Authority to be moral obligations of the state and directing payment thereof.**

1 The Legislature has considered the findings of fact and recommendations reported to it  
2 by the Court of Claims concerning various claims against the state and agencies thereof and in  
3 respect to each of the following claims, the Legislature adopts those findings of fact as its own  
4 and in respect of certain claims herein, the Legislature has independently made findings of fact  
5 and determinations of award and hereby declares it to be the moral obligation of the state to pay  
6 each such claim in the amount specified below and directs the Auditor to issue warrants for the  
7 payment thereof out of any fund appropriated and available for the purpose.
