1 A BILL to amend the Code of West Virginia, 1931, as amended, by adding thereto a new section, 2 designated §5B-2-9a, relating to declaring public policy and legislative intent for improving 3 the marketing, guality and frequency of passenger rail service of the Cardinal Passenger 4 Train operated by the National Railroad Passenger Corporation, doing business as 5 AMTRAK, along the route crossing the south-central region of the state from Huntington 6 eastward to White Sulphur Springs; the powers and duties of the Commissioner of the 7 Division of Tourism and the tourism commission to achieve those policies and Legislative intent: cooperation and assistance to be provided by the West Virginia Department of 8 9 Transportation and the West Virginia State Rail Authority to the commissioner and tourism 10 commission; cooperation of the commissioner with other states and the National Railroad 11 Passenger Corporation; participation in an interstate body to achieve such cooperation; 12 and creation of a Cardinal Passenger Train Enhancement Fund as a special revenue 13 account.

Be it enacted by the Legislature of West Virginia:

That the Code of West Virginia, 1931, as amended, be amended by adding thereto a new
section, designated § 5B-2-9a, to read as follows:

ARTICLE 2. WEST VIRGINIA DEVELOPMENT OFFICE.

§5B-2-9a. Powers and duties of Commissioner of the Division of Tourism and Tourism Commission for improving Cardinal Passenger Train Service; declaration of public policy and Legislative intent.

- 37 Passenger Train Enhancement Fund" into which all moneys intended to advance the purposes
- 38 of this section shall be deposited. Moneys in this account shall be expended solely for the public
- 39 policy and purposes set forth in this section. Funds paid into this account may also be derived
- 40 from the following sources: (1) All interest or return on investment accruing to this account; (2)
- 41 any gifts, grants, bequests, transfers, appropriations or other donations which may be received
- 42 from any governmental entity or unit or any person, firm, foundation, or corporation; and (3) any
- 43 appropriations by the Legislature which may be made for the purposes of this section. Any
- 44 balance including accrued interest and other earnings at the end of any fiscal year shall not revert
- 45 to the general fund but shall remain in the fund for the purposes set forth in this section. The
- 46 moneys in the fund shall be paid out, at the sole discretion and direction of the commissioner, to
- 47 advance the purposes of this section.

NOTE: The purpose of this bill is to declare the public policy of the state of West Virginia and the intent of the Legislature to facilitate, advance and improve the availability of interstate passenger rail service to the state by the Cardinal Passenger Train operated by the National Railroad Passenger Corporation, doing business as AMTRAK, including the provision of daily passenger train service at the earliest opportunity, on railroad lines crossing the south-central region of the State from Huntington eastward to White Sulphur Springs. The Commissioner of the West Virginia Division of Tourism is authorized and directed to supervise the state's activities and to participate with other states and AMTRAK in an interstate committee to improve the Cardinal Passenger Train.
