A BILL to amend and reenact §18C-1-1, §18C-1-3 and §18C-1-5 of the Code of West Virginia,
1931, as amended; and to amend said code by adding thereto a new article, designated
§18C-7A-1, §18C-7A-2, §18C-7A-3, §18C-7A-4, §18C-7A-5 and §18C-7A-6, all relating
to creation of a merit-based scholarship program for tuition and fee payments for certain
students at state community and technical colleges.

Be it enacted by the Legislature of West Virginia:

That §18C-1-1, §18C-1-3 and §18C-1-5 of the Code of West Virginia, 1931, as amended,
be amended and reenacted; and that said code be amended by adding thereto a new article,
designated §18C-7A-1, §18C-7A-2, §18C-7A-3, §18C-7A-4, §18C-7A-5 and §18C-7A-6, all to
read as follows:

# CHAPTER18C. STUDENT LOANS; SCHOLARSHIPS AND STATE AID.

## ARTICLE 1. FINANCIAL ASSISTANCE GENERALLY.

#### §18C-1-1. Legislative findings; purpose; administration generally; reporting.

- 1 (a) The Legislature makes the following findings: 2 (1) The Legislature recognizes and celebrates the determination, work and success of 3 Katherine Johnson, who is a native of White Sulphur Springs in Greenbrier County. Katherine 4 Johnson is an internationally acclaimed physicist and mathematician who in 1937 graduated from 5 the college that is today West Virginia State University. Following graduation, she became the 6 first female African-American graduate student to attend West Virginia University and began a 7 career of accomplishment as a lead mathematician for the national space program of the National 8 Aeronautics and Space Administration. The State of West Virginia salutes Katherine Johnson for 9 her success with the national space program and as an example of a woman, mother and African-American who excelled in her career in a time when women, mothers and African-Americans 10 11 were limited in their opportunities for employment.
- 12 (2) Although enrollments in institutions of higher education in this state and throughout the

13	nation continue to drop at a rapid pace, West Virginia has not developed sufficiently the state's
14	human talent and resources because many able, but needy, students are not able to finance a
15	higher education program.
16	(3) The costs of tuition and fees for community and technical colleges continue to climb
17	and create a barrier to many students especially those in new college families who are in the first
18	generation of family members to graduate from a two-year or four-year institution of higher
19	education.
20	(4) The state can achieve its full economic and social potential only when the following
21	elements are in place:
22	(A) Every individual has the opportunity to contribute to the full extent of his or her
23	capability, especially students in new college families;
24	(B) The state assists in removing financial barriers to the individual's education goals that
25	remain after he or she has used all resources and work opportunities available; and
26	(C) The state assists in changing the culture in many communities and families
27	discouraging higher education.
28	(b) The ultimate state goal in providing student financial aid is to create a culture that
29	values education in all levels of instruction, to improve the quality of the workforce and to enhance
30	the quality of life for the citizens of West Virginia.
31	(c) The Vice Chancellor for Administration has a ministerial duty to administer, oversee
32	and monitor all state and federal student financial aid programs administered at the state level in
33	accordance with established rules under the direction of the commission and council and in
34	consultation with the Higher Education Student Financial Aid Advisory Board.
35	(d) These programs include, but are not limited to, the following programs:
36	(1) The Guaranteed Student Loan Program, which may be administered by a private
37	nonprofit agency;
38	(2) The Medical Student Loan Program;

- 39 (3) The Underwood-Smith Teacher Scholarship Program;
- 40 (4) The Engineering, Science and Technology Scholarship Program;
- 41 (5) The West Virginia Higher Education Grant Program;
- 42 (6) The Higher Education Adult Part-Time Student Grant Program;
- 43 (7) The West Virginia Providing Real Opportunities for Maximizing In-State Student
- 44 Excellence (PROMISE) Scholarship Program;
- 45 (8) The Higher Education Student Assistance Loan Program established pursuant to
- 46 <u>article twenty-two-d, chapter eighteen of this code;</u>
- 47 (9) The West Virginia College Prepaid Tuition and Savings Program established pursuant
- 48 to article thirty, chapter eighteen of this code, which is administered by the State Treasurer;
- 49 (10) The state aid programs for students of optometry, pursuant to article three of this
- 50 chapter;
- 51 (11) The state aid programs for students of veterinary medicine pursuant to section six-a,
- 52 article eleven, chapter eighteen of this code;
- 53 (12) Any reciprocal program and contract program for student aid established pursuant to
- 54 sections three and four, article four, chapter eighteen-b of this code;
- 55 (13) Any other state-level student aid programs in this code;
- 56 (14) Any federal grant or contract student assistance or support programs administered at
- 57 the state level; and
- 58 (15) The Katherine Johnson Hope Scholarship Program, to pay tuition and fees for
   59 gualified students attending community and technical colleges in the state.
- 60 (e) Notwithstanding any provision of this chapter to the contrary, the Vice Chancellor for
- 61 Administration shall prepare a single, comprehensive report regarding the implementation of the
- 62 financial aid programs identified in subsection (d) of this section which are administered under his
- 63 or her supervision. The report shall be provided to the commission and the council and shall be
- 64 presented to the Legislative Oversight Commission on Education Accountability no later than

affordable for its citizens. To this end, it is essential that the state provide multiple financial aid
 programs which accomplish different goals;

26 (b) Purposes of financial aid programs:

(1) The West Virginia Higher Education Grant Program is a need-based program that
provides funding primarily to traditional college-age students who do not have sufficient financial
resources to attempt post-secondary education. This grant program is a vitally important source
of financial assistance for needy residents of the state and should continue to receive strong
financial support.

32 (2) The HEAPS Grant Program is a need-based program that provides funding primarily
 33 to nontraditional college students, including:

34 (A) Adult students who desire to pursue post-secondary education on a part-time basis
35 and who do not qualify for other forms of financial assistance;

36 (B) Place-bound students, often parents employed full-time, who require evening and
 37 weekend access to college courses; and

38 (C) Individuals pursuing workforce training or skill development training necessary to enter
39 the job market quickly.

40 (3) The Underwood-Smith Teacher Scholarship Program is a merit-based program that
41 encourages students who have demonstrated outstanding academic abilities to pursue teaching
42 careers. This program serves to meet West Virginia's statewide, geographic and discipline43 specific needs for highly qualified teachers.

(4) The West Virginia Engineering, Science and Technology Scholarship Program is a
merit-based program that encourages talented students to pursue baccalaureate degrees in
engineering, science and technology-related disciplines. This program serves to increase the size
and quality of the pool of individuals pursuing careers in engineering, science and technologyrelated fields.

(5) The PROMISE Scholarship Program is a merit-based program that enhances student

50 achievement by encouraging high school students to work harder to attain the necessary grades 51 and test scores to qualify for a PROMISE scholarship and provides an incentive for the most 52 capable students to attend college in the state. PROMISE provides affordability to traditional 53 college-age students.

54 (6) The Katherine Johnson Hope Scholarship is a merit-based scholarship like the PROMISE scholarship offering supplemental funds to help pay tuition and fees at community and 55 56 technical colleges in the state for up to four semesters for certain students graduating from high 57 school in this state with a composite score of sixteen or better on an ACT or similar standardized 58 college entrance test, and for adults age twenty-four or older who had a grade point average from 59 a state high school of at least 2.5 on a 4.0 scale and a composite score of 16 on an ACT or similar 60 standardized college entrance test, or who can present a feasible work plan with three years of 61 experience in the state before college, and at least two years of work in the state after graduation 62 from a two-year or one-year program at a community and technical college for which the adult 63 student has the necessary skills to succeed or can have a plan for remedial education to obtain 64 such skills as needed to succeed with their work plan. 65 (c) An appropriate blend of student financial aid programs provides the state with the

66 necessary tools to educate its citizenry for a broad range of economic opportunities:

67 (1) Without proper funding for need-based programs, lower income students may not be68 able to realize their full potential;

69 (2) Adults may not obtain the training they need to compete in the current and future job70 market;

(3) High-achieving students may not pursue rigorous courses in high school or attend
 college in West Virginia, all of which contribute to devaluing post-secondary education and
 perpetuating the culture of educational underachievement, <u>especially in communities and families</u>

- 74 with traditionally low college-going rates; and
- 75 (4) By assisting students interested in entering the workforce after one or two years of

76 specialized training in the state, through tuition and fee support for community and technical

77 college classes, the state will more rapidly provide to employers trained employees required to

78 meet the needs of business and industry; and

(4) (5) The state must continue to strive to support equally the need-based and merit based student financial aid programs.

#### §18C-1-5. Higher Education Student Financial Aid Advisory Board.

1 (a) The Higher Education Student Financial Aid Advisory Board is established.

(b) The purpose of the board is to provide financial aid expertise and policy guidance to
the commission, the council and the Vice Chancellor for Administration on all matters related to
federal, state and private student financial aid resources and programs.

- 5 (c) It is the intent of the Legislature that the advisory board:
- 6 (1) Recommend methods to balance the needs of state students from all levels of financial7 need and academic ability;
- 8 (2) Recommend methods for achieving a comprehensive system of student financial aid
  9 to maximize the return on the state's investment in student financial aid programs by increasing
  10 the skills, qualifications and education achievement of the citizens receiving the benefits;

(3) Recommend methods to coordinate state-funded student financial aid programs so
that the state achieves the appropriate blend of programs to expand the range of economic
opportunities available to state citizens;

- (4) Recommend ways to improve state-level administration of financial aid programs for
  the benefit of students and institutions:
- 16 (5) Recommend ways to improve financial aid outreach activities;

17 (6) Make recommendations, consistent with the nature of the PROMISE scholarship
18 program <u>and the Katherine Johnson Hope Scholarship program</u> as a merit-based student financial
19 aid program programs;

(7) Study feasibility of including for-profit institutions as eligible institutions for PROMISE

21	scholarship awards and requirements, if any, for inclusion; and
22	(8) Recommend rules that align with the goals, objectives and priorities set forth in section
23	one-a, article one, chapter eighteen-b of this code and article one-d of said chapter and with other
24	state and system public policy goals, objectives and priorities.
25	(d) Advisory board membership
26	(1) The advisory board shall consist of seven members selected as follows:
27	(A) Three Two members appointed by the commission Higher Education Policy
28	Commission:
29	(B) Two members appointed by the council West Virginia Council for Community and
30	Technical College Education;
31	(C) One member appointed by the West Virginia Independent Colleges and Universities;
32	and
33	(D) One member appointed by the West Virginia School Counselor Association; and
34	(E) One middle school or junior high school principal to be appointed by the Council for
35	Community and Technical College Education. The middle school or junior high school principal
36	shall be added to the advisory board at the end of the first term of a member representing the
37	Higher Education Policy Commission appointed under paragraph (A) in this subdivision.
38	(2) Members appointed by the commission and the council shall should possess a broad
39	knowledge of state and federal higher education student financial aid programs and the
40	challenges of students who may need financial help for a pathway to a college education based
41	on the merit performance of students, and have experience in administering these programs,
42	preferably at the school, campus or system level.
43	(3) The initial appointments of members shall be made as follows:
44	(A) The commission shall appoint one member to a one-year term, one member to a two-
45	year term and one member to a three-year term;
46	(B) The council shall appoint one member to a one-year term and one member to a three-

- 47 year term;
  48 (C) The West Virginia Independent Colleges and Universities shall appoint one member
  49 to a one-year term; and
  - 50 (D) The West Virginia School Counselor Association shall appoint one member to a two 51 year term.
  - 52 (4)(3) After the initial terms are completed, appointments shall be made as follows:
  - 53 (A) Members shall be appointed for three-year terms; and
  - 54 (B) Members are eligible to succeed themselves for one additional consecutive term.
  - 55 (5)(4) The term of each member begins on July 1 of the year in which the appointment is
     56 made and ends on June 30 of the year in which the appointment expires.

(e) The first meeting of the advisory board shall be called by the Vice Chancellor for
Administration, at which time the members shall elect a chairperson for an initial term ending on
July 31, 2010. The chairperson may succeed himself or herself for an additional one-year term
as chairperson. Thereafter, The term of the chairperson is for one year beginning on August 1 of
the year in which elected and ending on July 31 of the following year. A member may not serve
more than two consecutive terms as chairperson.

(f) In the event of a vacancy, a successor shall be appointed by the entity which appointed
the vacating member for the unexpired term of the vacating member. A person appointed to fill a
vacancy is eligible for reappointment for one additional consecutive term unless the time
remaining in the unexpired term is less than six months in which case the person filling the
vacancy is eligible for reappointment for two additional terms.

(g) Members of the advisory board serve without compensation, but are entitled to
reimbursement by the commission for expenses, including travel expenses, which are actually
incurred by the member in the official conduct of the business of the advisory board.

#### ARTICLE 7A. KATHERINE JOHNSON HOPE SCHOLARSHIP PROGRAM.

#### §18C-7A-1. Title.

1	This article shall be known and may be cited as the Katherine Johnson Hope Scholarship
2	Act, providing funds to supplement other sources of financial aid available to pay tuition or fees
3	for students meeting the criteria in section five of this article, to attend a West Virginia community
4	and technical college for up to four consecutive semesters.
	§18C-7A-2. Legislative findings and purpose.
1	(a) The Legislature finds and declares that:
2	(1) West Virginia must have an educated workforce in order to attract and retain the high
3	wage, high skill jobs of the twenty-first century;
4	(2) A large percentage of West Virginia residents who graduate from the state's colleges
5	and universities do not work in the state following graduation;
6	(3) Of all the states, West Virginia consistently has the lowest percentage of adults with
7	college degrees. The most important factors leading to low rates of higher education attainment
8	are known to be poverty and low parental education levels, along with low socio-economic
9	influences in the community. Enabling students to attend college who are in new college families,
10	which have never had a family member graduate from a two-year or four-year institution of higher
11	education, is vitally important to lifting the overall education level of West Virginia's population
12	and changing the culture against higher education which may exist in a number of communities
13	and families;
14	(4) Higher levels of education attainment result in higher levels of personal income over a
15	lifetime, which translates into an increased tax base and economic development for West Virginia
16	and more discretionary income for its citizens:
17	(5) Students at all education levels should have an incentive to perform at a high academic
18	level, including students in new college families, in all middle schools, junior high schools and
19	high schools;
20	(6) There is a need to provide parents, teachers and school counselors with all tools
21	possible to aid them in helping their children understand the importance of high academic

- 22 achievement in high school and college; 23 (7) The merit-based Katherine Johnson Hope Scholarship program is designed to: 24 (A) Provide an incentive for students to set higher academic standards in high school for 25 themselves and their peers; 26 (B) Encourage students to increase their high school achievement levels and enroll in 27 more rigorous courses; 28 (C) Encourage older students to enroll in more rigorous courses; 29 (D) Effect a culture change in many West Virginia communities and families toward 30 increased educational attainment; 31 (E) Result in improved standard academic test scores in the state since inception of the 32 program; and 33 (F) Encourage students who see no path to higher education for themselves and family 34 members, absent a scholarship that grants merit-based student financial aid upon proven 35 academic performance in high school or by work performance in the state after high school. 36 (b) Nothing in this article guarantees: 37 (1) A Katherine Johnson Hope Scholarship award or any specific amount of a scholarship 38 award to any student; or 39 (2) That the requirements necessary for a student to qualify for a scholarship will not be 40 changed by legislation or rule before the student is eligible to receive an award. §18C-7A-3. ## §18C-7A-4. Powers and duties of the West Virginia Council for Community and Technical College Education regarding the Katherine Johnson Hope Scholarship Program.

- 1 (a) Powers of council. In addition to the powers granted by any other provision of this
- 2 code, the West Virginia Council for Community and Technical College Education, in association
- 3 with the Higher Education Policy Commission and the Vice Chancellor for Administration, has the
- 4 powers necessary or convenient to carry out the purposes and provisions of this article including,
- 5 but not limited to, the following express powers:
- 6 (1) To promulgate legislative rules in accordance with the provisions of article three-a,
- 7 <u>chapter twenty-nine-a of this code to effectuate the purposes of this article;</u>
- 8 (2) To invest any of the funds of the scholarship program established in this article with

9 the West Virginia Investment Management Board in accordance with the provisions of article six,

- 10 chapter twelve of this code. Any investments made pursuant to this article shall be made with the
- 11 care, skill, prudence and diligence under the circumstances then prevailing that a prudent person
- 12 acting in a like capacity and familiar with such matters would use in conducting an enterprise of a
- 13 like character and with like aims. Fiduciaries shall diversify plan investments to the extent
- 14 permitted by law to minimize the risk of large losses, unless under the circumstances it is clearly
- 15 prudent not to do so:
- 16 (3) To execute contracts and other necessary instruments;

17 (4) To impose reasonable requirements for residency for students applying for the

18 <u>scholarship. Except as provided in section four, article one of this chapter, a student shall have</u>

19 met the following requirements to be eligible: (A) Completed at least one half of the credits required for high school graduation in a 20 21 public or private high school in this state; or 22 (B) Received instruction in the home or other approved place pursuant to subsection (c), 23 section one, article eight, chapter eighteen of this code for the two years immediately preceding 24 application; 25 (C) This subsection does not establish residency requirements for matriculation or fee 26 payment purposes at state institutions of higher education; 27 (5) To contract for necessary goods and services, to employ necessary personnel and to engage the services of private persons for administrative and technical assistance in carrying out 28 29 the responsibilities of the scholarship program. ## <u>§18C-7A-6. West Virginia Community and Technical College Katherine Johnson Hope</u> Scholarship Fund established.

- 1 There is hereby established in the State Treasury a nonexpiring special revenue fund
- 2 designated the Katherine Johnson Hope Scholarship Fund to be administered by the Vice
- 3 Chancellor for Administration of the Higher Education Policy Commission, solely for the purposes
- 4 provided in this article. All earnings shall accrue to and be retained by the fund unless otherwise
- 5 provided in this article. The fund may receive contributions from public or private sources. No
- 6 payments of awards from the Katherine Johnson Hope Scholarship Fund may be made until funds
- 7 are available.

NOTE: The purpose of this bill is to establish a merit-based Katherine Johnson Hope Scholarship program to provide tuition and fee payments for certain qualified students to attend state community and technical college education programs. No scholarship awards may be made until the program is funded.
