House Bill 101

By Mr. Speaker (Mr. Armstead) and Delegate Miley (By Request of the Executive)

[Introduced May 20, 2018]

A BILL to amend and reenact §5F-2-1 of the Code of West Virginia, 1931, as amended, as contained in Chapter 105, Acts of the Legislature, Regular Session, 2018; and to amend and reenact §29-1-1 and §29-1-2 of said code, all relating to the Division of Culture and History continuing as the Department of Arts, Culture and History; providing that the Library Commission and the West Virginia Educational Broadcasting Authority shall be organized within the Department of Arts, Culture and History for administrative support; providing that any references throughout this code to the "Commissioner of Culture and History" means the "Curator of Arts, Culture and History" and any references throughout this code to the "Division of Culture and History" means the "Department of Arts, Culture and History"; organizing the Department of Arts, Culture and History as a separate independent agency within the Executive Branch; continuing the Commissioner of Culture and History as the Curator of Arts, Culture and History; specifying that the curator reports directly to Governor in furtherance of purposes and duties of the department; specifying the role of the curator; specifying that the curator is to represent the department as a full participating member in meetings of department secretaries convened by the Governor.

Be it enacted by the Legislature of West Virginia:

CHAPTER 5F. REORGANIZATION OF THE EXECUTIVE BRANCH OF STATE GOVERNMENT.

ARTICLE 2. TRANSFER OF AGENCIES AND BOARDS.

§5F-2-1. Transfer and incorporation of agencies and boards; funds.

- (a) The following agencies and boards, including all of the allied, advisory, affiliated or related entities and funds associated with any agency or board, are incorporated in and administered as a part of the Department of Administration:

not affected by the enactment of this chapter. All boards that are appellate bodies or are independent decision makers shall not have their appellate or independent decision-making status affected by the enactment of this chapter.

(n) (o) Any department previously transferred to and incorporated in a department by prior enactment of this section means a division of the appropriate department. Wherever reference is made to any department transferred to and incorporated in a department created in §5F-1-2 of this code, the reference means a division of the appropriate department and any reference to a division of a department so transferred and incorporated means a section of the appropriate division of the department.

(e) (p) When an agency, board, or commission is transferred under a bureau or agency other than a department headed by a secretary pursuant to this section, that transfer is solely for purposes of administrative support and liaison with the Office of the Governor, a department secretary or a bureau. Nothing in this section extends the powers of department secretaries under §5F-2-2 of this code to any person other than a department secretary and nothing limits or abridges the statutory powers and duties of statutory commissioners or officers pursuant to this code.

CHAPTER 29. MISCELLANEOUS BOARDS AND OFFICERS.

ARTICLE 1. DIVISION OF DEPARTMENT OF ARTS, CULTURE AND HISTORY.

§29-1-1. Division of Culture and History continued <u>as the Department of Arts, Culture and History;</u> sections and commissions; purposes; definitions; effective date.

(a) The Division of Culture and History and the office of Commissioner of Culture and History heretofore created are hereby continued as the Department of Arts, Culture and History. The Governor shall nominate and, by and with the advice and consent of the Senate, appoint the commissioner Curator of Arts, Culture and History, who shall be the chief executive officer of the division department and shall be paid an annual salary as provided in §6-7-2a of this code. The

6 commissioner curator so appointed shall have: (1) A bachelor's degree in one of the fine arts,

- 7 social sciences, library science or a related field; or (2) four years' experience in the administration
- 8 of museum management, public administration, arts, history or a related field.
- 9 (b) The division department shall consist of five sections as follows:
- 10 (1) The arts section;

- 11 (2) The archives and history section:
- 12 (3) The museums section;
- 13 (4) The historic preservation section; and
- 14 (5) The administrative section.
- 15 (c) The division department shall also consist of two citizens commissions as follows:
- 16 (1) A Commission on the Arts; and
- 17 (2) A Commission on Archives and History.
 - (d) The commissioner curator shall exercise control and supervision of the division department and shall be responsible for the projects, programs and actions of each of its sections. The purpose and duty of the division department is to advance, foster and promote the creative and performing arts and crafts, including both indoor and outdoor exhibits and performances; to advance, foster, promote, identify, register, acquire, mark and care for historical, prehistorical, archaeological and significant architectural sites, structures and objects in the state; to encourage the promotion, preservation and development of significant sites, structures and objects through the use of economic development activities such as loans, subsidies, grants and other incentives; to coordinate all cultural, historical and artistic activities in state government and at state-owned facilities; to acquire, preserve and classify books, documents, records and memorabilia of historical interest or importance; and, in general, to do all things necessary or convenient to preserve and advance the arts, culture and history of the state. In the furtherance of these purposes and duties, the curator shall report directly to the Governor as a curator for both the intrinsic and extrinsic value for individuals, communities and the economy of the arts, culture and

history in West Virginia. As such, the curator shall represent the Department of Arts, Culture and History as a full participating member in meetings of the secretaries of the departments created in §5F-1-2 of this code that are convened at the call of the Governor.

- (e) The division department shall have jurisdiction and control and may set and collect fees for the use of all space in the building presently known as the West Virginia Science and Culture Center, including the deck and courtyards forming an integral part thereof; the building presently known as West Virginia Independence Hall in Wheeling, including all the grounds and appurtenances thereof; "Camp Washington Carver" in Fayette County, as provided in §29-1-14 of this code; and any other sites as may be transferred to or acquired by the division department. Notwithstanding any provision of this code to the contrary, including the provisions of article one, chapter five-b of this code, beginning on and after July 1, 1993 2018, the division department shall have responsibility for, and control of, all visitor touring and visitor tour guide activities within the state Capitol Building at Charleston.
- (f) For the purposes of this article, "commissioner" <u>or "curator"</u> means the Commissioner of <u>Curator of Arts</u>, Culture and History, and "division" <u>or "department"</u> means the Division of Department of Arts, Culture and History. <u>References throughout this code to the "Commissioner of Culture and History" mean the "Curator of Arts, Culture and History", and references throughout this code to the "Division of Culture and History" mean the "Department of Arts, Culture and History".</u>
- (g) Nothing in this article or any other provision of this code may be construed to mean that the Department of Arts, Culture and History is an executive department created pursuant to §5F-1-2 of this code, nor that the curator is the secretary of an executive department created pursuant to that section.

§29-1-2. General powers of commissioner curator.

The commissioner curator shall assign and allocate space in all facilities assigned to the division department and all space in the building presently known as the West Virginia science

and culture center, and any other buildings or sites under the control of the commissioner curator, and may, in accordance with the provisions of chapter twenty-nine-a of this code, prescribe rules, regulations and fees for the use and occupancy of said facilities, including tours.

The commissioner curator shall coordinate the operations and affairs of the sections and commissions of the division department and assign each section or commission responsibilities according to criteria the commissioner curator deems most efficient, productive and best calculated to carry out the purposes of this article. The commissioner curator shall provide to the fullest extent possible for centralization and coordination of the bookkeeping, personnel, purchasing, printing, duplicating, binding and other services which can be efficiently combined. The commissioner curator may establish such other sections for such purposes as he or she deems necessary, and may appoint directors thereof. The commissioner curator may appoint a director of the West Virginia science and culture center. The commissioner curator shall serve as the state historic preservation officer, and shall chair the capitol building commission

After consultation with the section directors and the commissions, the commissioner curator shall prepare a proposed division department budget for submission to the Governor for each fiscal year.

No contract, agreement or undertaking may be entered into by any section of the division department which involves the expenditure of funds without the express written approval of the commissioner curator as to fiscal responsibility.

The commissioner curator shall prepare and submit to the Governor an annual report in accordance with the provisions of §5-1-20 of this code, which report shall include a detailed account of the activities of each section and commission of the division department.

The commissioner curator shall employ all personnel for the sections, except for persons in the professional positions established within the sections as provided in this article; and shall supply support services to the commissions and to the Governor's Mansion Advisory Committee.

NOTE: The purpose of this bill is to reestablish the Division of Culture and History as the Department of Arts, Culture and History, which shall be a separate independent agency within the Executive Branch. The Commissioner of Culture and History will become the Curator of Arts, Culture and History. The Curator reports directly to the Governor and represents the department as a full participating member in meeting of the cabinet secretaries convened by the Governor. Also, the Library Commission and Educational Broadcast Authority are to be organized within the department for administrative support.
