1 A BILL making a supplementary appropriation of federal funds out of the Treasury from the  
 2 balance of federal moneys remaining unappropriated for the fiscal year ending June 30,  
 3 2018, to the Department of Education, State Board of Education – School Lunch Program,  
 4 fund 8713, fiscal year 2018, organization 0402, and to the Department of Education, State  
 5 Board of Education – Vocational Division, fund 8714, fiscal year 2018, organization 0402,  
 6 by supplementing and amending the appropriations for the fiscal year ending June 30,  
 7 2018.

8 Whereas, The Governor has established the availability of federal funds for expenditure  
 9 in the fiscal year ending June 30, 2018 which is hereby appropriated by the terms of this  
 10 supplementary appropriation bill; therefore

11 *Be it enacted by the Legislature of West Virginia:*

12 That the total appropriation for the fiscal year ending June 30, 2018, to fund 8713, fiscal  
 13 year 2018, organization 0402, be supplemented and amended by increasing an existing item of  
 14 appropriation as follows:
