Be it enacted by the Legislature of West Virginia:

#### ARTICLE 16. UNIFORM PARTITION OF HEIRS PROPERTY ACT.

#### §37-16-1. Short title.

1 This may be cited as the "Uniform Partition of Heirs Property Act.

#### §37-16-2. Definitions.

- 1 "Ascendant" means an individual who precedes another individual in lineage, in the direct
- 2 line of ascent from the other individual.
- 3 "Collateral" means an individual who is related to another individual under the law of
- 4 intestate succession of this state but who is not the other individual's ascendant or descendant.
- 5 <u>"Descendant" means an individual who follows another individual in lineage, in the direct</u>
- 6 line of descent from the other individual.
- 7 <u>"Determination of value" means a court order determining the fair market value of heirs</u>

| 10 | "Heirs property" means real property held in tenancy in common which satisfies all of the            |
| 11 | following requirements as of the filing of a partition action:                                       |

| 14 | (2) One or more of the cotenants acquired title from a relative, whether living or deceased;         |

| 18 | (B) Twenty percent or more of the interests are held by an individual who acquired title             |

| 21 | "Partition by sale" means a court-ordered sale of the entire heirs property, whether by              |
| 22 | auction, sealed bids, or open-market sale conducted under §37-16-10 of this code.                    |
| 23 | "Partition in kind" means the division of heirs property into physically distinct and                |
| 24 | separately titled parcels.   |
| 25 | "Record" means information that is inscribed on a tangible medium or that is stored in an            |
| 26 | electronic or other medium and is retrievable in perceivable form.                                   |
| 27 | "Relative" means an ascendant, descendant, or collateral or an individual otherwise                  |
| 28 | related to another individual by blood, marriage, adoption, or under the law of this state.          |
|    | §37-16-3. Applicability; relation to other law.  |
| 1  | (a) This article applies to partition actions filed on or after the effective date of this act.      |
| 2  | (b) In an action to partition real property under §37-4-1, et seq. of this code, the court shall     |
| 3  | determine whether the property is heirs property. If the court determines that the property is heirs |

|   | <u>§37-16-4. Notice; Service by posting.</u>   |
| 1 | (a) This article does not limit or affect the method by which service of a complaint in a            |
| 2 | partition action may be made.  |
| 3 | (b) If the plaintiff in a partition action seeks an order of notice by publication and the court     |
| 4 | determines that the property may be heirs property, the plaintiff, not later than ten days after the |
| 5 | court's determination, shall post and maintain while the action is pending a conspicuous sign on     |
| 6 | the property that is the subject of the action. The sign must state that the action has commenced    |
| 7 | and identify the name and address of the court and the common designation by which the property      |
| 8 | is known. The court may require the plaintiff to publish on the sign, the name of the plaintiff and  |
| 9 | the known defendants.  |
|   | <u>§37-16-5. Commissioners.</u>  |

|   | §37-16-6. Determination of value.  |
| 1 | (a) Except as otherwise provided in §37-16-6(b) and §37-16-6(c) of this code, if the court           |
| 2 | determines that the property that is the subject of a partition action is heirs property, the court  |
| 3 | shall determine the fair market value of the property by ordering an appraisal pursuant to §37-16-   |
| 4 | 6(d) of this code.   |
| 5 | (b) If all cotenants have agreed to the value of the property or to another method of                |
| 6 | valuation, the court shall adopt that value or the value produced by the agreed method of            |

| 22 | (f) If an appraisal is filed with the court pursuant to §37-16-6(d) of this code, the court shall     |
| 23 | conduct a hearing to determine the fair market value of the property not sooner than 30 days after    |
| 24 | a copy of the notice of the appraisal is sent to each party under §37-16-6(e) of this code, whether   |
| 25 | or not an objection to the appraisal is filed under §37-16-6(e)(3) of this code. In addition to the   |
| 26 | court-ordered appraisal, the court may consider any other evidence of value offered by a party.       |
| 27 | (g) After a hearing under §37-16-6(f) of this code, but before considering the merits of the          |
| 28 | partition action, the court shall determine the fair market value of the property and send notice to  |
| 29 | the parties of the value.   |

| 1  | (a) If any cotenant requested partition by sale, after the determination of value under §37-          |

2 <u>16-6 of this code, the court shall send notice to the parties that any cotenant except a cotenant</u>

3 <u>that requested partition by sale may buy all the interests of the cotenants that requested partition</u>

(b) Not later than forty-five days after the notice is sent under §37-16-7(a) of this code,

- 6 <u>any cotenant except a cotenant that requested partition by sale may give notice to the court that</u>
  7 <u>it elects to buy all the interests of the cotenants that requested partition by sale.</u>
- 8 (c) The purchase price for each of the interests of a cotenant that requested partition by
- 9 sale is the value of the entire parcel determined under §37-16-6 of this code multiplied by the
- 10 <u>cotenant's fractional ownership of the entire parcel.</u>
- 11 (d) After expiration of the period in §37-16-7(b) of this code, the following rules apply:
- 12 (1) If only one cotenant elects to buy all the interests of the cotenants that requested
- 13 partition by sale, the court shall notify all the parties of that fact.
- 14 (2) If more than one cotenant elects to buy all the interests of the cotenants that requested
- 15 partition by sale, the court shall allocate the right to buy those interests among the electing
- 16 cotenants based on each electing cotenant's existing fractional ownership of the entire parcel
- 17 divided by the total existing fractional ownership of all cotenants electing to buy and send notice
- 18 to all the parties of that fact and of the price to be paid by each electing cotenant.
- 19 (3) If no cotenant elects to buy all the interests of the cotenants that requested partition by
- 20 sale, the court shall send notice to all the parties of that fact and resolve the partition action under
- 21 §37-16-8(a) and §37-16-8(b) of this code.
- 22 (e) If the court sends notice to the parties under §37-16-7(d)(1) of this code or §37-16-
- 23 <u>7(d)(2) of this code, the court shall set a date, not sooner than sixty days after the date the notice</u>
- 24 was sent, by which electing cotenants must pay their apportioned price into the court. After this
- 25 <u>date, the following rules apply:</u>
- (1) If all electing cotenants timely pay their apportioned price into court, the court shall
   issue an order reallocating all the interests of the cotenants and disburse the amounts held by the
   court to the persons entitled to them.

| 44 | cotenants that requested partition by sale were not purchased.   |
| 45 | (3) If more than one cotenant pays the entire price for the remaining interest, the court              |
| 46 | shall reapportion the remaining interest among those paying cotenants, based on each paying            |
| 47 | cotenant's original fractional ownership of the entire parcel divided by the total original fractional |
| 48 | ownership of all cotenants that paid the entire price for the remaining interest. The court shall      |
| 49 | issue promptly an order reallocating all of the cotenants' interests, disburse the amounts held by     |
| 50 | it to the persons entitled to them, and promptly refund any excess payment held by the court.          |
| 51 | (g) Not later than forty-five days after the court sends notice to the parties pursuant to §37-        |
| 52 | 16-7(a) of this code, any cotenant entitled to buy an interest under this section may request the      |
| 53 | court to authorize the sale as part of the pending action of the interests of cotenants named as       |
| 54 | defendants and served with the complaint but that did not appear in the action.                        |

| 3  | §37-16-7 of this code, a cotenant remains that has requested partition in kind, the court shall order   |
| 4  | partition in kind unless the court, after consideration of the factors listed in §37-16-9 of this code, |
| 5  | finds that partition in kind will result in substantial prejudice to the cotenants as a group. In       |
| 6  | considering whether to order partition in kind, the court shall approve a request by two or more        |
| 7  | parties to have their individual interests aggregated.  |
| 8  | (b) If the court does not order partition in kind under §37-16-8(a) of this code, the court             |
| 9  | shall order partition by sale pursuant to §37-16-10 of this code or, if no cotenant requested           |
| 10 | partition by sale, the court shall dismiss the action.  |
| 11 | (c) If the court orders partition in kind pursuant to §37-16-8(a) of this code, the court may           |
| 12 | require that one or more cotenants pay one or more other cotenants amounts so that the                  |
| 13 | payments, taken together with the value of the in-kind distributions to the cotenants, will make the    |
| 14 | partition in kind just and proportionate in value to the fractional interests held.                     |
| 15 | (d) If the court orders partition in kind, the court shall allocate to the cotenants that are           |
| 16 | unknown, unlocatable, or the subject of a default judgment, if their interests were not bought out      |
| 14 | partition in kind just and proportionate in value to the fraction                                       |

### §37-16-9. Considerations for Partition in Kind.

- 1 (a) In determining under §37-16-8(a) of this code whether partition in kind would result in
- 2 <u>substantial prejudice to the cotenants as a group, the court shall consider the following:</u>
- 3 (1) Whether the heirs property practicably can be divided among the cotenants;
- 4 (2) Whether partition in kind would apportion the property in such a way that the aggregate
- 5 <u>fair market value of the parcels resulting from the division would be materially less than the value</u>
- 6 of the property if it were sold as a whole, taking into account the condition under which a court-
- 7 ordered sale likely would occur;
- 8 (3) Evidence of the collective duration of ownership or possession of the property by a
- 9 cotenant and one or more predecessors in title or predecessors in possession to the cotenant
- 10 who are or were relatives of the cotenant or each other;
- 11 (4) A cotenant's sentimental attachment to the property, including any attachment arising
- 12 because the property has ancestral or other unique or special value to the cotenant;
- 13 (5) The lawful use being made of the property by a cotenant and the degree to which the
- 14 cotenant would be harmed if the cotenant could not continue the same use of the property;
- 15 (6) The degree to which the cotenants have contributed their pro rata share of the property
- 16 taxes, insurance, and other expenses associated with maintaining ownership of the property or
- 17 <u>have contributed to the physical improvement, maintenance, or upkeep of the property; and</u>
- 18 (7) Any other relevant factor.
- 19 (b) The court may not consider any one factor in §37-16-8(a) of this code to be dispositive
- 20 <u>without weighing the totality of all relevant factors and circumstances.</u>

### §37-16-10. Open-market sale, sealed bids, or auction.

- 1 (a) If the court orders a sale of heirs property, the sale must be an open-market sale unless
- 2 the court finds that a sale by sealed bids or an auction would be more economically advantageous

| 16 | reasonable time an offer to purchase the property for at least the determination of value, the court,  |
| 17 | after hearing, may:  |
| 18 | (1) Approve the highest outstanding offer, if any;   |
| 19 | (2) Redetermine the value of the property and order that the property continue to be                   |
| 20 | offered for an additional time; or   |
| 21 | (3) Order that the property be sold by sealed bids or at an auction.                                   |
| 22 | (e) If the court orders a sale by sealed bids or an auction, the court shall set terms and             |
| 23 | conditions of the sale. If the court orders an auction, the auction must be conducted under §37-       |
| 24 | 4-1 et seq. of this code.  |
| 25 | (f) If a purchaser is entitled to a share of the proceeds of the sale, the purchaser is entitled       |
| 26 | to a credit against the price in an amount equal to the purchaser's share of the proceeds.             |
|    | §37-16-11. Report of Open-Market Sale.   |

1 (a) Unless required to do so within a shorter time by §37-16-1 et. seq. of this code a broker

- 2 appointed under §37-16-10(b) of this code to offer heirs property for open market sale shall file a
- 3 report with the court not later than seven days after receiving an offer to purchase the property
- 4 for at least the value determined under §37-16-6 or §37-16-10 of this code.
- 5 (b) The report required by §37-16-11(a) of this code shall contain the following information:
- 6 (1) A description of the property to be sold to each buyer;
- 7 (2) The name of each buyer;
- 8 (3) The proposed purchase price;
- 9 (4) The terms and conditions of the proposed sale, including the terms of any owner
- 10 financing;
- 11 (5) The amounts to be paid to lienholders;
- 12 (6) A statement of contractual or other arrangements or conditions of the broker's
- 13 commission; and
- 14 (7) Other material facts relevant to the sale.

#### §37-16-12. Uniformity of Application and Construction.

- 1 In applying and construing this uniform act, consideration must be given to the need to
- 2 promote uniformity of the law with respect to its subject matter among states that enact it.

#### §37-16-13. Relation to Electronic Signatures in Global and National Commerce Act.

- 1 This article modifies, limits and supersedes the Electronic Signatures in Global and
- 2 National Commerce Act, 15 U.S.C. Section 7001 et seq., but does not modify, limit or supersede
- 3 Section 101(c) of that act, 15 U.S.C. Section 7001(c), or authorize electronic delivery of any of
- 4 the notices described in Section 103(b) of that act, 15 U.S.C. Section 7003(b).

NOTE: The purpose of this bill is to enact the Uniform Partition of Heirs Property Act. The bill defines terms and provides for a court hearing to determine if the partition action concerns heirs' property and the manner in which such property and interests may be sold. The bill also provides for uniformity of application and construction; and modifies, limits and supersedes the Electronic Signatures in Global and National Commerce Act, *15 U.S.C. Section 7001 et seq.* 

Strike-throughs indicate language that would be stricken from a heading or the present law and underscoring indicates new language that would be added.
