1 AN ACT supplementing and amending by decreasing and increasing existing appropriations of  
2 public moneys out of the Treasury in the State Fund, General Revenue, to the Department  
3 of Health and Human Resources – Division of Human Services, fund 0403, fiscal year  
4 2018, organization 0511, to the Department of Health and Human Resources,  
5 Consolidated Medical Services Fund, fund 0525, fiscal year 2018, organization 0506, to  
6 the Bureau of Senior Services, fund 0420, fiscal year 2018, organization 0508, and to the  
7 Department of Health and Human Resources – Division of Health – Central Office, fund  
8 0407, fiscal year 2018, organization 0506, by supplementing, amending, increasing, and  
9 decreasing the appropriations for the fiscal year ending June 30, 2018.

10 Whereas, The Governor submitted to the Legislature the Executive Budget Document,  
11 dated January 10, 2018, which included a statement of the State Fund, General Revenue, setting  
12 forth therein the cash balance as of July 1, 2017, and further included the estimate of revenues  
13 for the fiscal year 2018, less net appropriation balances forwarded and regular appropriations for  
14 the fiscal year 2018; and

15 Whereas, There are available cash balances in the Medical Services Program Fund and  
16 the Lottery and Excess Lottery funds that can be utilized in order to decrease the appropriations  
17 from the State Fund, General Revenue; and

18 Whereas, It appears from the Executive Budget Document, statement of the State Fund,  
19 General Revenue, and this legislation, there will remain an unappropriated balance in the State  
20 Treasury which is available for appropriation during the fiscal year ending June 30, 2018;  
21 therefore

22 *Be it enacted by the Legislature of West Virginia:*

23 That the total appropriation for the fiscal year ending June 30, 2018, to fund 0403, fiscal  
24 year 2018, organization 0511, be supplemented and amended by decreasing existing items of  
25 appropriation as follows:
