1 AN ACT supplementing and amending by decreasing existing appropriations and adding new
2 appropriations of public moneys out of the Treasury in the State Fund, General Revenue,
3 to the Department of Health and Human Resources – Division of Human Services, fund
4 0403, fiscal year 2018, organization 0511, to the Department of Military Affairs and Public
5 Safety, Division of Corrections – Correctional Units, fund 0450, fiscal year 2018,
6 organization 0608, and to the Department of Military Affairs and Public Safety, Division of
7 Juvenile Services, fund 0570, fiscal year 2018, organization 0621, by supplementing,
8 amending, adding, and decreasing the appropriations for the fiscal year ending June 30,
9 2018.

10 Whereas, The Governor submitted to the Legislature the Executive Budget Document,
11 dated January 10, 2018, which included a statement of the State Fund, General Revenue, setting
12 forth therein the cash balance as of July 1, 2017, and further included the estimate of revenues
13 for the fiscal year 2018, less net appropriation balances forwarded and regular appropriations for
14 the fiscal year 2018; and

15 Whereas, There are available cash balances in the Medical Services Program Fund that
16 can be utilized in order to decrease the appropriations from the State Fund, General Revenue;
17 and

18 Whereas, It appears from the Executive Budget document, statement of the State Fund,
19 General Revenue, and this legislation, there will remain an unappropriated balance in the State
20 Treasury which is available for appropriation during the fiscal year ending June 30, 2018;
21 therefore

22 *Be it enacted by the Legislature of West Virginia:*

23 That the total appropriation for the fiscal year ending June 30, 2018, to fund 0403, fiscal
24 year 2018, organization 0511, be supplemented and amended by decreasing an existing item of
25 appropriation as follows:
