1 AN ACT expiring funds to the unappropriated surplus balance in the State Fund, General
2 Revenue, for the fiscal year ending June 30, 2018, in the amount of \$1,620,000 from the
3 Department of Revenue, Insurance Commissioner - Insurance Commission Fund, fund
4 7152, fiscal year 2018, organization 0704, and making a supplementary appropriation of
5 public moneys out of the Treasury from the balance of moneys remaining as an
6 unappropriated surplus balance in the State Fund, General Revenue, to the Department
7 of Health and Human Resources, Division of Health – Consolidated Medical Services
8 Fund, fund 0525, fiscal year 2018, organization 0506, by supplementing and amending
9 the appropriations for the fiscal year ending June 30, 2018.

1 Whereas, The Governor submitted to the Legislature the Executive Budget Document,
2 dated January 10, 2018, which included a statement of the State Fund, General Revenue, setting
3 forth therein the cash balance as of July 1, 2017, and further included the estimate of revenues
4 for the fiscal year 2018, less net appropriation balances forwarded and regular appropriations for
5 the fiscal year 2018, and further included recommended expirations to the surplus balance of the
6 State Fund, General Revenue; and

7 Whereas, It appears from the Executive Budget Document, statement of the State Fund,
8 General Revenue, and this legislation, there now remains an unappropriated surplus balance in
9 the State Treasury which is available for appropriation during the fiscal year ending June 30,
10 2018; therefore

Be it enacted by the Legislature of West Virginia:

1 That the balance of the funds available for expenditure in the fiscal year ending June 30,
2 2018, in the Department of Revenue Insurance Commissioner - Insurance Commission Fund,
3 fund 7152, fiscal year 2018, organization 0704, be decreased by expiring the amount of
4 \$1,620,000, to the unappropriated surplus balance of the State Fund, General Revenue, to be
5 available for appropriation during the fiscal year ending June 30, 2018.

1 And, That the total appropriation for the fiscal year ending June 30, 2018, to fund 0525,
2 fiscal year 2018, organization 0506, be supplemented and amended by increasing an existing
3 item of appropriation and by adding a new item of appropriation as follows:

4 TITLE II – APPROPRIATIONS.

5 Section 1. Appropriations from general revenue.

6 DEPARTMENT OF HEALTH AND HUMAN RESOURCES

7 57 – Consolidated Medical Services Fund
