1	A BILL supplementing, amending, decreasing, and increasing items of the existing appropriations
2	from the State Road Fund to the Department of Transportation, Division of Highways, fund
3	9017, fiscal year 2020, organization 0803, for the fiscal year ending June 30, 2020.
4	WHEREAS, The Governor submitted to the Legislature the Executive Budget Document,
5	dated January 9, 2019, which included a statement of the State Road Fund setting forth therein
6	the cash balances and investments as of July 1, 2018, and further included the estimate of
7	revenues for the fiscal year 2019, less regular appropriations for the fiscal year 2019 and that also
8	sets forth therein, the estimated cash balance and investments as of July 1, 2019, and further
9	included the estimate of revenues for the fiscal year 2020, less regular appropriations for the fiscal
10	year 2020; and
11	WHEREAS, The Governor submitted to the Legislature an Executive Message, dated May
12	20, 2019, which included a revised estimate of revenues for the State Road Fund and a statement
13	of the State Fund, State Road Fund for the fiscal year 2019; and
14	WHEREAS, It appears from the Statement of the State Road Fund there now remains an
15	unappropriated balance in the State Treasury which is available for appropriation during the fiscal
16	year ending June 30, 2020; therefore
17	Be it enacted by the Legislature of West Virginia:
18	That the total appropriation for the fiscal year ending June 30, 2020, to fund 9017, fiscal
19	year 2020, organization 0803, be supplemented and amended by decreasing existing items of
20	appropriation as follows:
