[Introduced May 20, 2019]

1 A BILL supplementing, amending, increasing and adding new items of appropriations to the
 2 Executive, Attorney General, Consolidated Federal Fund, fund 8882, fiscal year 2020,
 3 organization 1500, in the amount of \$1,533,581, by supplementing and amending chapter
 4 thirty-one, Acts of the Legislature, Regular Session, 2019, known as the budget bill.

5 WHEREAS, The Legislature passed Senate Bill 318, Regular Session, 2019, transferring
 6 the Medicaid Fraud Control Unit previously established within the West Virginia Department of
 7 Health and Human Resources to the Office of the Attorney General; and

8 WHEREAS, Based upon the passage of Senate Bill 318, Regular Session, 2019, the
 9 Governor has established there will be funds available for expenditure in the Attorney General,
 10 Consolidated Federal Fund, fund 8882, fiscal year 2020, organization 1500 during the fiscal year
 11 ending June 30, 2020; and

12 WHEREAS, West Virginia Code, Chapter 4, Article 11, Section 3 of the code requires the
 13 Governor to itemize in the state budget and in the budget bill, on a line-item basis, separately, for
 14 each spending unit, the amount and purpose of all federal funds received or anticipated for
 15 expenditure; therefore

16 *Be it enacted by the Legislature of West Virginia:*

17 That chapter thirty-one, Acts of the Legislature, Regular Session, 2019, known as the
 18 budget bill, be supplemented and amended by adding to Title II, section six thereof, the following:

19 **TITLE II – APPROPRIATIONS.**

20 **Sec. 6. Appropriations of federal funds.**
