1 AN ACT supplementing, amending, decreasing, and increasing items of the existing
2 appropriations from the State Road Fund to the Department of Transportation, Division of
3 Highways, fund 9017, fiscal year 2019, organization 0803, for the fiscal year ending June
4 30, 2019.

5 WHEREAS, The Governor submitted to the Legislature the Executive Budget Document,
6 dated January 9, 2019, which included a statement of the State Road Fund setting forth therein
7 the cash balances and investments as of July 1, 2018, and further included the estimate of
8 revenues for the fiscal year 2019, less regular appropriations for the fiscal year 2019; and

9 WHEREAS, It appears from the Statement of the State Road Fund there now remains an
10 unappropriated balance in the State Treasury which is available for appropriation during the fiscal
11 year ending June 30, 2019; therefore

Be it enacted by the Legislature of West Virginia:

1 That the total appropriation for the fiscal year ending June 30, 2019, to fund 9017, fiscal
2 year 2019, organization 0803, be supplemented and amended by decreasing existing items of
3 appropriation as follows:
