1 AN ACT supplementing and amending by increasing and decreasing existing items of  
2 appropriations of public moneys out of the Treasury in the State Fund, General Revenue,  
3 from the Department of Health and Human Resources, Division of Health, fund 0407, fiscal  
4 year 2020, organization 0506 to the Department of Agriculture, fund 0131, fiscal year  
5 2020, organization 1400, by supplementing, amending, increasing and decreasing items  
6 of appropriation for the fiscal year ending June 30, 2020.

7 WHEREAS, The Legislature passed Senate Bill 496, Regular Session, 2019, transferring  
8 the regulation of milk and milk products previously established within the West Virginia  
9 Department of Health and Human Resources to the Department of Agriculture; and

10 WHEREAS, Based upon the passage of Senate Bill 496, Regular Session, 2019, the  
11 Governor has established there are now funds available for expenditure in the Department of  
12 Health and Human Resources, fund 0407, fiscal year 2020, organization 0506 during the fiscal  
13 year ending June 30, 2020; therefore

*Be it enacted by the Legislature of West Virginia:*
