1 AN ACT making a supplementary appropriation of Lottery Net Profits by increasing existing items
2 of appropriation from the balance of moneys remaining as an unappropriated balance in
3 Lottery Net Profits to the Department of Arts, Culture and History, Division of Culture and
4 History, Lottery Education Fund, fund 3534, fiscal year 2020, organization 0432, by
5 supplementing and amending the appropriations for the fiscal year ending June 30, 2020.

6 WHEREAS, The Governor submitted to the Legislature the Executive Budget Document
7 to the Legislature on January 9, 2019, which included a Statement of the Lottery Fund setting
8 forth therein the unappropriated cash balance as of July 1, 2019, and further included the estimate
9 of revenues for the fiscal year 2020, less regular appropriations for fiscal year 2020; and

10 WHEREAS, It appears from the Governor's Statement of the Lottery Fund, there now
11 remains an unappropriated balance in the State Treasury which is available for appropriation
12 during the fiscal year ending June 30, 2020; therefore

Be it enacted by the Legislature of West Virginia:

1 That the total appropriation for the fiscal year ending June 30, 2020, to fund 3534, fiscal
2 year 2020, organization 0432 be supplemented and amended by increasing existing items of
3 appropriation as follows:
