1 AN ACT supplementing and amending by decreasing and increasing existing items of
2 appropriation of public moneys out of the Treasury in the State Fund, General Revenue,
3 to the Department of Arts, Culture, and History, Educational Broadcasting Authority, fund
4 0300, fiscal year 2020, organization 0439, by supplementing and amending the
5 appropriations for the fiscal year ending June 30, 2020.

6 Whereas, The Governor submitted to the Legislature the Executive Budget Document,
7 dated January 9, 2019, which included a statement of the State Fund, General Revenue, setting
8 forth therein the cash balance as of July 1, 2019, and further included an estimate of revenues
9 for the fiscal year 2020, less net appropriation balances forwarded and regular appropriations for
10 the fiscal year 2020; and

11 Whereas, It appears from the Executive Budget Document, statement of the State Fund,
12 General Revenue, there remains an unappropriated balance in the State Treasury which is
13 available for appropriation during the fiscal year ending June 30, 2020; therefore

Be it enacted by the Legislature of West Virginia:

1 That the total appropriation for the fiscal year ending June 30, 2020, to fund 0300, fiscal
2 year 2020, organization 0439, be supplemented and amended by decreasing an existing item of
3 appropriation as follows:




