1 AN ACT expiring funds to the unappropriated surplus balance in the State Fund, General
2 Revenue, for the fiscal year ending June 30, 2019 in the amount of \$4,705,000 from the
3 Treasurer's Office, Unclaimed Property Fund, fund 1324, fiscal year 2019, organization
4 1300, and making a supplementary appropriation of public moneys out of the Treasury
5 from the balance of moneys remaining as an unappropriated surplus balance in the State
6 Fund, General Revenue, to the Executive, Governor's Office, fund 0101, fiscal year 2019,
7 organization 0100, by supplementing and amending the appropriations for the fiscal year
8 ending June 30, 2019.

9 Whereas, The Governor finds that the account balance in the Treasurer's Office,
10 Unclaimed Property Fund, fund 1324, fiscal year 2019, organization 1300, exceeds that which is
11 necessary for the purposes for which the account was established; therefore

Be it enacted by the Legislature of West Virginia:

1 That the balance of the funds available for expenditure in the fiscal year ending June 30,
2 2019, in the Treasurer's Office, Unclaimed Property Fund, fund 1324, fiscal year 2019,
3 organization 1300, be decreased by expiring the amount of \$4,705,000 to the unappropriated
4 surplus balance of the State Fund, General Revenue, to be available for appropriation during the
5 fiscal year ending June 30, 2019.

6 And, That the total appropriation for the fiscal year ending June 30, 2019, to fund 0101,
7 fiscal year 2019, organization 0100, be supplemented and amended by adding a new item of
8 appropriation as follows:
