1 AN ACT supplementing and amending by adding a new item of appropriation of public moneys  
2 out of the Treasury in the State Fund, General Revenue, to the Governor’s Office, Civil  
3 Contingent Fund, fund 0105, fiscal year 2019, organization 0100, by supplementing and  
4 amending the appropriations for the fiscal year ending June 30, 2019.

5 Whereas, The Governor submitted to the Legislature the Executive Budget document,  
6 dated January 9, 2019, which included a Statement of the State Fund, General Revenue, setting  
7 forth therein the cash balance as of July 1, 2018, and further included a revised estimate of  
8 revenues for the fiscal year 2019, less net appropriation balances forwarded and regular  
9 appropriations for the fiscal year 2019; and

10 Whereas, It appears from the Executive Budget document, Statement of the State Fund,  
11 General Revenue, there remains an unappropriated balance in the State Treasury which is  
12 available for appropriation during the fiscal year ending June 30, 2019; therefore

*Be it enacted by the Legislature of West Virginia:*

1 That the total appropriation for the fiscal year ending June 30, 2019, to fund 0105, fiscal  
2 year 2019, organization 0100, be supplemented and amended by adding a new item of  
3 appropriation as follows:
