1 AN ACT making a supplementary appropriation of public moneys out of the Treasury from the
2 balance of moneys remaining unappropriated for the fiscal year ending June 30, 2019, to
3 the Department of Military Affairs and Public Safety, Division of Justice and Community
4 Services – Second Chance Driver’s License Program Account, fund 6810, fiscal year
5 2019, organization 0620, by supplementing and amending the appropriations for the fiscal
6 year ending June 30, 2019.

7 Whereas, The Governor has established that there now remains an unappropriated
8 balance in the Department of Military Affairs and Public Safety, Division of Justice and Community
9 Services – Second Chance Driver’s License Program Account, fund 6810, fiscal year 2019,
10 organization 0620, that is available for expenditure during the fiscal year ending June 30, 2019,
11 which is hereby appropriated by the terms of this supplementary appropriation bill; therefore

Be it enacted by the Legislature of West Virginia:

1 That the total appropriation for the fiscal year ending June 30, 2019, to fund 6810, fiscal
2 year 2019, organization 0620, be supplemented and amended by increasing an existing item of
3 appropriation as follows:
