1 AN ACT making a supplementary appropriation of Lottery Net Profits by adding a new item of  
2 appropriation from the balance of moneys remaining as an unappropriated balance in  
3 Lottery Net Profits to the Department of Education and the Arts, Educational Broadcasting  
4 Authority, fund 3587, fiscal year 2019, organization 0439, by supplementing and amending  
5 the appropriations for the fiscal year ending June 30, 2019.

6 Whereas, The Governor submitted the Executive Budget Document to the Legislature on  
7 January 9, 2019, which included a statement of the Lottery Fund, setting forth therein the  
8 unappropriated cash balance as of July 1, 2018, and further included the estimate of revenues  
9 for the fiscal year 2019, less regular appropriations for fiscal year 2019; and

10 Whereas, It appears from the Governor's Statement of the Lottery Fund, there now  
11 remains an unappropriated balance in the State Treasury which is available for appropriation  
12 during the fiscal year ending June 30, 2019; therefore

*Be it enacted by the Legislature of West Virginia:*

1 That the total appropriation for the fiscal year ending June 30, 2019, be supplemented and  
2 amended by adding a new item of appropriation as follows:
