1 A BILL expiring funds to the balance of the Department of Health and Human Resources, Division  
2 of Human Services, Medical Services Program Fund, fund 5084, organization 0511, in the  
3 amount of \$3,000,000 from the Department of Administration, Premium Tax Savings  
4 Fund, fund 2367, fiscal year 2020, organization 0218; in the amount of \$2,000,000 from  
5 the Department of Health and Human Resources, Division of Health, Hospital Services  
6 Revenue Account Special Fund, Capital Improvement, Renovation and Operations, fund  
7 5156, fiscal year 2020, organization 0506; and in the amount of \$360,000 from the  
8 Department of Health and Human Resources, Division of Human Services, Marriage  
9 Education Fund, fund 5490, fiscal year 2020, organization 0511, by supplementing and  
10 amending chapter 31, Acts of the Legislature, regular session, 2019, known as the Budget  
11 Bill.

12 Whereas, The Governor finds that the account balance in the Department of  
13 Administration, Premium Tax Savings Fund, fund 2367, fiscal year 2020, organization 0218, the  
14 Department of Health and Human Resources, Division of Health, Hospital Services Revenue  
15 Account Special Fund, Capital Improvement, Renovation and Operations, fund 5156, fiscal year  
16 2020, organization 0506, and the Department of Health and Human Resources, Division of  
17 Human Services, Marriage Education Fund, fund 5490, fiscal year 2020, organization 0511,  
18 exceed that which is necessary for the purposes for which the accounts were established;  
19 therefore

*Be it enacted by the Legislature of West Virginia:*

1 That the balance of funds available for expenditure in the fiscal year ending June 30, 2020,  
2 to the Department of Administration, Premium Tax Savings Fund, fund 2367, fiscal year 2020,  
3 organization 0218, be decreased by expiring the amount of \$3,000,000; that the balance of funds  
4 available for expenditure to the Department of Health and Human Resources, Division of Health,  
5 Hospital Services Revenue Account Special Fund, Capital Improvement, Renovation and  
6 Operations, fund 5156, fiscal year 2020, organization 0506, be decreased by expiring the amount

7 of \$2,000,000 and the balance of funds available for expenditure to the Department of Health and  
8 Human Resources, Division of Human Services, Marriage Education Fund, fund 5490, fiscal year  
9 2020, organization 0511, be decreased by expiring the amount of \$360,000 all to the Department  
10 of Health and Human Resources, Division of Human Services, Medical Services Program Fund,  
11 fund 5084, organization 0511, during the fiscal year ending June 30, 2020.

NOTE: The purpose of supplemental appropriation bill is to expire funds in the aforesaid accounts for the designated spending units during the fiscal year 2020.
