1 AN ACT to amend and reenact §20-2-30 of the Code of West Virginia, 1931, as amended; relating  
2 to eligibility for license or permit application and unlawful acts when applying for a license  
3 or permit.

*Be it enacted by the Legislature of West Virginia:*

**ARTICLE 2. WILDLIFE RESOURCES.**

**§20-2-30. Application and statement of eligibility for licenses or permits; procuring license  
or permit in violation of chapter.**

1 (a) Each person who applies for any class of license or permit must state to the issuing  
2 agent that he or she is eligible for and has satisfied all prerequisites required by this chapter for  
3 that class of license or permit.

4 (b) It is unlawful for a person to make a false statement when applying for any license or  
5 permit issued pursuant to the provisions of this chapter.
