[Passed June 24, 2021; in effect from passage]



1 AN ACT making a supplementary appropriation by adding a new item of appropriation and  
2 increasing the expenditure of public moneys out of the Treasury from the balance of  
3 moneys remaining as an unappropriated balance in the State Fund, General Revenue, to  
4 the Department of Revenue, Office of the Secretary, fund 0465, fiscal year 2021,  
5 organization 0701, by supplementing and amending the appropriations for the fiscal year  
6 ending June 30, 2021.

1 Whereas, The Governor submitted to the Legislature the Executive Budget Document,  
2 dated February 10, 2021, which included a Statement of the State Fund, General Revenue,  
3 setting forth therein the cash balance as of July 1, 2020, and further included an estimate of  
4 revenues for the fiscal year 2021, less net appropriation balances forwarded and regular  
5 appropriations for the fiscal year 2021; and

1 Whereas, The Governor submitted to the Legislature an Executive Message dated June  
2 7, 2021, which included a revised estimate of revenues for the State Fund, General Revenue,  
3 and a Statement of the State Fund, General Revenue, for the fiscal year 2021; and

1 Whereas, The Governor submitted to the Legislature an Executive Message dated June  
2 24, 2021, which included a revised estimate of revenues for the State Fund, General Revenue,  
3 and a Statement of the State Fund, General Revenue, for the fiscal year 2021; and

1 Whereas, It appears from the Statement of the State Fund, General Revenue, and  
2 Executive messages, there remains an unappropriated balance in the State Treasury which is  
3 available for appropriation during the fiscal year ending June 30, 2021; therefore

*Be it enacted by the Legislature of West Virginia:*

1 That the total appropriation for the fiscal year ending June 30, 2021, to fund 0465, fiscal  
2 year 2021, organization 0701, be supplemented and amended by adding a new item of  
3 appropriation as follows:
