1 A BILL supplementing and amending the appropriations of public moneys out of the Treasury 2 from the balance of moneys remaining as an unappropriated balance in the State Fund, 3 General Revenue, to the Department of Homeland Security, Division of Justice and Community Services, fund 0546, fiscal year 2022, organization 0623, by supplementing 4 5 and amending Chapter 11, Acts of the Legislature, Regular Session, 2021, known as the 6 Budget Bill, for the fiscal year ending June 30, 2022. 7 WHEREAS, The Governor submitted to the Legislature the Executive Budget document, 8 dated February 10, 2021, which included a Statement of the State Fund, General Revenue, 9 setting forth therein the cash balance as of July 1, 2020, and further included an estimate of 10 revenues for the fiscal year 2022 less net appropriation balances forwarded and regular 11 appropriations for the fiscal year 2022; and 12 WHEREAS, The Governor submitted to the Legislature an Executive Message dated June 13 24, 2021, which included a revised estimate of revenues for the State Fund, General Revenue 14 and a statement of the State Fund, General Revenue for the fiscal year 2021, and further included 15 an estimate of revenues for the fiscal year 2022 less net appropriation balances forwarded and 16 regular appropriations for the fiscal year 2022; and 17 WHEREAS, It appears from the Executive Message dated June 24, 2021, Statement of 18 the State Fund, General Revenue there remains an unappropriated balance in the State Treasury 19 which is available for appropriation during the fiscal year ending June 30, 2022; therefore 20 Be it enacted by the Legislature of West Virginia: 21 That Chapter eleven, Acts of the Legislature, Regular Session, 2021, known as the budget 22 bill to fund 0546, fiscal year 2022, organization 0623 be supplemented and amended to read as 23 follows:

Section 1. Appropriations from general revenue.

52	20	From the above appropriation for Current Expenses (fund 0546, appropriation 13000),
53	21	\$4,000,000 shall be used for the Victims of Crime Act (VOCA); and \$100,000 shall be
54	22	used for Court Appointed Special Advocates.
55	23	From the above appropriation for Child Advocacy Centers (fund 0546, appropriation
56	24	45800), the division may retain an amount not to exceed four percent of the appropriation
57	25	for administrative purposes.

NOTE: The purpose of supplemental appropriation bill is to supplement, amend, and increase an existing item of appropriation in the aforesaid account for the designated spending unit for expenditure during the fiscal year 2022.
