1 A BILL to amend and reenact §64-3-1 of the Code of West Virginia, 1931, as amended, all relating 2 generally to authorizing certain agencies of the Department of Environmental Protection 3 to promulgate legislative rules; authorizing the rules as filed and as modified by the Legislative Rule-Making Review Committee; authorizing the Department of Environmental 4 5 Protection to promulgate a legislative rule relating to ambient air guality standards; 6 authorizing the Department of Environmental Protection to promulgate a legislative rule 7 relating to standards of performance for new stationary sources; authorizing the 8 Department of Environmental Protection to promulgate a legislative rule relating to control 9 of air pollution from combustion of solid waste; authorizing the Department of 10 Environmental Protection to promulgate a legislative rule relating to control of air pollution 11 from municipal solid waste landfills; authorizing the Department of Environmental 12 Protection to promulgate a legislative rule relating to acid rain provisions and permits; authorizing the Department of Environmental Protection to promulgate a legislative rule 13 14 relating to emission standards for hazardous air pollutants; authorizing the Department of 15 Environmental Protection to promulgate a legislative rule relating to control of greenhouse 16 gas emissions from existing coal-fired electric utility generating units; authorizing the 17 Department of Environmental Protection to promulgate a legislative rule relating to 18 requirements governing water guality standards; authorizing the Department of 19 Environmental Protection to promulgate a legislative rule relating to hazardous waste 20 management system; and authorizing the Department of Environmental Protection to 21 promulgate a legislative rule relating to voluntary remediation and redevelopment rule.

Be it enacted by the Legislature of West Virginia:

ARTICLE 3. AUTHORIZATION FOR DEPARTMENT OF ENVIRONMENTAL PROTECTION TO PROMULGATE LEGISLATIVE RULES.

§64-3-1. Department of Environmental Protection.

(a) The legislative rule filed in the State Register on August 26, 2020, authorized under the
 authority of §22-5-4 of this code, relating to the Department of Environmental Protection (ambient
 air quality standards, 45 CSR 08), is authorized.

4 (b) The legislative rule filed in the State Register on August 26, 2020, authorized under the
5 authority of §22-5-4 of this code, relating to the Department of Environmental Protection
6 (standards of performance for new stationary sources, 45 CSR 16), is authorized.

7 (c) The legislative rule filed in the State Register on August 26, 2020, authorized under the
8 authority of §22-5-4 of this code, relating to the Department of Environmental Protection (control
9 of air pollution from combustion of solid waste, 45 CSR 18), is authorized.

(d) The legislative rule filed in the State Register on August 26, 2020, authorized under the
authority of §22-5-4 of this code, relating to the Department of Environmental Protection (control
of air pollution from municipal solid waste landfills, 45 CSR 23), is authorized.

(e) The legislative rule filed in the State Register on August 26, 2020, authorized under the
authority of §22-5-4 of this code, relating to the Department of Environmental Protection (acid rain
provisions and permits, 45 CSR 33), is authorized.

(f) The legislative rule filed in the State Register on August 26, 2020, authorized under the
authority of §22-5-4 of this code, relating to the Department of Environmental Protection (emission
standards for hazardous air pollutants, 45 CSR 34), is authorized.

(g) The legislative rule filed in the State Register on August 26, 2020, authorized under the authority of §22-5-4 of this code, modified by the Department of Environmental Protection to meet the objections of the Legislative Rule-Making Review Committee and refiled in the State Register on September 28, 2020, relating to the Department of Environmental Protection (control of greenhouse gas emissions from existing coal-fired electric utility generating units, 45 CSR 44), is authorized.

(h) The legislative rule filed in the State Register on August 17, 2020, authorized under the
authority of §22-11-4 of this code, modified by the Department of Environmental Protection to
meet the objections of the Legislative Rule-Making Review Committee and refiled in the State
Register on December 22, 2020, relating to the Department of Environmental Protection
(requirements governing water quality standards, 47 CSR 02), is authorized.

30 (i) The legislative rule filed in the State Register on August 25, 2020, authorized under the
31 authority of §22-18-6 of this code, relating to the Department of Environmental Protection
32 (hazardous waste management system, 33 CSR 20), is authorized.

(j) The legislative rule filed in the State Register on August 25, 2020, authorized under the
authority of §22-22-3 of this code, modified by the Department of Environmental Protection to
meet the objections of the Legislative Rule-Making Review Committee and refiled in the State
Register on December 11, 2020, relating to the Department of Environmental Protection
(voluntary remediation and redevelopment rule, 60 CSR 03), is authorized.

NOTE: The purpose of this bill is to authorize the Department of Environmental Protection to promulgate a legislative rule relating to ambient air quality standards.
