21	for prior disability; providing awards and benefits to surviving spouse and additional death
22	benefits and scholarships for dependent children; providing for burial benefit; prohibiting
23	double death benefits; establishing exemption from taxation, garnishment and other
24	process; authorizing certain deductions; establishing the effect of qualified domestic
25	relation orders; prohibiting fraud; establishing criminal penalties; requiring repayment in
26	certain circumstances; providing for treatment of prior military service; establishing

effective date of the system; providing voluntary employer participation; establishing
starting date for benefits; limiting county liability; and providing for no forfeiture of benefits
if system terminates.

Be it enacted by the Legislature of West Virginia:

CHAPTER 5. GENERAL POWERS AND AUTHORITY OF THE GOVERNOR, SECRETARY OF STATE AND ATTORNEY GENERAL; BOARD OF PUBLIC WORKS; MISCELLANEOUS AGENCIES, COMMISSIONS, OFFICES, PROGRAMS, ETC.

ARTICLE 10A. DISQUALIFICATION FOR PUBLIC RETIREMENT PLAN BENEFITS. §5-10A-2. Definitions.

1 As used in this article:

2 (a) "Retirement plan" or "plan" means the Public Employees Retirement Act pursuant to 3 §5-10-1 et seq. of this code; each municipal employees retirement plan pursuant to §8-22-1 et 4 seq. this code; each policemen's and firemen's pension and relief fund pursuant to §8-22-1 et 5 seq. of this code; the West Virginia Municipal Police Officers and Firefighters Retirement System 6 pursuant to §8-22-1 et seq. of this code; the West Virginia State Police Death, Disability and 7 Retirement Fund pursuant to §15-2-1 et seq. of this code; the West Virginia State Police 8 Retirement System pursuant to §15-2A-1 et seq. of this code; the State Teachers Retirement 9 System pursuant to §18-7A-1 et seq. of this code; the Teachers' Defined Contribution Retirement 10 System pursuant to §18-7B-1 et seq. of this code; the Deputy Sheriff Retirement System pursuant 11 to §7-14D-1 et seq. of this code; the higher education retirement plan and supplemental retirement 12 plans pursuant to §18-23-4a of this code; the Judges' Retirement System pursuant to §51-9-1 et 13 seq. of this code; the West Virginia Emergency Medical Services Retirement System pursuant to 14 article five-v, chapter sixteen §16-5V-1 et seq. of this code; the 911 Emergency Services

15 Retirement System established in §7-28-1 et seq. of this code; and any other plan established pursuant to this code for the payment of pension, annuity, disability or other benefits to any person 16 17 by reason of his or her service as an officer or employee of this state or of any political subdivision. 18 agency or instrumentality thereof, whenever the plan is supported, in whole or in part, by public 19 funds. 20 (b) "Beneficiary" means any person eligible for or receiving benefits on account of the 21 service for a public employer by a participant or former participant in a retirement plan. 22 (c) "Benefits" means pension, annuity, disability or any other benefits granted pursuant to 23 a retirement plan.

(d) "Conviction" means a conviction on or after the effective date of this article in any
federal or state court of record whether following a plea of guilty, not guilty, or nolo contendere
and whether or not the person convicted was serving as an officer or employee of a public
employer at the time of the conviction.

(e) "Former participant" means any person who is no longer eligible to receive any benefit
under a retirement plan because full distribution has occurred.

30 (f) "Less than honorable service" means:

31 (1) Impeachment and conviction of a participant or former participant under the provisions
32 of Article IV, §9 of the Constitution of West Virginia, except for a misdemeanor;

(2) Conviction of a participant or former participant of a felony for conduct related to his or
 her office or employment which he or she committed while holding the office or during the
 employment; or

36 (3) Conduct of a participant or former participant which constitutes all of the elements of a
37 crime described in either subdivision (1) or (2) of this subsection but for which the participant or
38 former participant was not convicted because:

- 45 (g) "Participant" means any person eligible for or receiving any benefit under a retirement
 46 plan on account of his or her service as an officer or employee for a public employer.

47 (h) "Public employer" means the State of West Virginia and any political subdivision,
48 agency or instrumentality thereof for which there is established a retirement plan.

(i) "Supervisory board" or "board" means the Consolidated Public Retirement Board; the
board of trustees of any municipal retirement fund; the board of trustees of any policemen's or
firemen's retirement plan; the governing board of any supplemental retirement plan instituted
pursuant to authority granted by the previous provisions of §18-23-4a of this code; and any other
board, commission, or public body having the duty to supervise and operate any retirement plan.

ARTICLE 10D. CONSOLIDATED PUBLIC RETIREMENT BOARD.

§5-10D-1. Consolidated Public Retirement Board continued; members; vacancies; investment of plan funds.

1 (a) The Consolidated Public Retirement Board is continued to administer all public 2 retirement plans in this state. It shall administer the Public Employees Retirement System 3 established in §5-10-1 et seq. of this code; the Teachers Retirement System established in §18-4 7A-1 et seq. of this code; the Teachers' Defined Contribution Retirement System created by §18-5 7B-1 et seq. of this code; the West Virginia State Police Death, Disability, and Retirement Fund 6 created by §15-2-1 et seq. of this code: the West Virginia State Police Retirement System created 7 by §15-2A-1 et seq. of this code; the Deputy Sheriff Death, Disability, and Retirement Fund created by §7-14D-1 et seq. of this code; the Judges' Retirement System created under §51-9-1 8 9 et seq. of this code; the Emergency Medical Services Retirement System established in §16-5V-10 1 et seq. of this code; the 911 Emergency Services Retirement System established in §7-28-1 et

seq. of this code; and the Municipal Police Officers and Firefighters Retirement System
established in §8-22A-1 *et seq.* of this code, and the West Virginia Division of Natural Resources
Retirement System created by §20-18-1 *et seq.* of this code.
(b) The membership of the Consolidated Public Retirement Board consists of:
(1) The Governor or his or her designee;

- 16 (2) The State Treasurer or his or her designee;
- 17 (3) The State Auditor or his or her designee;
- 18 (4) The Secretary of the Department of Administration or his or her designee;

(5) Four residents of the state, who are not members, retirants, or beneficiaries of any of
the public retirement systems, to be appointed by the Governor, with the advice and consent of
the Senate; and

22 (6) A member, annuitant, or retirant of the Public Employees Retirement System who is 23 or was a state employee; a member, annuitant, or retirant of the Public Employees Retirement 24 System who is not or was not a state employee; a member, annuitant, or retirant of the Teachers 25 Retirement System; a member, annuitant, or retirant of the West Virginia State Police Death, 26 Disability, and Retirement Fund; a member, annuitant, or retirant of the West Virginia State Police 27 Retirement System; a member, annuitant, or retirant of the Deputy Sheriff Death, Disability, and 28 Retirement Fund; a member, annuitant, or retirant of the Teachers' Defined Contribution 29 Retirement System; a member, annuitant, or retirant of the Emergency Medical Services 30 Retirement System; one person who is a member, annuitant, or retirant of a municipal policemen's 31 or firemen's pension and relief fund or the West Virginia Municipal Police Officers and Firefighters 32 Retirement System, and beginning as soon as practicable after January 1, 2022, one person who 33 is a member, annuitant or retirant of the West Virginia Division of Natural Resources Police Officer 34 Retirement System, all to be appointed by the Governor, with the advice and consent of the Senate. The Governor shall choose the member representing the municipal policemen's or 35 firemen's pension and relief fund or the West Virginia Municipal Police Officers and Firefighters 36

37 Retirement System from two names submitted by the state's largest organization of professional 38 police officers and two names submitted by the state's largest organization of professional 39 firefighters. Representation of the municipal police officers and firefighters shall alternate after 40 each term on the board between persons having police officer and firefighter affiliation so that 41 each professional group is represented on the board every other term.

All appointees to the board shall have recognized competence or significant experience in pension management or administration, actuarial analysis, institutional management, or accounting. Those members appointed prior to January 1, 2010, shall be considered to have met these qualifications. One trustee shall be an attorney experienced in finance and pension matters and one trustee shall be a certified public accountant. Each member of the board must <u>shall</u> complete annual fiduciary training and timely complete any conflict of interest forms required to serve as a trustee.

(c) The appointed members of the board shall serve five-year terms. A member appointed pursuant to subdivision (b)(6) of this section ceases to be a member of the board if he or she ceases to be a member of the represented system. If a vacancy occurs in the appointed membership, the Governor, within 60 days, shall fill the vacancy by appointment for the unexpired term. No more than seven appointees may be of the same political party.

54 (d) The Consolidated Public Retirement Board has all the powers, duties, responsibilities, 55 and liabilities of the Public Employees Retirement System established pursuant to §5-10-1 et seq. 56 of this code; the Teachers' Retirement System established pursuant to §18-7A-1 et seq. of this 57 code; the Teachers' Defined Contribution Retirement System established pursuant to §18-7B-1 58 et seq. of this code; the West Virginia State Police Death, Disability, and Retirement Fund created 59 pursuant to §15-2-1 et seq. of this code; the West Virginia State Police Retirement System created 60 by §15-2A-1 et seq. of this code; the Deputy Sheriff Death, Disability, and Retirement Fund 61 created pursuant to §7-14D-1 et seq. of this code; the Judges' Retirement System created 62 pursuant to §51-9-1 et seq. of this code; the Emergency Medical Services Retirement System

Division of Natural Resources Police Officers Retirement System created and established
pursuant to article §20-18-1 *et seq.* of this code and their appropriate governing boards.

(e) The Consolidated Public Retirement Board may propose rules for legislative approval,
in accordance with §29A-3-1 *et seq.* of this code, necessary to effectuate its powers, duties, and
responsibilities: *Provided*, That the board may adopt any or all of the rules, previously
promulgated, of a retirement system which it administers.

(f)(1) The Consolidated Public Retirement Board shall continue to transfer all funds received for the benefit of the retirement systems, including, but not limited to, all employer and employee contributions, to the West Virginia Investment Management Board: *Provided*, That the employer and employee contributions of the Teachers' Defined Contribution Retirement System, established in §18-7B-3 of this code, and voluntary deferred compensation funds invested by the West Virginia Consolidated Public Retirement Board pursuant to §5-10B-5 of this code may not be transferred to the West Virginia Investment Management Board.

(2) The board may recover from a participating employer that fails to pay any amount due a retirement system in a timely manner the contribution due and an additional amount not to exceed interest or other earnings lost as a result of the untimely payment, or a reasonable minimum fee, whichever is greater, as provided by legislative rule promulgated pursuant to the provisions of §29A-3-1 *et seq.* of this code. Any amounts recovered shall be administered in the same manner in which the amount due is required to be administered.

(g) Notwithstanding any provision of this code or any legislative rule to the contrary, all
assets of the public retirement plans set forth in subsection (a) of this section shall be held in trust.
The Consolidated Public Retirement Board is a trustee for all public retirement plans, except with
regard to the investment of funds: *Provided*, That the Consolidated Public Retirement Board is a

trustee with regard to the investments of the Teachers' Defined Contribution Retirement System and any other assets of the public retirement plans administered by the Consolidated Public Retirement Board as set forth in subsection (a) of this section for which no trustee has been expressly designated in this code.

CHAPTER 7. COUNTY COMMISSIONS AND OFFICERS.

ARTICLE 28. 911 EMERGENCY SERVICES RETIREMENT SYSTEM ACT.

§7-28-1. Title.

<u>This article is known and may be cited as the "West Virginia 911 Emergency Services</u>
 Retirement System Act."

§7-28-2. Definitions.

- 1 <u>As used in this article, unless a federal law or regulation or the context clearly requires a</u>
- 2 <u>different meaning:</u>
- 3 (a) "Accrued benefit" means on behalf of any member two and six-tenths percent per year 4 of the member's final average salary for the first 20 years of credited service. Additionally, two 5 percent per year for 21 through 25 years and one percent per year for 26 through 30 years will be 6 credited with a maximum benefit of 67 percent. A member's accrued benefit may not exceed the 7 limits of Section 415 of the Internal Revenue Code and is subject to §7-28-12 of this code. 8 (1) The board may upon the recommendation of the board actuary increase the 9 employees' contribution rate to 10 and five-tenths percent should the funding of the plan not reach 10 70 percent funded by the July 1, 2024. The board shall decrease the contribution rate to eight and 11 one-half percent once the plan funding reaches the 70 percent support objective as of any later
- 12 actuarial valuation date.

13	(2) Upon reaching the 75 percent actuarial funded level, as of an actuarial valuation date,
14	the board shall increase the two and six-tenths percent to two and three-quarter percent for the
15	first 20 years of credited service. The maximum benefit will also be increased from 67 percent to
16	70 percent.
17	(b) "Accumulated contributions" means the sum of all retirement contributions deducted
18	from the compensation of a member, or paid on his or her behalf as a result of covered
19	employment, together with regular interest on the deducted amounts.
20	(c) "Active military duty" means full-time active duty with any branch of the armed forces
21	of the United States, including service with the national guard or reserve military forces when the
22	member has been called to active full-time duty and has received no compensation during the
23	period of that duty from any board or employer other than the armed forces.
24	(d) "Actuarial equivalent" means a benefit of equal value computed upon the basis of the
25	mortality table and interest rates as set and adopted by the board in accordance with the
26	provisions of this article.
27	(e) "Annual compensation" means the wages paid to the member during covered
28	employment within the meaning of Section 3401(a) of the Internal Revenue Code, but determined
29	without regard to any rules that limit the remuneration included in wages based upon the nature
30	or location of employment or services performed during the plan year plus amounts excluded
31	under Section 414(h)(2) of the Internal Revenue Code and less reimbursements or other expense
32	allowances, cash or noncash fringe benefits or both, deferred compensation and welfare benefits.
33	Annual compensation for determining benefits during any determination period may not exceed
34	\$100,000 as adjusted for cost-of-living in accordance with Section 401(a)(17)(B) of the Internal
35	Revenue Code.
36	(f) "Annual leave service" means accrued annual leave.

57	(g) "Annuity starting date" means the first day of the month for which an annuity is payable

39	payments commence after the normal retirement age, "retirement" means the first day of the
40	month following or coincident with the latter of the last day the member worked in covered
41	employment or the member's normal retirement age and after completing proper written

43	(h) "Board" means the Consolidated Public Retirement Board.
44	(i) "County commission or political subdivision" has the meaning ascribed to it in this code.

47	are received under this article; or (3) concurrent employment by a 911 emergency services officer

49	the secondary employment requires the 911 emergency services officer to be a member of
50	another retirement system which is administered by the Consolidated Public Retirement Board
51	pursuant to this code: Provided, That the 911 emergency services officer contributes to the fund
52	created in this article the amount specified as the member's contribution in §7-28-8 of this code
53	(k) "Credited service," means the sum of a member's years of service, active military duty,
54	disability service and accrued annual and sick leave service.
55	(I) "911 emergency services officer" means an individual employed by the State, county
56	or other political subdivision as a dispatch professional that is qualified to respond or aid in the
57	response of emergency and nonemergency calls and/or the dispatching of public safety personnel
58	for law enforcement, fire services, and emergency medical services.
59	(m) "Dependent child" means either:
60	(1) An unmarried person under age 18 who is:
61	(A) A natural child of the member;
62	(B) A legally adopted child of the member;
63	(C) A child who at the time of the member's death was living with the member while the
64	member was an adopting parent during any period of probation; or

123	(1) Attainment of age 50 years and the completion of 20 or more years of regular
124	contributory service, excluding active military duty, disability service and accrued annual and sick
125	leave service.
126	(2) While still in covered employment, attainment of at least age 50 years and when the
127	sum of current age plus regular contributory years of service equals or exceeds 70 years;
128	(3) While still in covered employment, attainment of at least age 60 years and completion
129	of 10 years of regular contributory service; or
130	(4) Attainment of age 62 years and completion of five or more years of regular contributory
131	service.
132	(x) "Public Employees Retirement System" means the West Virginia Public Employee's
133	Retirement System created by West Virginia Code.
134	(y) "Plan" means the West Virginia Emergency Medical Services Retirement System

136	(z) "Plan year" means the 12-month period commencing on January 1 of any designated

1	(a) This section applies to rollovers and transfers as specified in this section made on or
2	after July 1, 2021. Notwithstanding any provision of this article to the contrary that would otherwise
3	prohibit or limit rollovers and plan transfers to this system, the plan shall accept the following
4	rollovers and plan transfers on behalf of a member solely for the purpose of purchasing permissive
5	service credit, in whole or in part, as otherwise provided in this article or for the repayment of

18	That any rollovers or transfers pursuant to this section shall be accepted by the system only if
19	made in cash or other asset permitted by the board and only in accordance with such policies,

21	the following definitions apply:
22	(1) "Permissive service credit" means service credit which is permitted to be purchased
23	under the terms of the retirement system by voluntary contributions in an amount which does not

31	(b) Nothing in this section may be construed as permitting rollovers or transfers into this

33	section and no rollover or transfer shall be accepted into the system in an amount greater than
34	the amount required for the purchase of permissive service credit or repayment of withdrawn or
35	refunded contributions.
36	(c) Nothing in this section shall be construed as permitting the purchase of service credit
37	or repayment of withdrawn or refunded contributions except as otherwise permitted in this article.
	§7-28-16. Retirement credited service through member's use, as option, of accrued annual
	or sick leave days.

1	Any member accruing annual leave or sick leave days may, after the effective date of this
2	section, elect to use the days at the time of retirement to acquire additional credited service in this
3	retirement system: Provided, That the accrued annual or sick leave may not be used to purchase
4	health insurance under the Public Employees Insurance Agency until the member reaches the
5	age of 55. The days shall be applied on the basis of two workdays' credit granted for each one

28	form which is the benefit to which he or she is entitled according to his or her accrued benefit
29	based on his or her final average salary and credited service at the time of his or her actual
30	retirement and following the completion of an application for retirement as required by the board.
31	(d) Retirement benefits shall be paid monthly in an amount equal to one twelfth of the
32	retirement income payments elected and at those times established by the board.

1	(a) The surviving spouse of any member who, after the effective date of this article while
2	in covered employment, has died or dies by reason of injury, illness or disease resulting from an
3	occupational risk or hazard inherent in or peculiar to the service required of members, while the
4	member was or is engaged in the performance of his or her duties as an 911 emergency services

5	officer, or the survivor spouse of a member who dies from any cause while receiving benefits
6	pursuant to §7-28-19 of this code, is entitled to receive and shall be paid from the fund benefits
7	as determined in subsection (b) of this section: To the surviving spouse annually, in equal monthly
8	installments during his or her lifetime an amount equal to the greater of: (1) Two thirds of the
9	annual compensation received in the preceding 12-month period by the deceased member; or (2)

	<u>§7-28-25. Same — When member dies from nonservice-connected causes.</u>
1	(a) If a member who has been a member for at least 10 years, while in covered
2	employment after the effective date of this article, has died or dies from any cause other than
3	those specified in §7-28-24 of this code and not due to vicious habits, intemperance or willful
4	misconduct on his or her part, the fund shall pay annually in equal monthly installments to the
5	surviving spouse during his or her lifetime, a sum equal to the greater of: (1) One half of the annual
6	compensation received in the preceding 12-month employment period by the deceased member;
7	or (2) if the member dies after his or her early or normal retirement age, the monthly amount which

	§7-28-26. Additional death benefits and scholarships — Dependent children.
1	(a) In addition to the spouse death benefits in this article, the surviving spouse is entitled
2	to receive and there shall be paid to the spouse \$100 monthly for each dependent child.
3	(b) If the surviving spouse dies or if there is no surviving spouse, the fund shall pay monthly

§7-28-27. Burial benefit.

1 The right of a person to any benefit provided for in this article may not be subject to 2 execution, attachment, garnishment, the operation of bankruptcy or insolvency laws, or other 3 process whatsoever, nor shall any assignment thereof be enforceable in any court except that the 4 benefits or contributions under this system shall be subject to "qualified domestic relations orders" 5 as that term is defined in Section 414(p) of the Internal Revenue Code as applicable to 6 governmental plans: Provided, That if a member is covered by a group insurance or prepayment 7 plan participated in by a participating public employer, and if he or she is permitted to, and elects 8 to, continue such coverage as a retirant, he or she may authorize the board of trustees to have 9 deducted from his or her annuity the payments required of him or her to continue coverage under 10 such group insurance or prepayment plan: Provided, however, That a participating public 11 employer may setoff for any claim arising from embezzlement by, or fraud of, a member, retirant 12 or beneficiary. The assets of the retirement system are hereby exempt from state, county and

§7-28-30. Fraud; penalties; and repayment.

1 Any person who knowingly makes any false statement or who falsifies or permits to be 2 falsified any record of the retirement system in any attempt to defraud that system is guilty of a 3 misdemeanor and, upon conviction thereof, shall be punished by a fine not to exceed \$1,000, by 4 confinement in jail not to exceed one year, or by both fine and confinement. Any increased benefit 5 received by any person as a result of the falsification or fraud shall be returned to the fund upon 6 demand by the board. §7-28-31. Credit toward retirement for member's prior military service; credit toward retirement when member has joined armed forces in time of armed conflict; gualified military service. 1 (a) Any member who has previously served on active military duty is entitled to receive 2 additional years of service for the purpose of determining his or her years of credited service for 3 a period equal to the active military duty not to exceed five years, subject to the following: 4 (1) That he or she has been honorably discharged from the armed forces; 5 (2) That he or she substantiates by appropriate documentation or evidence his or her 6 period of active military duty; and 7 (3) That he or she is receiving no benefits from any other retirement system for his or her 8 active military duty. 9 (b) In addition, any member who while in covered employment was commissioned, 10 enlisted or inducted into the armed forces of the United States or, being a member of the reserve 11 officers' corps, was called to active duty in the armed forces between September 1, 1940, and 12 the close of hostilities in World War II, or between June 27, 1950, and the close of the armed 13 conflict in Korea on July 27, 1953, between August 1,1964, and the close of the armed conflict in 14 Vietnam, or during any other period of armed conflict by the United States whether sanctioned by 15 a declaration of war by Congress or by executive or other order of the President, is entitled to and

16	shall receive credited service, for a period equal to the full time that he or she has or, pursuant to
17	that commission, enlistment, induction or call, shall have served with the armed forces subject to
18	the following:
19	(1) That he or she has been honorably discharged from the armed forces;
20	(2) That within 90 days after honorable discharge from the armed forces, he or she
21	presented himself or herself to the county commission or other political subdivision and offered to
22	resume service as a 911 emergency services officer; and
23	(3) That he or she has made no voluntary act, whether by reenlistment, waiver of
24	discharge, acceptance of commission or otherwise, to extend or participate in extension of the
25	period of service with the armed forces beyond the period of service for which he or she was
26	originally commissioned, enlisted, inducted or called.
27	(c) The total amount of service allowable under subsections (a) and (b) of this section may
28	not exceed five years.
29	(d) Any service credit allowed under this section may be credited one time only for each
30	911 emergency services officer, regardless of any changes in job title or responsibilities.
31	(e) Notwithstanding any provision of this section to the contrary, contributions, benefits
32	and service credit with respect to qualified military service shall be provided in accordance with
33	Section 414(u) of the Internal Revenue Code. For purposes of this section, "qualified military
34	service" has the same meaning as in Section 414(u) of the Internal Revenue Code. The
35	Retirement Board is authorized to determine all questions and make all decisions relating to this
36	section and, pursuant to the authority granted to the board in §5-10D-1 of this code, may
37	promulgate rules relating to contributions, benefits and service credit to comply with Section
38	414(u) of the Internal Revenue Code.
	§7-28-32. How a county commission or political subdivision becomes a participating public
	employer.

1 <u>Any county commission or political subdivision employing 911 emergency services officers</u>

2	may by a three-fifths vote of its governing body, or by a majority vote of its electors, elect to
3	become a participating public employer and thereby include its 911 emergency services officers
4	in the membership of the plan. The clerk or secretary of each such county commission or political
5	subdivision electing to become a participating public employer shall certify the determination of
6	the county commission or political subdivision to the Consolidated Public Retirement Board within
7	10 days from and after the vote of the governing body or the canvass of votes upon such action.
8	Once a county commission or political subdivision elects to participate in the plan, the action is

1	(a) The provisions of this article become effective July 1, 2021: Provided, That no payout
2	of any benefits may be made to any person prior to the first day of January 1, 2022: Provided,
3	however, That members who retired due to a disability may begin receiving the benefits at the
4	rate and in the amount specified in this article, from this fund after June 30, 2021: Provided further,
5	That until June 30, 2021, those members who retired due to a disability may draw benefits from
6	this fund at the rate and in the amount set forth in §5-10-25 of this code.
7	(b) During the 18-month period before the payout of benefits begins, the Joint Committee
8	on Government and Finance shall cause an interim study or studies to be conducted on potential
9	effects of the implementation of this retirement system, including, but not limited to, potential
10	funding mechanisms to provide health insurance coverage for retirees in the 50 to 55 age group:

§7-28-34. Limitation of county liability.

- 1 <u>No county which has timely met all of its obligations under this article is liable for any</u>
- 2 payments or contributions to the 911 emergency services retirement plan which are owed to the
- 3 plan by another county or counties.

§7-28-35. Benefits not forfeited if system terminates.

- 1 If the retirement system is terminated or contributions are completely discontinued, the
- 2 rights of all members to benefits accrued or contributions made to the date of the termination or
- 3 discontinuance, to the extent then funded, are not forfeited.

NOTE: The purpose of this bill is to establish a 911 Emergency Services Retirement System.
