1 A BILL expiring funds to the unappropriated surplus balance in the State Fund, General Revenue,
2 for the fiscal year ending June 30, 2021, in the amount of \$200,000 from the WV Board of
3 Examiners for Registered Professional Nurses – Registered Professional Nurses, fund
4 8520, organization 0907, fiscal year 2021, and making a supplementary appropriation of
5 public moneys out of the Treasury from the balance of moneys remaining as an
6 unappropriated surplus balance in the State Fund, General Revenue, to the Department
7 of Commerce, West Virginia Development Office, fund 0256, fiscal year 2021,
8 organization 0307, by supplementing and amending the appropriations for the fiscal year
9 ending June 30, 2021.

10 WHEREAS, The Governor submitted to the Legislature the Executive Budget document,
11 dated February 10, 2021, which included a Statement of the State Fund, General Revenue,
12 setting forth therein the cash balance as of July 1, 2020, and further included the estimate of
13 revenues for the fiscal year 2021, less net appropriation balances forwarded and regular
14 appropriations for the fiscal year 2021 and further included recommended expirations to the
15 surplus balance of the State Fund, General Revenue; and

16 WHEREAS, It appears from the Executive Budget document, Statement of the State Fund,
17 General Revenue, and this legislation, there now remains an unappropriated surplus balance in
18 the State Treasury which is available for appropriation during the fiscal year ending June 30,
19 2021; therefore

Be it enacted by the Legislature of West Virginia:

1 That the balance of the funds available for expenditure in the fiscal year ending June 30,
2 2021, in the WV Board of Examiners for Registered Professional Nurses – Registered
3 Professional Nurses, fund 8520, organization 0907, fiscal year 2021, be decreased by expiring
4 the amount of \$200,000, to the unappropriated surplus balance of the State Fund, General
5 Revenue to be available for appropriation during the fiscal year ending June 30, 2021.

6 And, That the total appropriation for the fiscal year ending June 30, 2021, to fund 0256,
7 fiscal year 2021, organization 0307, be supplemented by increasing existing items of
8 appropriation as follows:

10 **Section 1. Appropriations from general revenue.**

19 From the above appropriation for Current Expenses - Surplus (fund 0256, appropriation),
20 \$200,000 shall be used for the West Virginia Nurses Association for a Nurses Assisting Nursing
21 Program.

NOTE: The purpose of this supplemental appropriation bill is to expire funds to the surplus balance of General Revenue and to supplement and increase an item of appropriation in the aforesaid account for the designated spending unit for expenditure during the fiscal year 2021.
