§36-1-25. Public easement by prescription.

1 (a) When the owner of the property has notice of the establishment and continued use of 2 the surface of the private property by members of the public as a road or path for a period of 20 3 or more years and does not condition or limit its use, a public easement for that road or path may 4 be established by court order. 5 (b) Any member of the public who uses the road or path may petition the circuit court in 6 the county where the property exists for the establishment of a public easement to transverse the 7 property. The court may establish the public easement if the court fines the following conditions 8 exist: 9 (1) The property owner has actual or constructive notice of the existence of the path or 10 road and has taken no action to prohibit or condition its use; 11 (2) The court finds that the regular vehicular use of the road or path is by members of the 12 public or local community, and not just by adjacent or nearby property owners; and 13 (3) That granting the public easement will not result in a substantial reduction in the value 14 of the private property, that the public or local community derives benefit from use of the road or 15 path, and therefore it in the public interest to the public or the local community to establish a public 16 easement by prescription. 17 (c) For the purposes of this section, the term:

18	(1) "Public easement" means the right of transverse that has vested in the public or a local
19	community by their regular vehicular use of a road or path through private property to another
20	location;
21	(2) "Constructive notice" means that the property owner, through the exercise of
22	reasonable care, would have knowledge of the creation and use or a road or path that has been
23	used by members of the public to traverse through the property; and
24	(3) "Road or path" means an open way or line of travel that is observable and indicated by

- 25 physical or other evidence of vehicular use of property as a thruway across the surface of the
- 26 property.
- 27 (d) The provisions of this section are effective July 1, 2021, and are retroactive in
- 28 <u>calculation of the time period necessary for establishing the easement.</u>

NOTE: The purpose of this bill is to allow the establishment of a prescriptive public easement on private property for roads or paths traversed by the public in vehicles over a period of 20 or more years.
