[Passed April 10, 2021; in effect from passage.]



1 AN ACT supplementing and amending the appropriations of public moneys out of the Treasury  
2 from the balance of moneys remaining as an unappropriated surplus balance in the State  
3 Fund, General Revenue, to the Department of Veterans' Assistance, Department of  
4 Veterans' Assistance fund 0456, fiscal year 2021, organization 0613, by supplementing  
5 and amending the appropriations for the fiscal year ending June 30, 2021.

1 WHEREAS, The Governor submitted to the Legislature the Executive Budget document,  
2 dated February 10, 2021, which included a Statement of the State Fund, General Revenue,  
3 setting forth therein the cash balance as of July 1, 2020, and further included the estimate of  
4 revenues for the fiscal year 2021, less net appropriation balances forwarded and regular  
5 appropriations for the fiscal year 2021; and

6 WHEREAS, It appears from the Executive Budget Document, Statement of the State  
7 Fund, General Revenue, and this legislation, there now remains an unappropriated surplus  
8 balance in the State Treasury which is available for appropriation during the fiscal year ending  
9 June 30, 2021; therefore

*Be it enacted by the Legislature of West Virginia:*

1 That the total appropriation for the fiscal year ending June 30, 2021, to fund 0456, fiscal  
2 year 2021, organization 0613, be supplemented and amended by adding a new item of  
3 appropriation as follows:
