1 A BILL expiring funds to the balance of the Department of Transportation, State Rail Authority -
2 West Virginia Commuter Rail Access Fund, fund 8402, fiscal year 2021, organization
3 0804 in the amount of \$750,000 from the Department of Revenue, Insurance
4 Commissioner – Insurance Commission Fund, fund 7152, fiscal year 2021, organization
5 0704, and making a supplementary appropriation of public moneys out of the Treasury
6 for the fiscal year ending June 30, 2021.

1 WHEREAS, The Governor finds that the account balance in the Department of Revenue,
2 Insurance Commissioner – Insurance Commission Fund, fund 7152, fiscal year 2021,
3 organization 0704, exceeds that which is necessary for the purpose for which the account was
4 established; and

5 WHEREAS, The Governor has established that there now remains an unappropriated
6 balance in the Department of Revenue, Insurance Commissioner – Insurance Commission
7 Fund, fund 7152, fiscal year 2021, organization 0704 that is available for expenditure during the
8 fiscal year ending June 30, 2021 which is hereby appropriated by the terms of this
9 supplementary appropriation bill; therefore

Be it enacted by the Legislature of West Virginia:

1 That the balance of funds available for expenditure in the fiscal year ending June 30,
2 2021, to the Department of Revenue, Insurance Commissioner – Insurance Commission Fund,
3 fund 7152, fiscal year 2021, organization 0704, be decreased by expiring the amount of
4 \$750,000 to the Department of Transportation, State Rail Authority - West Virginia Commuter
5 Rail Access Fund, fund 8402, fiscal year 2021, organization 0804, to be available for
6 expenditure during the fiscal year ending June 30, 2021.

7 And, That the total appropriation for the fiscal year ending June 30, 2021, to fund 8402,
8 fiscal year 2021 organization 0804, be supplemented and amended by increasing an existing
9 item of appropriation as follows:
