A BILL to amend the Code of West Virginia, 1931, as amended, by adding thereto a new section,
 designated §62-12-26a, relating to mandating extended supervision for defendants
 convicted of stalking and related felonious acts; establishing the start date of such
 extended supervision; providing monitoring procedure; providing for modifications or
 revocations of extended supervision; providing for violations during extended supervision;
 and providing for delayed extended supervision.

Be it enacted by the Legislature of West Virginia:

ARTICLE 12. PROBATION AND PAROLE.

§62-12-26a. Extended supervision for certain stalking and related felonious acts; sentencing; conditions; supervision provisions; supervision fee.

1 (a) Notwithstanding any other provision of this code to the contrary, any defendant 2 convicted after the effective date of this section of a felony violation of §61-2-9a of this code shall, 3 as part of the sentence imposed at final disposition, be required to serve, in addition to any other 4 penalty or condition imposed by the court, a period of supervised release of up to 50 years: 5 Provided, That the period of supervised release imposed by the court pursuant to this section for 6 a defendant convicted after the effective date of this section shall be no less than 10 years: 7 Provided, however, That pursuant to the provisions of §62-12-26a(f) of this code, a court may 8 modify, terminate, or revoke any term of supervised release imposed pursuant to §62-12-26a(a) 9 of this code. 10 (b) The period of supervised release imposed by the provisions of this section shall begin 11 upon the expiration of any period of probation, the expiration of any sentence of imprisonment or 12 the expiration of any period of parole supervision imposed or required of the person so convicted, 13 whichever expires later. (c) Any person sentenced to a period of supervised release pursuant to the provisions of 14 15 this section shall be supervised by a multijudicial circuit probation officer, if available. Until such

16 time as a multijudicial circuit probation officer is available, the offender shall be supervised by the

17	probation office of the sentencing court or of the circuit in which he or she resides.
18	(d) A defendant sentenced to a period of supervised release shall be subject to any or all
19	of the conditions applicable to a person placed upon probation pursuant to the provisions of §62-
20	12-9 of this code: Provided, That any defendant sentenced to a period of supervised release
21	pursuant to this section shall be required to participate in appropriate offender treatment programs
22	or counseling during the period of supervised release unless the court deems the offender
23	treatment programs or counseling to no longer be appropriate or necessary and makes express
24	findings in support thereof.
25	(e) The sentencing court may, based upon defendant's ability to pay, impose a supervision
26	fee to offset the cost of supervision. Said fee shall not exceed \$50 per month. Said fee may be
27	modified periodically based upon the defendant's ability to pay.
28	(f) Modification of conditions or revocation. — The court may:
29	(1) Terminate a term of supervised release and discharge the defendant released at any
30	time after the expiration of two years of supervised release, pursuant to the provisions of the West
31	Virginia Rules of Criminal Procedure relating to the modification of probation, if it is satisfied that

46	(4) Order the defendant to remain at his or her place of residence during nonworking hours
47	and, if the court so directs, to have compliance monitored by telephone or electronic signaling
48	devices, except that an order under this paragraph may be imposed only as an alternative to
49	imprisonment.
50	(g) Written statement of conditions. — The court shall direct that the probation officer
51	provide the defendant with a written statement at the defendant's sentencing hearing that sets
52	forth all the conditions to which the term of supervised release is subject and that it is sufficiently
53	clear and specific to serve as a guide for the defendant's conduct and for such supervision as is
54	required.
55	(h) Supervised release following revocation. — When a term of supervised release is
56	revoked and the defendant is required to serve a term of imprisonment that is less than the
57	maximum term of supervised release authorized under §62-12-26a(a) of this code, the court may
58	include a requirement that the defendant be placed on a term of supervised release after
59	imprisonment. The length of such term of supervised release shall not exceed the term of
60	supervised release authorized by this section less any term of imprisonment that was imposed
61	upon revocation of supervised release.
62	(i) Delayed revocation. — The power of the court to revoke a term of supervised release
63	for violation of a condition of supervised release and to order the defendant to serve a term of
64	imprisonment and, subject to the limitations in §62-12-26a(h) of this code a further term of
65	supervised release extends beyond the expiration of the term of supervised release for any period
66	necessary for the adjudication of matters arising before its expiration if, before its expiration, a
67	warrant or summons has been issued on the basis of an allegation of such a violation.

NOTE: The purpose of this bill is to make extended supervision mandatory for felony convictions of stalking and related criminal acts.
