1 AN ACT supplementing and amending appropriations of public moneys out of the Treasury in the
2 State Fund, General Revenue, by decreasing and increasing existing items of
3 appropriation to the Department of Health and Human Resources, Division of Human
4 Services, fund 0403, fiscal year 2021, organization 0511 and increasing existing items of
5 appropriation to the Department of Health and Human Resources, Division of Health –
6 Central Office, fund 0407, fiscal year 2021, organization 0506, by supplementing and
7 amending appropriations for the fiscal year ending June 30, 2021.

8 WHEREAS, The Governor submitted to the Legislature the Executive Budget document,
9 dated February 10, 2021, which included a Statement of the State Fund, General Revenue,
10 setting forth therein the cash balance as of July 1, 2020, and further included the estimate of
11 revenues for the fiscal year 2021, less net appropriation balances forwarded and regular
12 appropriations for the fiscal year 2021; and

13 WHEREAS, It appears from the Executive Budget document, Statement of the State Fund,
14 General Revenue, and this legislation, there remains an unappropriated balance in the State
15 Treasury which is available for appropriation during the fiscal year ending June 30, 2021;
16 therefore

17 *Be it enacted by the Legislature of West Virginia:*

18 That the total appropriation for the fiscal year ending June 30, 2021, to fund 0403, fiscal
19 year 2021, organization 0511, be supplemented and amended by decreasing an existing item of
20 appropriation as follows:




