1 AN ACT to amend and reenact §64-12-1, §64-12-2, §64-12-3, and §64-12-4 of the Code of West
2 Virginia, 1931, as amended, all relating generally to repealing certain legislative,
3 procedural, and interpretative rules promulgated by certain agencies, boards, and
4 commissions which are no longer authorized or are obsolete; authorizing certain agencies
5 under the Department of Administration, Department of Health and Human Resources,
6 Department of Revenue, and Department of Commerce to repeal certain legislative,
7 procedural, and interpretative rules; repealing the Board of Risk and Insurance
8 Management legislative rule relating to discontinuation of professional malpractice
9 insurance; repealing the Department of Health and Human Resources legislative rule
10 relating to DUI safety and treatment; repealing the Department of Health and Human
11 Resources legislative rule relating to incorporation of the social services manual; repealing
12 the Department of Health and Human Resources legislative rule relating to operating rules
13 and regulations for the West Virginia Commission on Children and Youth; repealing the
14 Department of Health and Human Resources legislative rule relating to state child fatality
15 review team and county multidisciplinary review teams; repealing the Insurance
16 Commissioner legislative rule relating to emergency medical services; repealing the
17 Insurance Commissioner legislative rule relating to diabetes regulations; repealing the
18 Racing Commission procedural rule relating to dispute resolution procedures; repealing
19 the State Tax Department interpretative rule relating to tax shelter voluntary compliance
20 program; repealing the State Tax Department interpretative rule relating to preference for
21 determining successful bids; repealing the State Tax Department procedural rule relating
22 to tobacco products excise tax on floorstocks; repealing the State Tax Department
23 legislative rule relating to West Virginia Film Industry Investment Act; repealing the State
24 Tax Department legislative rule relating to residential solar energy tax credit; repealing the
25 State Tax Department legislative rule relating to Business Franchise Tax; repealing the
26 Division of Labor legislative rule relating to hazardous chemical substances; and repealing
27 the Division of Labor legislative rule relating to Commercial Bungee Jumping Safety Act.

Be it enacted by the Legislature of West Virginia:

ARTICLE 12. REPEAL OF UNAUTHORIZED AND OBSOLETE RULES.

§64-12-1. Department of Administration

Board of Risk and Insurance Management

1 The legislative rule effective April 14, 1992, authorized under the authority of §29-12-5 of
2 this code, relating to the Board of Risk and Insurance Management (discontinuation of
3 professional malpractice insurance, 115 CSR 04), is repealed.

§64-12-2. Department of Health and Human Resources

1 (a) The legislative rule effective May 4, 2012, authorized under the authority of §22-1-3 of
2 this code, relating to the Department of Health and Human Resources (DUI safety and treatment,
3 64 CSR 98), is repealed.

4 (b) The legislative rule effective July 1, 1986, authorized under the authority of §49-2-121
5 of this code, relating to the Department of Health and Human Resources (incorporation of the
6 social services manual, 78 CSR 04), is repealed.

7 (c) The procedural rule effective March 15, 1986, authorized under the authority of §49-2-
8 121 of this code, relating to the Department of Health and Human Resources (operating rules and
9 regulations for the West Virginia Commission on Children and Youth, 79 CSR 01), is repealed.

10 (d) The procedural rule effective December 1, 2001, authorized under the authority of §49-
11 2-121 of this code, relating to the Department of Health and Human Resources (state child fatality
12 review team and county multidisciplinary review teams, 64 CSR 20), is repealed.

§64-12-3. Department of Revenue

(a) Insurance Commissioner

1 (1) The legislative rule effective May 16, 1997, authorized under the authority of §33-2-10
2 of this code, relating to the Insurance Commissioner (emergency medical services, 114 CSR 50),
3 is repealed.

4 (2) The legislative rule effective May 16, 1997, authorized under the authority of §33-2-10
5 of this code, relating to the Insurance Commissioner (diabetes regulation, 114 CSR 52), is
6 repealed.

(b) Racing Commission

7 The procedural rule effective September 30, 1991, authorized under the authority of §19-
8 23-6 of this code, relating to the Racing Commission (dispute resolution procedures, 178 CSR
9 04), is repealed.

(c) State Tax Department

10 (1) The interpretative rule effective August 26, 2006, authorized under the authority of §11-
11 10E-2 of this code, relating to the State Tax Department (tax shelter voluntary compliance
12 program, 110 CSR 10E), is repealed.

13 (2) The interpretative rule effective October 12, 1992, authorized under the authority of
14 §5A-3-37 of this code, relating to the State Tax Department (preference for determining
15 successful bids, 110 CSR 12C), is repealed.

16 (3) The legislative rule effective May 11, 2010, authorized under the authority of §11-13X-
17 9 of this code, relating to the State Tax Department (West Virginia Film Industry Investment Act,
18 110 CSR 13X), is repealed.

19 (4) The procedural rule effective June 16, 2003, authorized under the authority of §11-10-
20 5 of this code, relating to the State Tax Department (tobacco products excise tax on floorstocks,
21 110 CSR 17A), is repealed.

22 (5) The legislative rule effective May 11, 2010, authorized under the authority of §11-13Z-
23 3 of this code, relating to the State Tax Department (residential solar energy tax credit, 110 CSR
24 21D), is repealed.

25 (6) The legislative rule effective April 15, 1992, authorized under the authority of §11-10-
26 5 of this code, relating to the State Tax Department (Business Franchise Tax, 110 CSR 23), is
27 repealed.


§64-12-4. Department of Commerce

6 23), is repealed.






