1 AN ACT to amend and reenact §18B-10-1a of the Code of West Virginia, 1931, as amended,  
2 relating generally to in-state residency tuition rates; providing that nonresident members  
3 of a reserve unit in West Virginia qualify as residents for purposes of determining tuition  
4 rates; removing the requirement that members of the National Guard participate in the  
5 National Guard education services program; and providing that current members of the  
6 United States armed forces who reside in West Virginia qualify as residents for purposes  
7 of determining tuition rates.

*Be it enacted by the Legislature of West Virginia:*

**ARTICLE 10. FEES AND OTHER MONEY COLLECTED AT STATE INSTITUTIONS OF  
HIGHER EDUCATION.**

**§18B-10-1a. Resident tuition rates for members of the National Guard, reserves, and armed  
forces.**

1 (a) The term “resident” or “residency”, or any other term or expression used to designate  
2 a West Virginia resident student, when used to determine the rate of tuition to be charged students  
3 attending state institutions of higher education, shall be construed to include the following:


4 (1) Members of the National Guard or reserves who are not residents of West Virginia but  
5 who are active members of a National Guard or reserve unit in West Virginia; and

6 (2) Current members of the United States armed forces who reside in West Virginia.

7 (b) A person who qualifies as a resident, as that term is defined in subsection (a) of this  
8 section, on the first day of the semester or term of the college or institution, shall be charged  
9 resident tuition rates.

10 (c) The provisions of this section apply at the beginning of the semester or term  
11 immediately following the effective date of this section.






