1 AN ACT supplementing and amending appropriations of public moneys out of the Treasury in the
2 State Fund, General Revenue, by decreasing an existing item of appropriation and
3 increasing an existing item of appropriation to West Virginia Council for Community and
4 Technical College Education, West Virginia Council for Community and Technical College
5 Education - Control Account, fund 0596, fiscal year 2021, organization 0420, by
6 supplementing and amending appropriations for the fiscal year ending June 30, 2021.

1 Whereas, The Governor submitted to the Legislature the Executive Budget Document,
2 dated February 10, 2021, which included a statement of the State Fund, General Revenue, setting
3 forth therein the cash balance as of July 1, 2020, and further included the estimate of revenues
4 for the fiscal year 2021, less net appropriation balances forwarded and regular appropriations for
5 the fiscal year 2021; and

6 Whereas, It appears from the Executive Budget Document, statement of the State Fund,
7 General Revenue, and this legislation, there remains an unappropriated balance in the State
8 Treasury which is available for appropriation during the fiscal year ending June 30, 2021;
9 therefore

Be it enacted by the Legislature of West Virginia:

1 That the total appropriation for the fiscal year ending June 30, 2021, to fund 0596, fiscal
2 year 2021, organization 0420, be supplemented and amended by decreasing an existing item of
3 appropriation as follows:






