**Senate Bill 1006**

BY SENATORS BLAIR (MR. PRESIDENT) AND BALDWIN

[BY REQUEST OF THE EXECUTIVE]

[Introduced January 10, 2022]

1 A BILL supplementing and amending the appropriations of public moneys out of the Treasury  
2 from the balance of moneys remaining as an unappropriated balance in the State Fund,  
3 General Revenue, to the Department of Economic Development, Department of Economic  
4 Development – Office of the Secretary, fund 0256, fiscal year 2022, organization 0307, by  
5 supplementing and amending the appropriations for the fiscal year ending June 30, 2022.

6 WHEREAS, The Governor submitted to the Legislature the Executive Budget document,  
7 dated February 10, 2021, which included a Statement of the State Fund, General Revenue,  
8 setting forth therein the cash balance as of July 1, 2020, and further included an estimate of  
9 revenues for the fiscal year 2022 less net appropriation balances forwarded and regular  
10 appropriations for the fiscal year 2022; and

11 WHEREAS, The Governor submitted to the Legislature an Executive Message dated June  
12 24, 2021, which included a revised estimate of revenues for the State Fund, General Revenue  
13 and a statement of the State Fund, General Revenue for the fiscal year 2021, and further included  
14 an estimate of revenues for the fiscal year 2022 less net appropriation balances forwarded and  
15 regular appropriations for the fiscal year 2022; and

16 WHEREAS, The Governor submitted to the Legislature an Executive Message dated  
17 January 11, 2022, which included a revised statement of the State Fund, General Revenue for  
18 the fiscal year 2022, and further included an estimate of revenues for the fiscal year 2022 less  
19 net appropriation balances forwarded and regular appropriations for the fiscal year 2022; and

20 WHEREAS, It appears from the Executive Message dated January 11, 2022, statement  
21 of the State Fund, General Revenue and this legislation there remains an unappropriated balance  
22 in the State Treasury which is available for appropriation during the fiscal year ending June 30,  
23 2022; therefore

*Be it enacted by the Legislature of West Virginia:*

24 That the total appropriation for the fiscal year ending June 30, 2022, to fund 0256, fiscal  
25 year 2022, organization 0307, be supplemented and amended by increasing an existing item of  
26 appropriation as follows:

38 The above appropriation for Directed Transfer (fund 0256, appropriation 70000) shall be  
39 transferred to the Economic Development Promotion and Closing Fund (3171).

NOTE: The purpose of this supplemental appropriation bill is to supplement and amend an item of appropriation in the aforesaid account for the designated spending unit for expenditure during the fiscal year 2022.
