1 A BILL expiring funds to the unappropriated surplus balance in the State Fund. General Revenue. 2 for the fiscal year ending June 30, 2022 in the amount of \$157,500,000 from the balance 3 of moneys remaining as an unappropriated balance in Federal Funds to the Executive. 4 Governor's Office, Coronavirus State Fiscal Recovery Fund, fund 8823, organization 5 0100, and making a supplementary appropriation of public moneys out of the Treasury 6 from the unappropriated surplus balance in the State Fund, General Revenue, for the 7 fiscal year ending June 30, 2022 to the Department of Health and Human Resources, Division of Heath – Central Office, fund 0407, fiscal year 2022, organization 0506; to the 8 Department of Health and Human Resources, Consolidated Medical Services Fund, fund 9 10 0525, fiscal year 2022, organization 0506; to the Department of Homeland Security, 11 Division of Corrections and Rehabilitation – West Virginia Parole Board, fund 0440, fiscal 12 year 2022, organization 0608; to the Department of Homeland Security, Division of 13 Corrections and Rehabilitation – Central Office, fund 0446, fiscal year 2022, organization 14 0608; to the Department of Homeland Security, Division of Corrections and Rehabilitation - Correctional Units, fund 0450, fiscal year 2022, organization 0608; to the Department of 15 16 Homeland Security, Division of Corrections and Rehabilitation - Bureau of Juvenile Services, fund 0570, fiscal year 2022, organization 0608; and to the Department of 17 Homeland Security, West Virginia State Police, fund 0453, fiscal year 2022, organization 18 19 0612.

WHEREAS, The Governor finds the account balance in the Executive, Governor's Office,
Coronavirus State Fiscal Recovery Fund, fund 8823, organization 0100 exceeds that which is
necessary for the purposes for which the account was established; and

WHEREAS, The Governor submitted to the Legislature an Executive Message dated January 10, 2022, which included a statement of the State Fund, General Revenue for the fiscal year 2022, and further included an estimate of revenues for the fiscal year 2022 less net appropriation balances forwarded and regular appropriations for the fiscal year 2022; and
