1 A BILL to repeal §16-1-8, §16-1-13 and §16-1-21 of the Code of West Virginia, 1931, as amended;  
 2 to amend and reenact §16-1-2, §16-1-3 §16-1-4, §16-1-5, §16-1-6, §16-1-7, §16-1-10,  
 3 §16-1-11, §16-1-12, and §16-1-14 of said code; and to amend and reenact §16-2-2, §16-  
 4 2-10, §16-2-11, §16-2-12, §16-2-13, §16-2-14, and §16-2-17 of said code, all relating to  
 5 public health; repealing certain provisions; amending definitions; clarifying duties of the  
 6 Secretary; amending rulemaking authority and the required experience of state health  
 7 officer; modifying duties of commissioner; clarifying commissioner's service on advisory  
 8 boards; omitting requirement for annual report on health facility licensing account;  
 9 modifying provisions on disposition of fees received by commissioner, disbursement of  
 10 federal aid, and training of employees; clarifying meeting requirements and duties of local  
 11 board of health; modifying provision concerning appointment of local health officer;  
 12 amending powers of local health officer and financial provisions for local boards of health;  
 13 and omitting Secretary's review of certain legislative rules.

## **ARTICLE 1. STATE PUBLIC HEALTH SYSTEM.**

### **§16-1-2. Definitions.**

1 As used in this article:  
 2 ~~(1)~~ "Basic public health services" means those services that are necessary to protect the  
 3 health of the public. The three areas of basic public health services are communicable and  
 4 reportable disease prevention and control, community health promotion and environmental health  
 5 protection;  
 6 ~~(2)~~ "Bureau" means the Bureau for Public Health in the Department;  
 7 ~~(3)~~ "Combined local board of health" means one form of organization for a local board of  
 8 health and means a board of health serving any two or more counties or any county or counties  
 9 and one or more municipalities within or partially within the county or counties;  
 10 ~~(4)~~ "Commissioner" means the commissioner of the bureau, who is the state health officer;

11 ~~(5)~~ "County board of health" means one form of organization for a local board of health  
12 and means a local board of health serving a single county;

13 ~~(6)~~ "Department" means the West Virginia Department of Health and Human Resources;

14 ~~(7)~~ "Director" or "director of health" means the state health officer. Administratively within  
15 the department, the bureau through its commissioner carries out the public health functions of the  
16 department, unless otherwise assigned by the secretary;

17 ~~(8)~~ "Essential public health services" means the core public health activities necessary to  
18 promote health and prevent disease, injury and disability for the citizens of the state. The services  
19 include:

20 (A) Monitoring health status to identify community health problems;

21 (B) Diagnosing and investigating health problems and health hazards in the community;

22 (C) Informing, educating and empowering people about health issues;

23 (D) Mobilizing community partnerships to identify and solve health problems;

24 (E) Developing policies and plans that support individual and community health efforts;

25 (F) Enforcing laws and rules that protect health and ensure safety;

26 (G) Uniting people with needed personal health services and assuring the provision of  
27 health care when it is otherwise not available;

28 (H) Promoting a competent public health and personal health care workforce;

29 (I) Evaluating the effectiveness, accessibility and quality of personal and population-based  
30 health services; and

31 (J) Researching for new insights and innovative solutions to health problems;

32 ~~(9)~~ "Licensing boards" means those boards charged with regulating an occupation,  
33 business or profession and on which the commissioner serves as a member;

34 ~~(10)~~ "Local board of health", "local board" or "board" means a board of health serving one  
35 or more counties or one or more municipalities or a combination thereof;

36 ~~(11)~~ "Local health department" means the staff of the local board of health;

37           ~~(12)~~ “Local health officer” means the physician with a current West Virginia license to  
38 practice medicine who supervises and directs the activities, services, staff and facilities of the  
39 local health department and is appointed by the local board of health with approval by the  
40 commissioner;

41           ~~(13)~~ “Municipal board of health” means one form of organization for a local board of health  
42 and means a board of health serving a single municipality;

43           ~~(14)~~ “Performance-based standards” means generally accepted, objective standards such  
44 as rules or guidelines against which public health performance can be measured;

45           ~~(15)~~ “Potential source of significant contamination” means a facility or activity that stores,  
46 uses or produces substances or compounds with potential for significant contaminating impact if  
47 released into the source water of a public water supply;

48           ~~(16)~~ “Program plan” or “plan of operation” means the annual plan for each local board of  
49 health that must be submitted to the commissioner for approval

50           ~~(17)~~ “Public groundwater supply source” means a primary source of water supply for a  
51 public water system which is directly drawn from a well, underground stream, underground  
52 reservoir, underground mine or other primary source of water supplies which is found underneath  
53 the surface of the state;

54           ~~(18)~~ “Public surface water supply source” means a primary source of water supply for a  
55 public water system which is directly drawn from rivers, streams, lakes, ponds, impoundments or  
56 other primary sources of water supplies which are found on the surface of the state;

57           ~~(19)~~ “Public surface water influenced groundwater supply source” means a source of water  
58 supply for a public water system which is directly drawn from an underground well, underground  
59 river or stream, underground reservoir or underground mine, and the quantity and quality of the  
60 water in that underground supply source is heavily influenced, directly or indirectly, by the quantity  
61 and quality of surface water in the immediate area;

62           ~~(20)~~ “Public water system” means:

63 (A) Any water supply or system which regularly supplies or offers to supply water for  
64 human consumption through pipes or other constructed conveyances, if serving at least an  
65 average of 25 individuals per day for at least 60 days per year, or which has at least 15 service  
66 connections, and shall include:

67 (i) Any collection, treatment, storage and distribution facilities under the control of the  
68 owner or operator of the system and used primarily in connection with the system; and

69 (ii) Any collection or pretreatment storage facilities not under such control which are used  
70 primarily in connection with the system;

71 (B) A public water system does not include a system which meets all of the following  
72 conditions:

73 (i) Consists only of distribution and storage facilities and does not have any collection and  
74 treatment facilities;

75 (ii) Obtains all of its water from, but is not owned or operated by, a public water system  
76 which otherwise meets the definition;

77 (iii) Does not sell water to any person; and

78 (iv) Is not a carrier conveying passengers in interstate commerce;

79 ~~(24)~~ "Public water utility" means a public water system which is regulated by the West  
80 Virginia Public Service Commission pursuant to the provisions of chapter twenty-four of this code;

81 ~~(22)~~ "Secretary" means the secretary of the department.

82 ~~(23)~~ "Service area" means the territorial jurisdiction of a local board of health;

83 ~~(24)~~ "State Advisory Council on Public Health" means the advisory body charged by this  
84 article with providing advice to the commissioner with respect to the provision of adequate public  
85 health services for all areas in the state;

86 ~~(25)~~ "State Board of Health" means the secretary, notwithstanding any other provision of  
87 this code to the contrary, whenever and wherever in this code there is a reference to the State  
88 Board of Health;

89           ~~(26)~~ “Zone of critical concern” for a public surface water supply is a corridor along streams  
 90 within a watershed that warrant more detailed scrutiny due to its proximity to the surface water  
 91 intake and the intake's susceptibility to potential contaminants within that corridor. The zone of  
 92 critical concern is determined using a mathematical model that accounts for stream flows, gradient  
 93 and area topography. The length of the zone of critical concern is based on a five-hour time-of-  
 94 travel of water in the streams to the water intake, plus an additional one-fourth mile below the  
 95 water intake. The width of the zone of critical concern is 1,000 measured horizontally from each  
 96 bank of the principal stream and 500 feet measured horizontally from each bank of the tributaries  
 97 draining into the principal stream.

**§16-1-3. Powers and duties of the secretary.**

1           (a) The secretary may establish a state public health system.

2           ~~(b) All powers and duties of the director of health previously established by former section~~  
 3 ~~ten of this article that are not specifically included in this chapter as powers and duties of the~~  
 4 ~~commissioner are powers and duties of the secretary~~

5           ~~(e)~~(b) As necessary for the effective, efficient and economical operation of the system, the  
 6 secretary may from time to time delegate, assign, transfer or combine responsibilities or duties to  
 7 or among employees of the department.

8           ~~(d)~~ (c) Within the limits of applicable federal law, the secretary may require every applicant  
 9 for a license, permit, certificate of registration, or registration under this chapter to place his or her  
 10 social security number on the application.

11           (d) The secretary may appoint advisory councils.

**§16-1-4. Proposal of rules by the secretary.**

1           (a) The secretary may propose legislative rules in accordance with the provisions of §29A-  
 2 3-1 ~~et seq. of this code that are necessary and proper to effectuate the purposes of this chapter.~~  
 3 ~~The secretary may appoint or designate advisory councils of professionals in the areas of~~  
 4 ~~hospitals, nursing homes, barbers and beauticians, postmortem examinations, mental health and~~

5 ~~intellectual disability centers and any other areas necessary to advise the secretary on rules.~~

6 ~~(b) The rules may include, but are not limited to, the regulation of~~

7 (1) Land usage endangering the public health: *Provided*, That no rules may be  
8 promulgated or enforced restricting the subdivision or development of any parcel of land within  
9 which the individual tracts, lots or parcels exceed two acres each in total surface area and which  
10 individual tracts, lots or parcels have an average frontage of not less than 150 feet even though  
11 the total surface area of the tract, lot or parcel equals or exceeds two acres in total surface area,  
12 and which tracts are sold, leased or utilized only as single-family dwelling units. Notwithstanding  
13 the provisions of this subsection, nothing in this section may be construed to abate the authority  
14 of the department to:

15 (A) Restrict the subdivision or development of a tract for any more intense or higher density  
16 occupancy than a single-family dwelling unit;

17 (B) Propose or enforce rules applicable to single-family dwelling units for single-family  
18 dwelling unit sanitary sewerage disposal systems; or

19 (C) Restrict any subdivision or development which might endanger the public health, the  
20 sanitary condition of streams or sources of water supply;

21 (2) The sanitary condition of all institutions and schools, whether public or private, public  
22 conveyances, dairies, slaughterhouses, workshops, factories, labor camps, all other places open  
23 to the general public and inviting public patronage or public assembly, or tendering to the public  
24 any item for human consumption and places where trades or industries are conducted;

25 (3) Occupational and industrial health hazards, the sanitary conditions of streams, sources  
26 of water supply, sewerage facilities and plumbing systems and the qualifications of personnel  
27 connected with any of those facilities, without regard to whether the supplies or systems are  
28 publicly or privately owned; and the design of all water systems, plumbing systems, sewerage  
29 systems, sewage treatment plants, excreta disposal methods, and swimming pools in this state,  
30 whether publicly or privately owned;

31 (4) Safe drinking water, including:

32 (A) The maximum contaminant levels to which all public water systems must conform in  
33 order to prevent adverse effects on the health of individuals and, if appropriate, treatment  
34 techniques that reduce the contaminant or contaminants to a level which will not adversely affect  
35 the health of the consumer. The rule shall contain provisions to protect and prevent contamination  
36 of wellheads and well fields used by public water supplies so that contaminants do not reach a  
37 level that would adversely affect the health of the consumer;

38 (B) The minimum requirements for: Sampling and testing; system operation; public  
39 notification by a public water system on being granted a variance or exemption, or upon failure to  
40 comply with specific requirements of this section and rules promulgated under this section; record  
41 keeping; laboratory certification; as well as procedures and conditions for granting variances and  
42 exemptions to public water systems from state public water systems rules; and

43 (C) The requirements covering the production and distribution of bottled drinking water  
44 and may establish requirements governing the taste, odor, appearance and other consumer  
45 acceptability parameters of drinking water;

46 (5) Food and drug standards, including cleanliness, proscription of additives, proscription  
47 of sale and other requirements in accordance with §16-7-1 *et seq.* of this code as are necessary  
48 to protect the health of the citizens of this state;

49 (6) The training and examination requirements for emergency medical service attendants  
50 and emergency medical care technician-paramedics; the designation of the health care facilities,  
51 health care services, and the industries and occupations in the state that must have emergency  
52 medical service attendants and emergency medical care technician-paramedics employed, and  
53 the availability, communications and equipment requirements with respect to emergency medical  
54 service attendants and to emergency medical care technician-paramedics. Any regulation of  
55 emergency medical service attendants and emergency medical care technician- paramedics may  
56 not exceed the provisions of §16-4C-1 *et seq.* of this code;



57 (7) The health and sanitary conditions of establishments commonly referred to as bed and  
58 breakfast inns. For purposes of this article, "bed and breakfast inn" means an establishment  
59 providing sleeping accommodations and, at a minimum, a breakfast for a fee. The secretary may  
60 not require an owner of a bed and breakfast providing sleeping accommodations of six or fewer  
61 rooms to install a restaurant-style or commercial food service facility. The secretary may not  
62 require an owner of a bed and breakfast providing sleeping accommodations of more than six  
63 rooms to install a restaurant-type or commercial food service facility if the entire bed and breakfast  
64 inn or those rooms numbering above six are used on an aggregate of two weeks or less per year;

65 (8) Fees for services provided by the Bureau for Public Health including, but not limited to,  
66 laboratory service fees, environmental health service fees, health facility fees, and permit fees;

67 (9) The collection of data on health status, the health system and the costs of health care;

68 ~~(c) The secretary shall propose a rule for legislative approval in accordance with the~~  
69 ~~provisions of §29A-3-1 et seq. of this code for~~ The rule shall include the following provisions in  
70 accordance with:

71 (10) The distribution of state aid to local health departments and basic public health  
72 services funds in accordance with:

73 (A) Base allocation amount for each county;

74 (B) Establishment and administration of an emergency fund of no more than two percent  
75 of the total annual funds of which unused amounts are to be distributed back to local boards of  
76 health at the end of each fiscal year;

77 (C) A calculation of funds utilized for state support of local health departments;

78 (D) Distribution of remaining funds on a per capita weighted population approach which  
79 factors coefficients for poverty, health status, population density and health department  
80 interventions for each county and a coefficient which encourages counties to merge in the  
81 provision of public health services;

82 (E) A hold-harmless provision to provide that each local health department receives no

83 less in state support for a period of four years beginning in the 2009 budget year.

84 ~~The Legislature finds that an emergency exists and, therefore, the secretary shall file an~~  
85 ~~emergency rule to implement the provisions of this section pursuant to the provisions §29A-3-15~~  
86 ~~of this code. The emergency rule is subject to the prior approval of the Legislative Oversight~~  
87 ~~Commission on Health and Human Resources Accountability prior to filing with the Secretary of~~  
88 ~~State.~~

89 ~~(d) The secretary may propose rules for legislative approval that may include the~~  
90 ~~regulation of other health-related matters which the department is authorized to supervise and for~~  
91 ~~which the rule-making authority has not been otherwise assigned~~

92 ~~(e) (b)~~ The secretary shall not review any repair or modernization of equipment at a public  
93 pool facility as long as such activity does not change the scope of the facility or its current use  
94 and such activity does not exceed \$25,000 in planned cost.

**§16-1-5. State health officer; appointment; qualifications; term.**

1 The Commissioner of the Bureau for Public Health is the state health officer and shall be  
2 appointed by the secretary. The commissioner shall be ~~a physician~~ licensed under the laws of  
3 this state to practice medicine or a person holding a doctorate degree in public health  
4 administration. ~~The commissioner shall have not less than four years' experience in health~~  
5 ~~services administration or a related field~~ The commissioner serves at the will and pleasure of the  
6 secretary and shall not be actively engaged or employed in any other business, vocation or  
7 employment, serving full time in the duties of the office as prescribed by this article.

**§16-1-6. Powers and duties of the commissioner.**

1 (a) The commissioner is the chief executive, administrative and fiscal officer of the Bureau  
2 for Public Health and has the following powers and duties:

3 ~~(a) (1)~~ To supervise and direct the fiscal and administrative matters of the bureau, and in  
4 that regard and in accordance with law, employ, fix the compensation of and discharge all persons  
5 necessary for the proper execution of the public health laws of this state and the efficient and

6 proper discharge of the duties imposed upon, and execution of powers vested in the  
7 commissioner by law and as directed by the secretary;

8 ~~(b) (2)~~ To enforce all laws of this state concerning public health. ~~to that end,~~

9 ~~(3) The commissioner shall make, or cause to be made, investigations and inquiries~~  
10 ~~respecting~~ To investigate the cause of disease, especially of epidemics and endemic conditions,  
11 and the means of prevention, suppression or control of those conditions; the source of sickness  
12 and mortality, ~~and~~ the effects of environment, employment, habits and circumstances of life on  
13 the public health.

14 ~~The commissioner shall further make, or cause to be made, inspections and examinations~~  
15 ~~of~~ (4) To inspect and examine food, drink and drugs offered for sale or public consumption in the  
16 manner the commissioner considers necessary to protect the public health and shall report all  
17 violations of laws and rules relating to the law to the prosecuting attorney of the county in which  
18 the violations occur;

19 ~~(e) (5)~~ To make complaint or cause proceedings to be instituted against any person,  
20 corporation or other entity for the violation of any public health law before any court or agency,  
21 without being required to give security for costs; the action may be taken without the sanction of  
22 the prosecuting attorney of the county in which the proceedings are instituted or to which the  
23 proceedings relate;

24 ~~(d) (6)~~ To promote the provision of essential public health services to citizens of this state;

25 ~~(e) (7)~~ To monitor the ~~administration,~~ operation and coordination of the local boards of  
26 health and local health officers;

27 ~~(f) (8)~~ To develop and maintain a state plan of operation that sets forth the needs of the  
28 state in the areas of public health; goals and objectives for meeting those needs; methods for  
29 achieving the stated goals and objectives; and needed personnel, funds and authority for  
30 achieving the goals and objectives;

31 ~~(g) (9)~~ To collect data as may be required to foster knowledge on the citizenry's health

32 status, the health system and costs of health care;

33 ~~(h)~~ (10) To delegate to any appointee, assistant or employee any and all powers and  
34 duties vested in the commissioner, including, but not limited to, the power to execute contracts  
35 and agreements in the name of the bureau: *Provided*, That the commissioner is responsible for  
36 the acts of his or her appointees, assistants and employees;

37 ~~(i)~~ (11) To transfer ~~at the direction of the secretary, notwithstanding other provisions of this~~  
38 ~~code~~ any patient or resident between hospitals and facilities under the control of the commissioner  
39 and, by agreement with the state Commissioner of Corrections and otherwise in accord with law,  
40 accept a transfer of a resident of a facility under the jurisdiction of the state Commissioner of  
41 Corrections;

42 ~~(j)~~ (12) To make periodic reports to the Governor and to the Legislature relative to specific  
43 subject areas of public health, ~~the state facilities under the supervision of the commissioner or~~  
44 other matters affecting the public health of the people of the state; ~~at the direction of the secretary;~~

45 ~~(k) At the direction of the secretary,~~ (13) To accept and use for the benefit of the health of  
46 the people of this state, any gift or devise of any property or thing which is lawfully given: *Provided*,  
47 That if any gift is for a specific purpose ~~or for a particular state hospital or facility~~ it shall be used  
48 as specified. Any profit which may arise from any gift or devise of any property or thing shall be  
49 deposited in a special revenue fund with the state Treasurer and shall be used only as specified  
50 by the donor or donors;

51 ~~(l)~~ (14) To acquire by condemnation or otherwise any interest, right, privilege, land or  
52 improvement and hold title to the land or improvement, for the use or benefit of the state or a state  
53 hospital or facility, ~~and, by and with the consent of the Governor, and at the direction of the~~  
54 ~~secretary~~ to sell, exchange or otherwise convey any interest, right, privilege, land or improvement  
55 acquired or held by the state, state hospital or state facility and deposit the proceeds from the  
56 sale, exchange or other conveyance into the hospital services revenue account. Any  
57 condemnation proceedings shall be conducted pursuant to chapter fifty-four of this code;

58 ~~(m)~~ (15) To inspect and enforce rules to control the sanitary conditions of and license all  
59 institutions and health care facilities as set forth in this chapter, including, but not limited to,  
60 schools, whether public or private, public conveyances, dairies, slaughterhouses, workshops,  
61 factories, labor camps, places of entertainment, hotels, motels, tourist camps, all other places  
62 open to the general public and inviting public patronage or public assembly, or tendering to the  
63 public any item for human consumption and places where trades or industries are conducted;

64 ~~(n)~~ (16) To make inspections, conduct hearings, and to enforce the legislative rules  
65 concerning occupational and industrial health hazards, the sanitary condition of streams, sources  
66 of water supply, sewerage facilities, and plumbing systems, and the qualifications of personnel  
67 connected with the supplies, facilities or systems without regard to whether they are publicly or  
68 privately owned; and to make inspections, conduct hearings and enforce the legislative rules  
69 concerning the design of chlorination and filtration facilities and swimming pools;

70 ~~(o)~~ ~~To provide in accordance with this subdivision and the definitions and other provisions~~  
71 ~~of article one-a, chapter twenty-seven 27-1A-1 et seq. of this code, and as directed by the~~  
72 ~~secretary, for a comprehensive program for the care, treatment and rehabilitation of alcoholics~~  
73 ~~and drug abusers; for research into the cause and prevention of alcoholism and drug abuse; for~~  
74 ~~the training and employment of personnel to provide the requisite rehabilitation of alcoholics and~~  
75 ~~drug abusers; and for the education of the public concerning alcoholism and drug abuse~~

76 ~~(p)~~ (17) To provide in accordance with this subdivision for a program for the care, treatment  
77 and rehabilitation of the parents of sudden infant death syndrome victims; for the training and  
78 employment of personnel to provide the requisite rehabilitation of parents of sudden infant death  
79 syndrome victims; for the education of the public concerning sudden infant death syndrome; ~~for~~  
80 ~~the responsibility of reporting to the Legislature on a quarterly basis the incidence of sudden infant~~  
81 ~~death syndrome cases occurring in West Virginia; for the education of police, employees and~~  
82 ~~volunteers of all emergency services concerning sudden infant death syndrome; for the state~~  
83 ~~sudden infant death syndrome advisory council to develop regional family support groups to~~

87 ~~(g) (18) To establish and maintain a state hygienic laboratory as an aid in performing the~~  
88 ~~duties imposed upon the commissioner, and to employ chemists, bacteriologists, and other~~  
89 ~~employees that may be necessary to properly operate the laboratory. The commissioner may~~  
90 ~~establish branches of the state laboratory at any points within the state that are necessary in the~~  
91 ~~interest of the public health;~~

92 ~~(f) To establish and fund a uniform health professionals data system to collect and~~  
93 ~~maintain uniform data on all health professionals in the state. This data shall include, but not be~~  
94 ~~limited to, the following information about each health professional: His or her name, profession,~~  
95 ~~the area of the state where he or she is practicing, his or her educational background, his or her~~  
96 ~~employer's name, and number of years practicing within the profession. The boards provided for~~  
97 ~~in articles three, four, four-a, five, seven, seven-a, fourteen, fourteen-a, fifteen, sixteen, twenty,~~  
98 ~~twenty-one, twenty-three, twenty-eight, thirty-one, thirty-two, thirty-four, thirty-five, thirty-six and~~

109 ~~(s) (19) To expend, for the purpose of performing the public health duties imposed on the~~

110 bureau, or authorized by law, any sums appropriated by the Legislature. The commissioner may  
111 make advance payments to public and nonprofit health services providers when the commissioner  
112 determines it is necessary for the initiation or continuation of public health services. The advance  
113 payments, being in derogation of the principle of payment only after receipt of goods or services,  
114 shall be authorized only after serious consideration by the commissioner of the necessity of the

9 refuses to enforce public health laws and rules necessary to prevent and control the spread of  
10 communicable or reportable diseases dangerous to the public health. Upon removal, a successor  
11 local health officer shall immediately be appointed by the board pursuant to the provisions of this  
12 article.

**§16-2-13. Local health officer; powers and duties.**

1 (a) A local health officer serves as the executive officer of the local board and under its  
2 supervision, a local health officer shall administer the provisions of this article, all other laws of  
3 this state and the rules and orders of the secretary ~~of the department~~ relating to public health and  
4 applicable to the local board's service area, any county commission orders and municipal  
5 ordinances of the board's service area relating to public health and the rules and orders of the  
6 local board.

7 (b) A local health officer has the following additional powers ~~and duties~~ which may be  
8 delegated with the approval of the board:

9 (1) To attend local board meetings as a nonvoting member. A local health officer serves  
10 as secretary at all board meetings and is responsible for maintaining the board's offices, meeting  
11 minutes and records;

12 (2) To supervise and direct the activities of the local board's health services, employees  
13 and facilities;

14 (3) To ensure that procedures are established for the receipt of communicable or  
15 reportable disease reports, ~~from local physicians and other reporting sources~~ and for the  
16 transmittal of the reports to the commissioner;

17 (4) To perform mandatory HIV tests on persons convicted of sex-related offenses and  
18 resident within the service area; and

19 (5) To determine when sufficient corrections have been made to warrant removal of any

20 restrictions or limitations placed on an individual or entity for public health purposes by an  
 21 employee of the local board of health.

**§16-2-14. Financial responsibilities of appointing authorities for local boards of health;  
 levies; appropriation of county or municipal general funds for public health  
 purposes; state funding.**

1 The appointing authorities for local boards of health shall provide financial support for the  
 2 operation of the local health department. The county commission of any county or the governing  
 3 body of any municipality in which a local board of health is established ~~pursuant to the provisions~~  
 4 ~~of this article~~, or the county commission of any county or the governing body of any municipality  
 5 who is a participating member of a combined local board of health may levy a county or municipal  
 6 tax to provide funds for the local board of health: Provided, That the tax may not exceed 3¢ on  
 7 each \$100 of assessed valuation of the taxable property in the levying county or municipality,  
 8 according to the latest assessment.

9 The county commission of any county or the governing body of any municipality in which  
 10 a local board of health is established, ~~pursuant to the provisions of this article~~, or the county  
 11 commission of any county or the governing body of any municipality who is a participating member  
 12 of a combined local board of health may appropriate and spend money from the county or  
 13 municipal general funds for public health purposes and to pay the expenses of the operation of  
 14 the local board of health services and facilities.

15 The commissioner and the secretary may pay over and contribute to any board of health,  
 16 ~~created and maintained pursuant to the provisions of this article~~ the sum or sums of money that  
 17 may be available from funds included in appropriations made for the department of Health and  
 18 Human Resources. The commissioner may withhold all or part of any funds until a local board of  
 19 health submits an acceptable plan to correct deficiencies in the local board's program plan.

**§16-2-17. Event permit fees good for a year, reciprocity from other state health  
 departments.**

1 (a) A temporary food service permit issued by a local or county health department to an  
2 in-state vendor in their county of residence for preparing and selling non-potentially hazardous  
3 foods at a festival, scheduled event, or similar activity which is valid for any time period less than  
4 annual and any permit fee paid shall be valid for an entire calendar year for the vendor regardless  
5 of the length of time for which the first permit is issued and regardless of the number of subsequent  
6 festivals, events or activities for which the vendor requires the same permit. Non-potentially  
7 hazardous foods mean food that does not require time or temperature control for safety to limit  
8 pathogenic microorganism growth or toxin formation.

9 (b) The permit shall also be valid in the counties that border the vendor's county of  
10 residence or 25 air miles, whichever is greater. No health department within these defined areas  
11 may charge a permit fee to any in-state vendor that has received a temporary food service permit  
12 to prepare and sell non-potentially hazardous foods by the other in-state health department during  
13 the same calendar year for the same type of activity, but may place conditions and limitations  
14 upon an issued permit to assure compliance with that health departments rules and standards for  
15 the type of permit being issued. Each vendor must provide notice to the local health department  
16 with jurisdiction at least 14 days prior to the start of the festival, event or activity. The permit must  
17 be visibly posted at the festival, event, or activity or the permit is not valid.

18 ~~(c) The Secretary shall review and modernize legislative rules regarding local boards of~~  
19 ~~health fees located in 64 CSR 30 in the next filing period~~

NOTE: The purpose of this bill relates generally to public health; repealing certain provisions; amending definitions; clarifying duties of the Secretary; amending rulemaking authority and required experience for the state health officer; modifying duties of commissioner; clarifying commissioner's service on advisory boards; omitting requirement for annual report on health facility licensing account; modifying provisions on disposition of fees received by commissioner, disbursement of federal aid, and training of employees; clarifying meeting requirements and duties of local board of health; modifying provision concerning appointment of local health officer; amending powers of local health officer and financial provisions for local boards of health; and omitting Secretary's review of certain legislative rules.
