## Senate Bill 439

BY SENATORS WOODRUM, TRUMP, AND LINDSAY

[Introduced January 20, 2022; referred

to the Committee on the Judiciary]

1 A BILL to amend and reenact §30-39-1, §30-39-2, §30-39-3, §30-39-4, §30-39-5, §30-39-6, §30-2 39-7, §30-39-9, §30-39-10, §30-39-11, §30-39-12, §30-39-13, §30-39-14, §30-39-15, §30-3 39-16, §30-39-19, and §30-39-21 of the Code of West Virginia, 1931, as amended, all 4 relating to adopting the Revised Uniform Athlete Agents Act of 2015; modifying short title; 5 defining terms; granting legislative rule-making authority to the Secretary of State; establishing seven-day limit on athlete agent to register; requiring additional information 6 7 from applicant in registration process; eliminating language making applications or renewals for athlete agent registration public records; providing for reciprocal registration; 8 9 updating required contents of reciprocal registration application; requiring Secretary of 10 State issue reciprocal license if certain criteria satisfied; requiring Secretary of State 11 cooperate with certain national organizations; allowing the Secretary of State to consider 12 whether the athlete agent has pled guilty or no contest to a crime of moral turpitude in 13 decision to issue registration: providing requirements for reciprocal renewals of 14 registration; providing Secretary of State authority to suspend or revoke registration for 15 same reasons as would justify refusal to issue certificate of registration; permitting 16 applicant to appeal adverse decision of Secretary of State; authorizing Secretary of State 17 promulgate procedural rules to implement appeal procedures; increasing fees for initial 18 license and renewal; adding required contract terms; requiring certain notices by athlete 19 agent to educational institutions; requiring educational institution notify Secretary of State 20 and others if it becomes aware of violation of article by athlete agent; allowing parent and 21 guardian of student athlete ability to cancel contract; requiring athlete agent to create 22 certain records; expanding scope of what constitutes prohibited conduct under the act; 23 expanding scope of who might engage in prohibited conduct under the act; expanding 24 scope of who can be charged with a criminal violation of the act; enabling student athletes 25 to bring civil action for act or omission of athlete agent: expanding scope of damages that 26 may be available in civil action; making a civil violation an unfair trade practice under West

27 Virginia law; establishing relation to the Electronic Signatures in Global and National
28 Commerce Act; and modifying effective date.

Be it enacted by the Legislature of West Virginia:

#### ARTICLE 39. REVISED UNIFORM ATHLETE AGENTS ACT.

#### §30-39-1. Short title.

This article may be cited as the <u>Revised</u> Uniform Athlete Agents Act (2015).

#### §30-39-2. Definitions.

1 In this article:

2 (1) "Agency contract" means an agreement in which a student athlete authorizes a person
3 to negotiate or solicit on behalf of the student athlete a professional-sports-services contract or
4 an endorsement contract.

5 (2) "Athlete agent" means: means an individual who enters into an agency contract with a 6 student athlete or, directly or indirectly, recruits or solicits a student athlete to enter into an agency 7 contract. The term includes an individual who represents to the public that the individual is an 8 athlete agent. The term does not include a spouse, parent, sibling, grandparent, or guardian of the student athlete or an individual acting solely on behalf of a professional sports team or 9 10 professional sports organization 11 (1) An individual, whether or not registered under this article, who: 12 (A) Directly or indirectly recruits or solicits a student athlete to enter into an agency contract 13 or, for compensation, procures employment or offers, promises, attempts, or negotiates to obtain 14 employment for a student athlete as a professional athlete or member of a professional sports 15 team or organization;

- 16 (B) For compensation or in anticipation of compensation related to a student athlete's
- 17 participation in athletics:
- 18 (i) Serves the student athlete in an advisory capacity on a matter related to finances,
- 19 business pursuits, or career management decisions, unless the individual is an employee of an

20	educational institution acting exclusively as an employee of the institution for the benefit of the
21	institution; or
22	(ii) Manages the business affairs of the student athlete by providing assistance with bills,
23	payments, contracts, or taxes.
24	(C) In anticipation of representing a student athlete for a purpose related to the athlete's
25	participation in athletics:
26	(i) Gives consideration to the student athlete or another person;
27	(ii) Serves the student athlete in an advisory capacity on a matter related to finances,
28	business pursuits, or career management decisions; or
29	(iii) Manages the business affairs of the student athlete by providing assistance with bills,
30	payments, contracts, or taxes; but
31	(2) Does not include an individual who:
32	(A) Acts solely on behalf of a professional sports team or organization; or
33	(B) Is a licensed, registered, or certified professional and offers or provides services to a
34	student athlete customarily provided by members of the profession, unless the individual:
35	(i) Also recruits or solicits the student athlete to enter into an agency contract;
36	(ii) Also, for compensation, procures employment or offers, promises, attempts, or
37	negotiates to obtain employment for the student athlete as a professional athlete or member of a
38	professional sports team or organization; or
39	(iii) Receives consideration for providing the services calculated using a different method
40	than for an individual who is not a student athlete.
41	(3) "Athletic director" means an individual responsible for administering the overall athletic
42	program of an educational institution or, if an educational institution has separately administered
43	athletic programs for male students and female students, the athletic program for males or the

44 athletic program for females, as appropriate.

(4) "Contact" means a communication, direct or indirect, between an athlete agent and a

48 school, community college, college, and university. 49 (5) "Endorsement contract" means an agreement under which a student athlete is 50 employed or receives consideration to use on behalf of the other party any value that the student 51 athlete may have because of publicity, reputation, following, or fame obtained because of athletic 52 ability or performance. "Enrolled" means registered for courses and attending athletic practice or class. "Enrolls" 53 54 has a corresponding meaning. 55 (6) "Intercollegiate sport" means a sport played at the collegiate level for which eligibility 56 requirements for participation by a student athlete are established by a national association for

student athlete, to recruit or solicit the student athlete to enter into an agency contract "Educational

institution" means a public or private elementary school, secondary school, technical or vocational

57 the promotion or regulation of collegiate athletics.

58 <u>"Interscholastic sport" means a sport played between educational institutions that are not</u>
 59 community colleges, colleges, or universities.

60 <u>"Licensed, registered, or certified professional" means an individual licensed, registered,</u> 61 <u>or certified as an attorney, dealer in securities, financial planner, insurance agent, real estate</u>

62 broker or sales agent, tax consultant, accountant, or member of a profession, other than that of

63 athlete agent, who is licensed, registered, or certified by the state or a nationally recognized

64 organization that licenses, registers, or certifies members of the profession on the basis of

65 <u>experience</u>, education, or testing.

66 (7) "Person" means an individual, corporation, business trust, estate, trust, partnership,
 67 limited liability company, association, joint venture, government, governmental subdivision,
 68 agency, or instrumentality, public corporation, or any other legal or commercial entity.

69 (8) "Professional-sports-services contract" means an agreement under which an individual
 70 is employed or agrees to render services, as a player on a professional sports team, with a
 71 professional sports organization, or as a professional athlete as a professional athlete or agrees

- to render services as a player on a professional sports team or with a professional sports
   organization.
- 74 (9) "Record" means information that is inscribed on a tangible medium or that is stored in
- an electronic or other medium and is retrievable in perceivable form.
- 76 <u>"Recruit or solicit" means attempt to influence the choice of an athlete agent by a student</u>
- 77 <u>athlete or, if the student athlete is a minor, a parent or guardian of the student athlete. The term</u>

78 does not include giving advice on the selection of a particular agent in a family, coaching, or social

79 situation unless the individual giving the advice does so because of the receipt or anticipated

- 80 receipt of an economic benefit, directly or indirectly, from the agent.
- 81 (10) "Registration" means registration as an athlete agent pursuant to this article.
- 82 <u>"Sign" means with present intent to authenticate or adopt a record:</u>
- 83 (1) To execute or adopt a tangible symbol; or
- 84 (2) To attach to or logically associate with the record an electronic symbol, sound, or
- 85 process.

(11) "State" means a state of the United States, the District of Columbia, Puerto Rico, the
 United States Virgin Islands, or any territory or insular possession subject to the jurisdiction of the
 United States. References to "this state" mean the State of West Virginia.

89 (12) "Student-athlete" means an individual who engages in, is eligible to engage in, or may 90 be eligible in the future to engage in, any intercollegiate sport. If an individual is permanently 91 ineligible to participate in a particular intercollegiate sport, the individual is not a student athlete 92 for purposes of that sport is eligible to attend an educational institution and engages in, is eligible 93 to engage in, or may be eligible in the future to engage in any interscholastic or intercollegiate 94 sport. The term does not include an individual permanently ineligible to participate in a particular 95 interscholastic or intercollegiate sport.

1	(a) The Secretary of State has authority to propose rules for legislative approval in
2	accordance with §29A-3-1 et seq. of this code to implement the provisions of this article.
3	(b) By acting as an athlete agent in this state, a nonresident individual appoints the
4	Secretary of State as the individual's agent for service of process in any civil action in this state
5	related to the individual's acting as an athlete agent in this state.
6	(b) (c) The Secretary of State may issue subpoenas for any material that is relevant to the
7	administration of this article.
	§30-39-4. Athlete agents; registration required; void contracts.
1	(a) Except as otherwise provided in §30-39-4(b) of this code, an individual may not act as
2	an athlete agent in this state without holding a certificate of registration under section six or eight
3	of this article.
4	(b) Before being issued a certificate of registration, an individual may act as an athlete
5	agent in this state for all purposes except signing an agency contract, if:
6	(1) A student athlete or another person acting on behalf of the student athlete initiates
7	communication with the individual; and
8	(2) Within seven days after an initial act as an athlete agent, the individual submits an
9	application for registration as an athlete agent in this state Not later than seven days after an initial
10	act that requires the individual to register as an athlete agent, the individual submits an application
11	for registration as an athlete agent in this state.
12	(c) An agency contract resulting from conduct in violation of this section is void and the
13	athlete agent shall return any consideration received under the contract.
	§30-39-5. Registration as athlete agent; form; requirements; reciprocal registration.
1	(a) An applicant for registration shall submit an application for registration to the Secretary
2	of State in a form prescribed by the Secretary of State. An application filed under this section is a
3	public record The application must be in the name of an individual and, except as otherwise
4	provided in §30-39-5(b) of this code, signed or otherwise authenticated by the applicant under

5	penalty of perjury and state or contain:
6	(1) The name of the applicant and the address of the applicant's principal place of business
7	The name, date, and place of birth of the applicant, and the following contact information for the
8	applicant:
9	(A) The address of the applicant's principal place of business:
10	(B) The applicant's work and mobile telephone numbers, if any; and
11	(C) Any means of communicating electronically with the applicant, including a facsimile
12	number, electronic mail address, and personal, and business or employer websites.
13	(2) The name of the applicant's business or employer, if applicable, including for each
14	business or employer, its mailing address, telephone number, organization form, and the nature
15	of the business:
16	(3) Each social media account with which the applicant or the applicant's business or
17	employer is affiliated;
18	(4) Any business or occupation engaged in by the applicant for the five years next
19	preceding the date of submission of the application, including self-employment and employment
20	by others, and any professional or occupational license, registration, or certification held by the
21	applicant during that time;
22	(4) (5) A description of the applicant's:
23	(A) Formal training as an athlete agent;
24	(B) Practical experience as an athlete agent; and
25	(C) Educational background relating to the applicant's activities as an athlete agent.
26	(5) The names and addresses of three individuals not related to the applicant who are
27	willing to serve as references
28	(6) The name of each student athlete for whom the applicant acted as an athlete agent
29	within five years prior to the date of the application or, if the individual is a minor, the name of the
30	parent or guardian of the minor, together with the athlete's sport and last known team;

31	(6) The name, sport and last known team for each individual for whom the applicant acted
32	as an athlete agent during the five years next preceding the date of submission of the application
33	(7) The names and addresses of all persons who are each person who is:
34	(A) With respect to the athlete agent's business if it is not a corporation, the partners,
35	members, officers, managers, associates or profit-sharers of the business A partner, member,
36	officer, manager, associate, or profit sharer who directly or indirectly holds an equity interest of
37	five percent or greater of the athlete agent's business if it is not a corporation; and
38	(B) With respect to a corporation employing the athlete agent, the officers, directors and
39	any shareholder of the corporation having an interest of five percent or greater An officer or
40	director of a corporation employing the athlete agent or a shareholder having an interest of five
41	percent or greater in the corporation:
42	(8) Whether the applicant or any person named pursuant to subdivision (7) of this
43	subsection has been convicted of a crime that, if committed in this state, would be a crime
44	involving moral turpitude or a felony and, identify the crime A description of the status of any
45	application by the applicant, or any person named under §30-39-5(a)(7) of this code, for a state
46	or federal business, professional, or occupational license, other than as an athlete agent, from a
47	state or federal agency, including any denial, refusal to renew, suspension, withdrawal, or
48	termination of the license and any reprimand or censure related to the license.
49	(9) Whether there has been any administrative or judicial determination that the applicant
50	or any person named pursuant to subdivision (7) of this subsection has made a false, misleading,
51	deceptive, or fraudulent representation the applicant, or any person named under §30-39-5(a)(7)
52	of this code has pleaded guilty or no contest to, has been convicted of, or has charges pending
53	for a crime that would involve moral turpitude or be a felony if committed in this state, and which
54	is factually related to their practice as an athlete agent and, if so, identification of:
55	(A) The crime;
56	(B) The law-enforcement agency involved; and

57	(C) If applicable, the date of the conviction and the fine or penalty imposed.
58	(10) Any instance in which the conduct of the applicant or any person named pursuant to
59	subdivision (7) of this subsection resulted in the imposition of a sanction, suspension, or
60	declaration of ineligibility to participate in an interscholastic or intercollegiate athletic event on a
61	student athlete or educational institution Whether, 15 years prior to the date of application, the
62	applicant, or any person named under §30-39-5(a)(7) of this code has been a defendant or
63	respondent in a civil proceeding, including a proceeding seeking an adjudication of involuntary
64	hospitalization under §27-5-1 et seq. of this code, or a similar proceeding under the laws of this
65	state, any other state, or the United States and, if so, the date and a full explanation of each
66	proceeding;
67	(11) Any sanction, suspension, or disciplinary action taken against the applicant or any
68	person named pursuant to subdivision (7) of this subsection arising out of occupational or
69	professional conduct; and Whether the applicant, or any person named under §30-39-5(a)(7) of
70	this code has an unsatisfied judgment or a judgment of continuing effect, including alimony or a
71	domestic order in the nature of child support, which is not current at the date of the application;
72	(12) Whether there has been any denial of an application for, suspension or revocation of,
73	or refusal to renew, the registration or licensure of the applicant or any person named pursuant
74	to subdivision (7) of this subsection as an athlete agent in any state Whether, 10 years prior to the
75	date of application, the applicant, or any person named under §30-39-5(a)(7) of this code, was
76	adjudicated bankrupt or was an owner of a business that was adjudicated bankrupt;
77	(13) Whether there has been any administrative or judicial determination that the
78	applicant, or any person named under §30-39-5(a)(7) of this code, made a false, misleading,
79	deceptive, or fraudulent representation;
80	(14) Each instance in which conduct of the applicant, or any person named under §30-39-
81	5(a)(7) of this code, resulted in the imposition of a sanction, suspension, or declaration of
82	ineligibility to participate in an interscholastic, intercollegiate, or professional athletic event on a

- 83 student athlete or a sanction on an educational institution;
- 84 (15) Each sanction, suspension, or disciplinary action taken against the applicant, or any
- 85 person named under §30-39-5(a)(7) of this code, arising out of occupational or professional
- 86 <u>conduct;</u>
- 87 (16) Whether there has been a denial of an application for, suspension or revocation of,
- 88 refusal to renew, or abandonment of, the registration of the applicant, or any person named under
- 89 §30-39-5(a)(7) of this code, as an athlete agent in any state;
- 90 (17) Each state in which the applicant currently is registered as an athlete agent or has
- 91 applied to be registered as an athlete agent;
- 92 (18) If the applicant is certified or registered by a professional league or players
- 93 <u>association:</u>
- 94 (A) The name of the league or association;
- 95 (B) The date of certification or registration, and the date of expiration of the certification or
- 96 registration, if any; and
- 97 (C) If applicable, the date of any denial of an application for, suspension or revocation of,
- 98 refusal to renew, withdrawal of, or termination of, the certification or registration or any reprimand
- 99 or censure related to the certification or registration; and
- 100 (19) Any additional information required by the Secretary of State.

101 (b) An individual who has submitted an application for, and holds a certificate of, 102 registration or licensure as an athlete agent in another state, may submit a copy of the application 103 and certificate in lieu of submitting an application in the form prescribed pursuant to subsection 104 (a) of this section. The Secretary of State shall accept the application and the certificate from the 105 other state as an application for registration in this state if the application to the other state Instead 106 of proceeding under §30-39-5(a) of this code, an individual registered as an athlete agent in 107 another state may apply for registration as an athlete agent in this state by submitting to the 108 Secretary of State:

111	application is current A copy of the application for registration in the other state;
112	(2) Contains information substantially similar to or more comprehensive than that required
113	in an application submitted in this state A statement that identifies any material change in the
114	information on the application or verifies there is no material change in the information, signed
115	under penalty of perjury; and
116	(3) Was signed by the applicant under penalty of perjury A copy of the certificate of
117	registration from the other state, as well as a copy of the certificate of registration from any other
118	state in which the applicant is registered.
119	(c) The Secretary of State shall issue a certificate of registration to an individual who
120	applies for registration under §30-39-5(b) of this code if the Secretary of State determines:
121	(1) The application and registration requirements of the other state are substantially similar
122	to or more restrictive than this article; and
123	(2) The registration has not been revoked or suspended and no action involving the
124	individual's conduct as an athlete agent is pending against the individual or the individual's
125	registration in any state.
126	(d) For purposes of implementing §30-39-5(c) of this code, the Secretary of State shall:
127	(1) Cooperate with national organizations concerned with athlete agent issues and
128	agencies in other states which register athlete agents to develop a common registration form and
129	determine which states have laws that are substantially similar to or more restrictive than this
130	article; and
131	(2) Exchange information, including information related to actions taken against registered
132	athlete agents or their registrations, with those organizations and agencies.
	§30-39-6. Certificate of registration; issuance or denial; renewal.

(a) Except as otherwise provided in §30-39-6(b) of this code, the Secretary of State shall

2	issue a certificate of registration to an individual who complies with §30-39-5(a) of this code or
3	whose application has been accepted under §30-39-5(b) of this code.
4	(b) The Secretary of State may refuse to issue a certificate of registration if the Secretary
5	of State determines that the applicant has engaged in conduct that has a significant adverse effect
6	on the applicant's fitness to act as an athlete agent. In making the determination, the Secretary
7	of State may consider whether the applicant has:
8	(1) Been convicted of a crime that, if committed in this state, would be a crime involving
9	moral turpitude or a felony Pleaded guilty or no contest to, has been convicted of, or has charges
10	pending for a crime that would involve moral turpitude or be a felony if committed in this state,
11	and which is factually related to their practice as an athlete agent;
12	(2) Made a materially false, misleading, deceptive, or fraudulent representation in the
13	application or as an athlete agent;
14	(3) Engaged in conduct that would disqualify the applicant from serving in a fiduciary
15	capacity;
16	(4) Engaged in conduct prohibited by §30-39-14 of this code;
17	(5) Had a registration or licensure as an athlete agent suspended, revoked, or denied or
18	been refused renewal of registration or licensure as an athlete agent in any state;
19	(6) Engaged in conduct the consequence of which was that a sanction, suspension, or
20	declaration of ineligibility to participate in an interscholastic or intercollegiate athletic event was
21	imposed on a student athlete or educational institution; or
22	(7) Engaged in conduct that significantly adversely reflects on the applicant's credibility,
23	honesty, or integrity.
24	(c) In making a determination under §30-39-6(b) of this code, the Secretary of State shall
25	consider:
26	(1) How recently the conduct occurred;
27	(2) The nature of the conduct and the context in which it occurred; and

(3) Any other relevant conduct of the applicant.

(d) An athlete agent may apply to renew a registration by submitting an application for
 renewal in a form prescribed by the Secretary of State. An application filed under this section is a
 <del>public record</del> The application for renewal must be signed by the applicant under penalty of perjury
 and must contain current information on all matters required in an original registration.

(e) An individual who has submitted an application for renewal of registration or licensure
in another state, in lieu of submitting an application for renewal in the form prescribed pursuant to
§30-39-6(d) of this code, may file a copy of the application for renewal and a valid certificate of
registration or licensure from the other state. The Secretary of State shall accept the application
for renewal from the other state as an application for renewal in this state if the application to the
other state:

(1) Was submitted in the other state within six months next preceding the filing in this state
 and the applicant certifies the information contained in the application for renewal is current <u>The</u>
 registration requirements of the other state are substantially similar to or more restrictive than this
 article;

(2) Contains information substantially similar to or more comprehensive than that required
in an application for renewal submitted in this state <u>The renewed registration has not been</u>
suspended or revoked and no action involving the individual's conduct as an athlete agent is
pending against the individual or the individual's registration in any state; and

47 (3) Was signed by the applicant under penalty of perjury.

48 (f) A certificate of registration or a renewal of a registration is valid for two years.

#### §30-39-7. Suspension, revocation, or refusal to renew registration.

(a) The Secretary of State may <u>limit</u>, suspend, revoke, or refuse to renew a registration for
 conduct that would have justified denial of registration under §30-39-6(b) of this code.

3 (b) The Secretary of State may deny, suspend, revoke or refuse to renew a certificate of
4 registration or licensure only after proper notice and an opportunity for a hearing. The provisions

5	of article five, chapter twenty-nine-a of this code apply to this article The Secretary of State may
6	suspend or revoke the registration of an individual registered under §30-39-5(c) of this code, or
7	renewed under §30-39-6(e) of this code, for any reason for which the Secretary of State could
8	have refused to grant or renew registration, or for conduct that would justify refusal to issue a
9	certificate of registration under §30-39-6(b) of this code.
10	(c) An applicant may appeal a decision of the Secretary of State to refuse to issue, deny,
11	suspend, revoke, or refuse to renew a certificate of registration or licensure. The provisions of
12	§29A-5-1 et seq. of this code shall apply. The Secretary of State may promulgate procedural rules
13	to implement the provisions of this subsection.
	§30-39-9. Registration and renewal fees.
1	An application for registration or renewal of registration must be accompanied by a fee in
2	the following amount:
3	(1) Fifty dollars <u>\$100</u> for an initial application for registration;
4	(2) Fifty dollars <u>\$100</u> for an application for registration based upon a certificate of
5	registration or licensure issued by another state;
6	(3) Ten dollars <u>\$50</u> for an application for renewal of registration; or
7	(4) Ten dollars <u>\$50</u> for an application for renewal of registration based upon an application
8	for renewal of registration or licensure submitted in another state.
	§30-39-10. Required form of contract.
1	(a) An agency contract must be in a record, signed or otherwise authenticated by the
2	parties.
3	(b) An agency contract must state or contain:
4	(1) A statement that the athlete agent is registered as an athlete agent in this state and a
5	list of any other states in which the agent is registered as an athlete agent;
6	(1) (2) The amount and method of calculating the consideration to be paid by the student
7	athlete for services to be provided by the athlete agent under the contract and any other

8 consideration the athlete agent has received or will receive from any other source for entering into
9 the contract or for providing the services;

10 (2) (3) The name of any person not listed in the application for registration or renewal of

- 11 registration who will be compensated because the student athlete signed the agency contract;
- 12 (3) (4) A description of any expenses that the student athlete agrees to reimburse;
- 13 (4) (5) A description of the services to be provided to the student athlete;
- 14 (5) (6) The duration of the contract; and

15 (6) (7) The date of execution.

(c) An agency contract must contain, in close proximity to the signature of the student
athlete, a conspicuous notice in boldface type in capital letters stating:

#### 18 WARNING TO STUDENT ATHLETE

- 19 IF YOU SIGN THIS CONTRACT:
- 20 (1) YOU MAY LOSE YOUR ELIGIBILITY TO COMPETE AS A STUDENT-ATHLETE IN21 YOUR SPORT;
