Senate Bill 715

BY SENATORS BLAIR (MR. PRESIDENT) AND BALDWIN

(BY REQUEST OF THE EXECUTIVE)

[Passed March 10, 2022; in effect from passage]

1 AN ACT supplementing and amending the appropriations of public moneys out of the State
2 Treasury in the State Fund, General Revenue, by decreasing items of appropriation to the
3 Department of Economic Development - Office of the Secretary, fund 0256, fiscal year
4 2022, organization 0307; and by increasing items of appropriation to the Department of
5 Commerce - Office of the Secretary, fund 0606, fiscal year 2022, organization 0327 for
6 the fiscal year ending June 30, 2022.

1 Whereas, The Governor submitted the Executive Budget Document to the Legislature on
2 January 12, 2022, containing a statement of the State Fund, General Revenue, setting forth
3 therein the cash balance as of July 1, 2021, and further included the revised estimate of revenue
4 for the fiscal year 2022, less net appropriation balances forwarded and regular and surplus
5 appropriations for the fiscal year 2022; and

6 Whereas, It appears from the Governor's Statement of the State Fund, General Revenue,
7 there now remains an unappropriated balance in the State Treasury which is available for
8 appropriation during the fiscal year ending June 30, 2022; therefore

Be it enacted by the Legislature of West Virginia:

1 That the total appropriations for the fiscal year ending June 30, 2022, to fund 0256, fiscal
2 year 2022, organization 0307 be supplemented and amended by decreasing existing items of
3 appropriation as follows:
