### **Senate Bill 733**

1 A BILL supplementing and amending appropriations of public moneys out of the State Treasury  
2 in the State Fund, General Revenue, by decreasing an existing item of appropriation and  
3 adding a new item of appropriation to the Executive, Governor's Office, fund 0101, fiscal  
4 year 2022, organization 0100, by supplementing and amending appropriations for the  
5 fiscal year ending June 30, 2022.

1 Whereas, The Governor submitted the Executive Budget Document to the Legislature on  
2 January 12, 2022, containing a statement of the State Fund, General Revenue, setting forth  
3 therein the cash balance as of July 1, 2021, and further included the revised estimate of revenue  
4 for the fiscal year 2022, less net appropriation balances forwarded and regular and surplus  
5 appropriations for the fiscal year 2022; and

6 Whereas, It appears from the Executive Budget document, Statement of the State Fund,  
7 General Revenue, and this legislation, there remains an unappropriated balance in the State  
8 Treasury which is available for appropriation during the fiscal year ending June 30, 2022;  
9 therefore

*Be it enacted by the Legislature of West Virginia:*

1 That the total appropriation for the fiscal year ending June 30, 2022, to fund 0101, fiscal  
2 year 2022, organization 0100, be supplemented and amended by decreasing an existing item of  
3 appropriation as follows:
