1 A BILL making a supplementary appropriation of public moneys out of the Treasury from the
2 balances of moneys remaining unappropriated for the fiscal year ending June 30, 2024, to
3 the Department of Homeland Security, Division of Corrections and Rehabilitation – Parolee
4 Supervision Fees, fund 6362, fiscal year 2024, organization 0608, and to the Department
5 of Homeland Security, Division of Corrections and Rehabilitation – Regional Jail and
6 Correctional Facility Authority, fund 6675, fiscal year 2024, organization 0608 by
7 supplementing and amending the appropriations for the fiscal year ending June 30, 2024.

8 Whereas, The Governor has established that there now remains an unappropriated
9 balances in the Department of Homeland Security, Division of Corrections and Rehabilitation –
10 Parolee Supervision Fees, fund 6362, fiscal year 2024, organization 0608, and in the Department
11 of Homeland Security, Division of Corrections and Rehabilitation – Regional Jail and Correctional
12 Facility Authority, fund 6675, fiscal year 2024, organization 0608, that is available for expenditure
13 during the fiscal year ending June 30, 2024, which is hereby appropriated by the terms of this
14 supplementary appropriation bill; therefore

Be it enacted by the Legislature of West Virginia:

1 That the total appropriation for the fiscal year ending June 30, 2024, to fund 6362, fiscal
2 year 2024, organization 0608, be supplemented and amended by increasing an existing item of
3 appropriation as follows:
