**Senate Bill 1023**

1 AN ACT making a supplementary appropriation of public moneys out of the Treasury from the  
2 balances of moneys remaining unappropriated for the fiscal year ending June 30, 2024, to  
3 the Department of Homeland Security, Division of Emergency Management, All County  
4 Fire Protection Fund, fund xxxx, fiscal year 2024, organization 0606 and to the Department  
5 of Homeland Security, Division of Emergency Management, County Fire Protection Fund,  
6 fund xxxx, fiscal year 2024, organization 0606 by supplementing and amending the  
7 appropriations for the fiscal year ending June 30, 2024.

8 Whereas, The Governor has established that there now remains unappropriated balances  
9 in the Department of Homeland Security, Division of Emergency Management, All County Fire  
10 Protection Fund, fund xxxx, fiscal year 2024, organization 0606, and in the Department of  
11 Homeland Security, Division of Emergency Management, County Fire Protection Fund, fund xxxx,  
12 fiscal year 2024, organization 0606 that is available for expenditure during the fiscal year ending  
13 June 30, 2024, which is hereby appropriated by the terms of this supplementary appropriation bill;  
14 therefore

*Be it enacted by the Legislature of West Virginia:*
