# CHAPTER 5F. REORGANIZATION OF THE EXECUTIVE BRANCH OF

# STATE GOVERNMENT.

# ARTICLE 1. GENERAL PROVISIONS.

### §5F-1-2. Executive departments created.

- (a) There are created, within the executive branch of the state government, the following
   departments:

(<del>o</del>) (<u>q</u>) Any department previously transferred to and incorporated in a department by prior enactment of this section means a division of the appropriate department. Wherever reference is made to any department transferred to and incorporated in a department created in §5F-1-2 of this code, the reference means a division of the appropriate department and any reference to a division of a department so transferred and incorporated means a section of the appropriate division of the department.

(p) (r) When an agency, board, or commission is transferred under a bureau or agency other than a department headed by a secretary pursuant to this section, that transfer is solely for purposes of administrative support and liaison with the Office of the Governor, a department secretary, or a bureau. Nothing in this section extends the powers of department secretaries under §5F-2-2 of this code to any person other than a department secretary and nothing limits or abridges the statutory powers and duties of statutory commissioners or officers pursuant to this code.

 §5F-2-2. Power and authority of secretary of each department.

(a) Notwithstanding any other provision of this code to the contrary, the secretary of each
 department shall have plenary power and authority within and for the department to:

3 (1) Employ and discharge within the office of the secretary employees as may be

necessary to carry out the functions of the secretary, which employees shall serve at the will and
pleasure of the secretary;

6 (2) Cause the various agencies and boards to be operated effectively, efficiently, and
7 economically and develop goals, objectives, policies, and plans that are necessary or desirable for
8 the effective, efficient, and economical operation of the department;

9 (3) Eliminate or consolidate positions, other than positions of administrators or positions of
10 board members and name a person to fill more than one position;

(4) Transfer permanent state employees between departments in accordance with the
 provisions of §5F-2-7 of this code;

13 (5) Delegate, assign, transfer, or combine responsibilities or duties to or among
14 employees, other than administrators or board members;

15 (6) Reorganize internal functions or operations;

16 (7) Formulate comprehensive budgets for consideration by the Governor; and transfer 17 within the department funds appropriated to the various agencies of the department which are not 18 expended due to cost savings resulting from the implementation of the provisions of this chapter: 19 Provided, That no more than 25 percent of the funds appropriated to any one agency or board may 20 be transferred to other agencies or boards within the department: Provided, however, That no 21 funds may be transferred from a special revenue account, dedicated account, capital expenditure 22 account, or any other account or funds specifically exempted by the Legislature from transfer, 23 except that the use of appropriations from the State Road Fund transferred to the office of the 24 Secretary of the Department of Transportation is not a use other than the purpose for which the 25 funds were dedicated and is permitted: Provided further, That if the Legislature by subsequent 26 enactment consolidates agencies, boards, or functions, the appropriate secretary may transfer the 27 funds formerly appropriated to the agency, board, or function in order to implement consolidation. 28 The authority to transfer funds under this section shall expire on June 30, 2010

(8) Enter into contracts or agreements requiring the expenditure of public funds and

(b) The secretaries of the departments hereby created shall engage in a comprehensive
review of the practices, policies, and operations of the agencies and boards within their
departments to determine the feasibility of cost reductions and increased efficiency which may be
achieved therein, including, but not limited to, the following:

(c) Notwithstanding the provisions of subsections (a) and (b) of this section, none of the powers granted to the secretaries herein shall be exercised by the secretary if to do so would violate or be inconsistent with the provisions of any federal law or regulation, any federal-state program or federally delegated program or jeopardize the approval, existence or funding of any program.

(d) The layoff and recall rights of employees within the classified service of the state as
provided in §29-6-10(5) and §29-6-10(6) of this code shall be limited to the organizational unit
within the agency or board and within the occupational group established by the classification and

compensation plan for the classified service of the agency or board in which the employee was employed prior to the agency or board's transfer or incorporation into the department: *Provided*, That the employee shall possess the qualifications established for the job class. The duration of recall rights provided in this subsection shall be limited to two years or the length of tenure, whichever is less. Except as provided in this subsection, nothing contained in this section shall be construed to abridge the rights of employees within the classified service of the state as provided in §29-6-10 and §29-6-10a of this code.

# CHAPTER 6. GENERAL PROVISIONS RESPECTING OFFICERS.

#### **ARTICLE 7. COMPENSATION AND ALLOWANCES.**

# §6-7-2a. Terms of certain appointive state officers; appointment; qualifications; powers and salaries of officers.

1 (a) Each of the following appointive State officers named in this subsection shall be 2 appointed by the Governor, by and with the advice and consent of the Senate. Each of the 3 appointive state officers serves at the will and pleasure of the Governor for the term for which the Governor was elected and until the respective state officers' successors have been appointed and 4 5 gualified. Each of the Appointive state officers are subject to the existing gualifications for holding 6 each respective office and each has and is hereby granted all of the powers and authority and shall 7 perform all of the functions and services heretofore vested in and performed by virtue of existing 8 law respecting each office.

The annual salary of each named appointive state officer is as follows:

10 Commissioner, Division of Highways, \$92,500; Commissioner, Division of Corrections and 11 Rehabilitation, \$90,000; Director, Division of Natural Resources, \$75,000; Superintendent, State 12 Police, \$85,000; Commissioner, Division of Financial Institutions, \$75,000; Commissioner, 13 Division of Culture and History, \$65,000; Commissioner, Alcohol Beverage Control Commission, 14 \$75,000: Commissioner, Division of Motor Vehicles, \$75,000; Director, Human Rights 15 Commission, \$55,000; Commissioner, Division of Labor, \$70,000; Chairperson, Board of Parole, 16 \$55,000; members, Board of Parole, \$50,000; members, Employment Security Review Board, 17 \$17,000; and Commissioner, Workforce West Virginia, \$75,000. 8 (c) The term "Federal-state assistance" means and includes: (1) All forms of aid, care, assistance and services to or on behalf of persons, which are authorized by, and who are 9 10 authorized to receive the same under and by virtue of, subchapters one, four, five, ten, fourteen, 11 sixteen, eighteen and nineteen, chapter seven, Title 42, United States Code, as those 12 subchapters have heretofore been and may hereafter be amended, supplemented and revised by 13 acts of Congress, and as those subchapters so amended, supplemented and revised have 14 heretofore been and may hereafter be supplemented by valid rules and regulations promulgated 15 by authorized federal agents and agencies, and as those subchapters so amended, 16 supplemented and revised have heretofore been and may hereafter be supplemented by rules 17 promulgated by the state division of human services, which division rules shall be consistent with 18 federal laws, rules and regulations, but not inconsistent with state law; and (2) all forms of aid, 19 care, assistance and services to persons, which are authorized by, and who are authorized to 20 receive the same under and by virtue of, any act of Congress, other than the federal social security 21 act, as amended, for distribution through the state division of human services to recipients of any 22 form of aid, care, assistance and services to persons designated or referred to in (1) of this definition and to recipients of state assistance, including by way of illustration, surplus food and

distribute to needy persons.

(d) The term "Federal assistance" means and includes all forms of aid, care, assistance

 division of human services, the cost of which is paid entirely out of federal appropriations.

30 (e) The term "State assistance" means and includes all forms of aid, care, assistance,
 31 services and general relief made possible solely out of state, county and private appropriations to
 32 or on behalf of indigent persons, which are authorized by, and who are authorized to receive the
 33 same under and by virtue of, state division of human services' department rules.

34 (f) The term "Welfare Assistance" means the three classes of assistance administered by
 35 the state division of human services, namely: Federal-state assistance, federal assistance and

petition. Unless otherwise agreed by the parties, the court may not schedule the hearing sooner
than 10 days after the filing of the petition for appeal. The petitioner shall provide notice of the date
and time of the hearing to the agency.

(I) In cases involving alleged irregularities in procedure before the agency that are not shown in the record, the court may take additional testimony. Otherwise, the circuit court shall review the appeal without a jury and may only consider the official record provided pursuant to the requirements of this section. The court may hear oral arguments and require written briefs.

(j) The court may affirm the final decision or order of the agency or remand the matter for further proceedings. The court may reverse, vacate or modify the final decision or order of the agency only if the substantial rights of the petitioner have been prejudiced because the administrative findings, inferences, conclusions, decision or order are:

62 (1) In violation of constitutional or statutory provisions;

63 (2) In excess of the statutory authority or jurisdiction of the agency;

64 (3) Made upon unlawful procedures;

65 (4) Affected by other error of law;

66 (5) Clearly wrong in view of the reliable, probative, and substantial evidence on the whole67 record; or

68 (6) Arbitrary or capricious or characterized by an abuse of discretion or clearly unwarranted
69 exercise of discretion.

(k) The judgment of the circuit court is final unless reversed, vacated or modified on appeal
to the West Virginia Supreme Court of Appeals.

(I) The process established by this section is the exclusive remedy for judicial review of
 final decisions of the Board of Review and the Bureau for Medical Services.

## §9-2-14. Office of Chief Operating Officer.

(a) By July 1, 2023, there is continued an Office of the Chief Operating Officer. The Chief

# §16-1-2. Definitions.

with the state Commissioner of Corrections and Rehabilitation and otherwise in accord with law,
accept a transfer of a resident of a facility under the jurisdiction of the state Commissioner of
Corrections and Rehabilitation;

(12) To make periodic reports to the Governor and to the Legislature relative to specific
subject areas of public health, or other matters affecting the public health of the people of the state;
(13) To accept and use for the benefit of the health of the people of this state, any gift or
devise of any property or thing which is lawfully given: *Provided*, That if any gift is for a specific
purpose shall be used as specified. Any profit which may arise from any gift or devise of any
property or thing shall be deposited in a special revenue fund with the State Treasurer and shall be
used only as specified by the donor or donors;

# CHAPTER 26. STATE HEALTH CARE FACILITIES.

## ARTICLE 1. DEPARTMENT OF HEALTH CARE FACILITIES.

### §26-1-1. Department of Health Care Facilities.

Secretary of Department of Health Care Facilities. 1 The state department of welfare shall admit to the home children surrendered or otherwise 2 placed in its custody in any manner authorized by law; and the children shall be kept, maintained 3 and educated therein until they can be placed by legal authority in suitable homes elsewhere 4 (a) The secretary shall be the head of the department, and shall be appointed before July 5 1, 2023, by the Governor, with the advice and consent of the Senate. 6 (b) Before entering upon the duties of his or her office, the secretary shall take and 7 subscribe to the oath of office prescribed by section five, article four of the state Constitution. 8 (c) The secretary shall not be a candidate for, or hold, any other public office or public 9 employment under the federal government or under the government of this state or any of its political subdivisions, or be a member or officer of any political party committee, or serve as an 10 11 election official, or engage in any political activity, other than to vote, in behalf of, or in opposition 12 to, any candidate, political party or public issue involved in an election. Any violation by the 13 secretary of the provisions of this section shall automatically vacate his or her appointment as 14 secretary.

# CHAPTER 49. CHILD WELFARE.

## **ARTICLE 1. GENERAL PROVISIONS AND DEFINITIONS.**

# §49-1-106. Location of child welfare services; state and federal cooperation; juvenile services.

1 (a) The child welfare service of the state shall be located within and administered by the 2 Bureau for Family Assistance of Department of Health and Human Resources Human Services. 3 The Division of Juvenile Services of the Department of Military Affairs and Public Safety shall 4 administer the secure predispositional juvenile detention and juvenile correctional facilities of the 5 state. Notwithstanding any other provision of this code to the contrary, the administrative authority 6 of the Division of Juvenile Services over any child or juvenile in this state extends only to those 7 detained or committed to a secure detention facility or secure correctional facility operated and 8 maintained by the division by an order of a court of competent jurisdiction during the period of 9 actual detention or confinement in the facility.

10 (b) The Department of Health and Human Resources Human Services is designated as 11 the state entity to cooperate with the United States Department of Health and Human Services and 12 United States Department of Justice in extending and improving child welfare services, to comply 13 with federal regulations, and to receive and expend federal funds for these services. The Division 14 of Juvenile Services of the Department of Military Affairs and Public Safety is designated as the 15 state entity to cooperate with the United States Department of Health and Human Services and 16 United States Department of Justice in operating, maintaining and improving juvenile correction 17 facilities and centers for the predispositional detention of children, to comply with federal 18 regulations, and to receive and expend federal funds for these services.

(c) The Division of Juvenile Services of the Department of Military Affairs and Public Safety
 is authorized to operate and maintain centers for juveniles needing detention pending disposition
 by a court having juvenile jurisdiction or temporary care following that court action.
