1 A BILL finding and declaring certain claims against the state and its agencies to be moral
2 obligations of the state; and directing the Auditor to issue warrants for the payment thereof.

Be it enacted by the Legislature of West Virginia:

§1. Finding and declaring certain claims against the Department of Administration;
Department of Administration, Office of Technology; Department of Administration,
General Services Division; Department of Environmental Protection; Department of
Military Affairs & Public Safety, Division of Corrections and Rehabilitation;
Department of Military Affairs & Public Safety, West Virginia Army National Guard;
Department of Transportation, Division of Highways; and Department of
Transportation, Division of Motor Vehicles, to be moral obligations of the state and
directing payment thereof.

1 The Legislature has considered the findings of fact and recommendations reported to it by
2 the Legislative Claims Commission concerning various claims against the state and agencies
3 thereof and, in respect to each of the following claims, the Legislature adopts those findings of fact
4 as its own and in respect of the claims herein, the Legislature has independently made findings of
5 fact and determinations of award and hereby declares it to be the moral obligation of the state to
6 pay each such claim in the amount specified below and directs the Auditor to issue warrants for the
7 payment thereof out of any fund appropriated and available for the purpose.

10 to any claimant provided in this bill, the Legislative Claims Commission shall receive a release
11 from said claimant releasing any and all claims for moral obligations arising from the matters
12 considered by the Legislature in the finding of the moral obligations and the making of the
13 appropriations for said claimant. The Legislative Claims Commission shall deliver all releases
14 obtained from claimants to the department against which the claim was allowed.
