A BILL to amend the Code of West Virginia, 1931, as amended, by adding thereto a new section,
designated §11-21-98, relating to tax reductions and other aid for West Virginians; stating a
purpose; providing for a child tax credit; providing for a child and dependent care tax credit;
authorizing an earned income tax credit; authorizing a student loan interest tax credit; and
providing for rulemaking and an effective date.

Be it enacted by the Legislature of West Virginia:

## ARTICLE 21. PERSONAL INCOME TAX.

Тах reductions and other aid for West Virginians. §11-21-98. 1 (a) Purpose. -- The purpose of this section is to provide cash relief and financial support to 2 families with young children and to employees who incur child and dependent care expenses to 3 enable them to remain in the workforce, and to lessen the financial impact of higher education on 4 residents with student loans.

5 (b) Child tax credit. -- A resident individual or part-year resident individual who is entitled to 6 a child tax credit under the laws of the United States shall be entitled to a refundable credit against 7 the tax imposed by §11-21-1, et seq. of this code for the taxable year. The total credit per taxable 8 year shall be in the amount of \$1,000 per qualifying child, as defined under 26 U.S.C. § 152(c), 9 who is five years of age or younger as of the close of the calendar year in which the taxable year of 10 the taxpayer begins. For a part-year resident individual, the amount of the credit shall be multiplied 11 by the percentage that the individual's income that is earned or received during the period of the 12 individual's residency in this state bears to the individual's total income. 13 (1) Notwithstanding any provision of law to the contrary, the refundable credit and its 14 payment authorized under this section shall be treated in the same manner as the federal Earned Income Tax Credit and shall not be considered as assets, income, or resources to the same extent 15

16 the credit and its payment would be disregarded pursuant to 26 U.S.C. §3512. This section shall

17 only apply to the extent that it does not conflict with federal law relating to the benefit or assistance

18 program and that any required federal approval or waiver is first obtained for that program.

19	(c) Child and dependent care credit A resident of this state shall be eligible for a
20	refundable credit against the tax imposed under §11-21-1, et seq. of this code. The credit shall be
21	equal to 72% of the federal child and dependent care credit allowed to the taxpayer for the taxable
22	year for child or dependent care services provided in this state.
23	(d) Earned income tax credit A resident individual or part-year resident individual who is
24	entitled to an earned income tax credit granted under the laws of the United States shall be entitled
25	to a credit against the tax imposed by §11-21-1, et seq. of this code for the taxable year. The credit
26	shall be 38% of the earned income tax credit granted to the individual under the laws of the United
27	States, multiplied by the percentage that the individual's earned income that is earned or received
28	during the period of the individual's residency in this state bears to the individual's total earned
29	income.
30	(e) Student loan interest credit A qualified resident taxpayer who incurs interest on a
31	qualified education loan for the costs of attendance at an eligible educational institution is entitled
32	to a credit against the tax imposed by §11-21-1, et seq. of this code for the taxable year. For
33	purposes of this subsection, a "qualified education loan" and "eligible educational institution" shall
34	have the same meanings as under 26 U.S.C. § 221(d).
35	(f) Rulemaking In order to effectuate the purposes of this section, the Tax Commissioner
36	may promulgate procedural rules, interpretive rules and legislative rules, including emergency
37	rules, or any combination thereof in accordance with §29A-3-1, et seq. of this code.
38	(g) Effective date This section shall be effective for personal income tax years beginning
39	<u>on or after January 1, 2024.</u>

NOTE: The purpose of this bill is to provide tax reductions and other aid to West Virginians. The bill states a purpose; provides for a child tax credit; provides for a child and dependent care tax credit; authorizes an earned income tax credit; authorizes a student loan interest tax credit; and provides for rulemaking and an effective date.
