1	A BILL to amend the Code of West Virginia, 1931, as amended, by adding thereto a new article,
2	designated §18B-22-1, §18B-22-2, §18B-22-3, §18B-22-4, §18B-22-5, §18B-22-6, §18B-
3	22-7, §18B-22-8, §18B-22-9, and §18B-22-10, all relating to the Student Basic Needs
4	Campus Initiative; establishing the Student Basic Needs Campus Initiative; authorizing the
5	creation of the Student Basic Needs Campus Program office; establishing the duties of the
6	Hunger Free Campus Program office; authorizing the Student Basic Needs Campus
7	Program office to administer and advise the Chancellor on the Student Basic Needs
8	Campus Grant Program; establishing the requirement for designation as a Student Basic
9	Needs Campus; setting requirements for awarding Student Basic Needs grants;
10	addressing Student Basic Needs Campus grant administration; creating the Student Basic
11	Needs Campus Program and Grant Fund; setting forth reporting requirements; and
12	authorizing legislative rules.

1	(a) The Legislature of the State of West Virginia finds:						
2	(1) Food insecurity can look like the inability to afford balanced meals, or that the food				or that the food		
3	students buy does not last and they are unable to afford more.						
4	(2) The most common presentation of food insecurity in college students is skipping meals						
5	or cutting the size of meals because they could not afford food.						
6	<u>(3) Studi</u>	ies shc	w that over one	in three stud	ents at West	Virginia Univers	ity surveyed are
7	food insecure.						
8	<u>(4) At lea</u>	ast one	-third of two-yea	r students ar	e housing inse	ecure, including	up to 14 percent
9	who are homele	ss, wh	ereas between 1	1 percent and	d 19 percent o	f four-year stude	ents are housing

10	insecure.
11	(5) Students pay an average of \$9,261 a year for on-campus housing and \$682 a month for
12	off campus housing.
13	(6) Out of the 10 largest universities in West Virginia, the cheapest average room and
14	board option in 2016 cost \$7,960 for in-state students at West Liberty University and the highest
15	cost of average room and board was \$10,575 at West Virginia University.
16	(7) Studies show that being food insecure affects the sleep quality by looking at factors
17	such as glycemic control disruptions, low energy, and weight issues as well as physical health,
18	mental health, and academic progress in students and,
19	(8) Such results have suggested that food insecurity can contribute to poor health and
20	increased Body Mass Index (BMI) as well as food insecure students have more coping
21	mechanisms and lower academic progress.
22	(9) West Virginia University is ranked fifth out of 37 public universities in the state for the
23	freshman retention rate and ranked 1,101 out of 3,392 nationally.
24	(10) West Virginia ranks as the 8th worst in the United States for four-year institutional
25	graduation at 24 percent.
26	(11) Approximately \$4,750 is spent on an estimated 3,200 West Virginia Promise students
27	each year.
28	(12) In order for the estimated \$15.2 million investment for West Virginia Promise students
29	to see a return on investment, additional steps must be taken to ensure students can stay in school
30	and complete their degree successfully.
31	(b) The intent of the Legislature relating to this article is to reduce the dropout rate and aid
32	in the successful completion of higher education in West Virginia. This will be accomplished by
33	alleviating the food and housing insecurity barriers that make successful completion of this
34	achievement an often unattainable and unrealistic goal for many undergraduate students within
35	the state.

	§18B-22-3. Definitions.				
1	In this article the following words have the meanings indicated.				
2	"Chancellor" means the Chancellor for Higher Education.				
3	"Commission" means the Higher Education Policy Commission.				
4	"Student Basic Needs Campus Program Office" or "office" means the office established by				
5	the commission to support institutions of public higher education to build their capacity to				
6	understand and address existing gaps in addressing student food insecurity and hunger on their				
7	campus, using interventions that reflect best practices.				
	<u>§18B-22-4. Student Basic Needs Campus Initiative.</u>				
1	(a) The Higher Education Policy Commission shall establish an initiative known as the				
2	Student Basic Needs Campus Initiative to address college student food insecurity and hunger				
3	across all public higher education campuses. This initiative may also be available to certain not-				
4	for-profit campuses that disproportionately serve low-income students as determined by the				
5	Student Basic Needs Campus Program office.				
6	(b) The commission shall establish the Student Basic Needs Campus Program office. The				
7	mission of the office is to support institutions of public higher education to build their capacity to				
8	understand and address existing gaps in addressing student food insecurity and hunger on their				
9	campus, using interventions that reflect best practices.				
10	(c) The office shall assist public higher education campuses to be designated as a "Student				
11	Basic Needs Campus" as provided by this section and to meet the eligibility for Student Basic				
12	Needs Campus grants. In addition, the office administers the Student Basic Needs Campus Grant				
13	Program as established by §18B-22-6 of this code.				
14	(d) The office will develop and deliver technical assistance to assist the public higher				
15	education campuses to engage in activities and implement interventions that reflect best practices				
16	that:				
17	(1) Raise awareness on resources available to address basic food needs;

18	(2) Leverage existing infrastructure and maximize current federal programs; and
19	(3) Build strategic partnerships at the federal, state, and local levels to mitigate food
20	insecurity among students.
21	(e) The office shall provide technical assistance to support the knowledge, skills, and
22	comfort the campuses need in order to deliver services as part of this program. Technical
23	assistance may include:
24	(1) Resource and materials development;
25	(2) Consultation;
26	(3) Training;
27	(4) Network development and support; and
28	(5) The statewide Student Basic Needs Campus grant program to support campus efforts
29	to implement measurable, sustainable, and equitable interventions to address the basic food
30	needs of college students in the state.
31	(f) The office shall also administer and advise the chancellor on the Student Basic Needs
32	Campus Grant Program. The Student Basic Needs Campus grants will be awarded to sustain
33	efforts by institutions to implement measurable, sustainable, and equitable solutions to address
34	the basic food needs of college students in the state.
35	(g) The office of capacity building services shall submit a report on common themes and
36	best practices for increasing food security resources available to students to the chancellor as well
37	as the Legislative Oversight Commission on Education Accountability no later than two years after
38	the enactment of this article.
	<u>§18B-22-5. Student Basic Needs Campus Initiative - Capacity Building Services.</u>
1	(a) The Student Basic Needs Campus Initiative shall partner with public higher education
2	campuses and certain not-for-profit campuses that disproportionately serve low-income students
3	to support implementation of interventions that meet the aforementioned goals including the
4	following five anti-hunger activities. Completion of the initiatives set out in subsection (b) in each

5	academic year will earn the campus the designation of a Student Basic Needs Campus.
6	(b) Campus anti-hunger activities can utilize the initiative's capacity building services and
7	may include:
8	(1) Institutions will designate one staff person to be the Student Basic Needs Campus
9	Coordinator. The coordinator will be the contact person with the Student Basic Needs Campus
10	Program office and oversee the institution's activities.
11	(2) Institutions shall establish a Student Basic Needs Campus Task Force. The Task Force
12	determines the priority activities for the campus for the academic year and can also engage in
13	multi-year campus planning. The Task Force includes, but is not limited to, two or more students
14	with lived experience of food insecurity, a faculty member, a member of the health services staff, a
15	member of the student services staff, a member of the campus dining or food services staff, and a
16	representative from a local hunger-relief organization. The task force shall meet a minimum of
17	twice per academic year in order to plan accordingly for action and program engagement.
18	(3) Institutions will determine mechanisms to notify students who receive need-based
19	financial aid of their potential eligibility to receive Supplemental Nutrition Assistance Program
20	(SNAP) benefits, Special Supplemental Nutrition Program for Women, Infants, and Children (WIC)
21	benefits, and other federal and state nutrition benefits available to said student or dependents.
22	Mechanisms can include submitting such notification in all financial aid award letters and through
23	financial aid portals available to students. Institutions will make such notification.
24	(4) Institutions will conduct an annual hunger awareness activity in concert with other
25	statewide and national anti-hunger events.
26	(5) Institutions will assess the need to provide access to on-campus food distribution, or to
27	a local off-campus food pantry, or to an on-campus food pantry.
28	(c) Designation as a Student Basic Needs Campus will qualify institutions to apply for
29	Student Basic Needs Campus grants to support their work in addition to demonstrating public
30	recognition of their efforts. Initial designation is for two years, with annual renewal thereafter.

	<u>§18B-22-6. Student Basic Needs Campus Grants – Eligible Activities.</u>				
1	(a) Subject to available resources at the institution, the commission shall consider				
2	awarding Student Basic Needs Campus grants to institutions that have been designated Student				
3	Basic Needs Campuses and can demonstrate progress or commitment to implementing one or				
4	more of the following anti-hunger initiatives:				
5	(1) The establishment of a campus basic needs emergency fund to support students in				
6	crisis with emergency expenses associated with but not limited to food, shelter, utilities, and				
7	childcare. Such fund will include policies of administration, ways to access, and an identified				
8	administration contact.				
9	(2) The designation of one or more staff persons whose responsibility is to assist food				
10	insecure students access nutrition and other basic needs resources, subject to appropriation.				
11	(3) The dissemination of an anonymous brief campus-wide annual survey in which				
12	students are asked about their experience with food insecurity; their access to anti-hunger				
13	campus resources; awareness and access to Supplemental Nutrition Assistance Program				
14	(SNAP) and Special Supplemental Nutrition Program for Women, Infants, and Children (WIC)				
15	benefits. Such questions could be included in other campus-wide surveys.				
16	(4) The commitment of on-campus meal vendors to become Electronic Benefits Transfer				
17	vendors under the Restaurant Meal Program under the Supplemental Nutrition Assistance				
18	Program in order to allow students who are homeless and students with disabilities to use their				
19	Supplemental Nutrition Assistance Program benefits to access hot meals.				
20	(5) The establishment of an on-campus food pantry.				
21	(b) The commission shall establish a grant making process for public higher education				
22	campuses and certain not-for-profit campuses that disproportionately serve low-income students,				
23	including an application that clarifies eligibility. Following implementation of the award, recipients				
24	will be expected to provide basic information to the commission on how the award was used, its				
25	deliverables and outcomes.

<u>§18B-22-10.</u>	Legislative	Rules.

- 1 (a) The commission shall propose a legislative rule pursuant to §29A-3A-1 et seq. of this
- 2 code to implement the provisions of this article and shall file the rule with the Legislative Oversight
- 3 Commission on Education Accountability no later than October 1, 2024.
- 4 (b) The Legislature finds that an emergency exists and, therefore, the commission shall
- 5 propose an emergency rule to implement the provisions of this article in accordance with section
- 6 six, article one of this chapter and §29A-3A-1 et seq. of this code by October 1, 2024.
