1	A BILL to amend the Code of West Virginia, 1931, as amended, by adding thereto a new section
2	designated §5A-1-13, relating to prohibiting state contracts with entities who engage in
3	specific activities found to be inimical to the people of West Virginia; termination of
4	contracts and state employees for failure to comply; and duties of The Secretary of State,
5	in coordination with the Governor, Attorney General, State Treasurer and State Auditor to
6	maintain lists of entities not complying with this prohibition.
	Be it enacted by the Legislature of West Virginia:
	ARTICLE 1. DEPARTMENT OF ADMINISTRATION.
	§5A-1-13. Prohibiting certain state contracts; legislative findings; failure to comply by
	employees.
1	(a) Legislative findings The Legislature finds that:
2	(1) The Constitution of the State of West Virginia states "The Constitution of the United
3	States, and the laws and treaties made in pursuance thereof, shall be the supreme law of the
4	land";
5	(2) Actions counter to the Constitution of the United States of America and Constitution of
6	West Virginia are repugnant and will not be tolerated within the government of West Virginia;
7	(3) Unrestricted abortion is abhorrent and unacceptable to civilized peoples and states;
8	(4) Genocide, terrorism, rape and racism are illegal and must be eradicated;
9	(5) Grooming of children to facilitate their mutilation via surgery or chemical means is
10	abhorrent and unacceptable to civilized peoples and states; and
11	(6) Corporations, companies and other entities that use environmental, social and
12	governance (ESG) agendas to further their activities are inimical to the people of West Virginia.
13	(b) Contracts not permitted. The government of the State of West Virginia, as well as any
14	entities that receive any funding by the State of West Virginia, may not undertake nor maintain any
15	contracts with, affiliations with, or employment of, any corporations, companies, or other entities,
16	including educational institutions or individuals, which:

17	(1) Conducted actions or efforts to infringe on the Constitutional rights of Americans,
18	including efforts coordinated with or voluntarily in support of the federal government, or any state
19	or local governments;
20	(2) Conducted actions or efforts designed to undermine the Constitution of West Virginia or
21	the Constitution of the United States of America;
22	(3) Supported abortion, genocide, terrorism, rape or racism;
23	(4) Supported use of surgery or chemical means to attempt to alter the sex or sexual
24	appearance of anyone under the age of 18; or
25	(5) Use or incorporate environmental, social and governance (ESG) agendas as part of
26	any financial activities or investments.
27	(c) Contracts currently in force. Contracts currently in force with the State of West Virginia
28	shall be terminated at the earliest opportunity, ensuring services are maintained by contracting
29	with entities which do not violate the above.

NOTE: The purpose of this bill is to prohibit state contracts with entities who engage in specific activities found to be inimical to the people of West Virginia; termination of contracts and state employees for failure to comply; and duties of The Secretary of State, in coordination with the Governor, Attorney General, State Treasurer and State Auditor to maintain lists of entities not complying with this prohibition.
