1 A BILL to amend the Code of West Virginia, 1931, as amended, by adding thereto a new article, 2 designated §18B-22-1, §18B-22-2, §18B-22-3, §18B-22-4, and §18B-22-5, all relating to 3 creating the Hunger-Free Campus Act; providing for a short title; establishing the act and 4 providing for a legislative purpose; authorizing the Higher Education Policy Commission to 5 implement program; providing qualifications for campuses to be designated as hunger-free 6 zones; allowing for grant funding of hunger-free zones; providing for reporting on the 7 impact of any grants; and providing for an effective date. Be it enacted by the Legislature of West Virginia: ARTICLE 22. HUNGER FREE CAMPUS ACT. §18B-22-1. Short title. 1 This article shall be known and may be cited as the "Hunger-Free Campus Act." Enactment §18B-22-2. and purpose. 1 The West Virginia Higher Education Policy Commission shall establish a Hunger-Free Campus Grant Program. The purpose of the program shall be to provide grants to public 2 3 institutions of higher education that have one or more campuses that are designated by the 4 secretary as hunger-free campuses. The purpose of the grant funding shall be to: 5 (1) Address student hunger; 6 (2) Leverage more sustainable solutions to address basic food needs on campus; 7 (3) Raise awareness of services currently offered on campus which address basic food 8 needs; and 9 (4) Continue to build strategic partnerships at the local, state, and national levels to 10 address food insecurity among students. §18B-22-3. Campus qualification. 1 In order to be designated as a hunger-free campus, the institution shall: 2 (1) Establish a Campus Hunger Task Force that meets a minimum of three times per

academic year to set at least two goals with action plans;

22	The secreta	ary shall allocate grant funding to each public instit	tution of higher education that	
23	has one or more campuses designated by the secretary as a hunger-free campus in accordance			
24	with the criteria established pursuant to this article. The secretary shall determine the amount of			
25	each grant which sh	each grant which shall be used by the institution to further address food insecurity among students		
26	enrolled in the instit	enrolled in the institution. Any and all grant funding shall be made from any moneys received from		
27	legislative appropri	egislative appropriations or from any other sources provided for purposes of this article.

- 2 years after the establishment of the Hunger-Free Campus Grant Program. The report shall
- 3 include, but not be limited to, the number and amounts of the grant awards, the impact the grant
- 4 program has had on establishing additional hunger-free campuses at public institutions of higher
- 5 education and reducing the number of students experiencing food insecurity, and
- 6 recommendations on the expansion of the grant program.

§18B-22-5. Effective date.

1 This article shall take effect immediately upon passage.

NOTE: The purpose of this bill is to create the "Hunger-Free Campus Act," which requires the West Virginia Higher Education Policy Commission to establish a grant program to address food insecurity among students enrolled in public institutions of higher education.
